### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Crosby Company of New Hampshire, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Crosby Company of New Hampshire, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

**NOTE A – DESCRIPTION OF THE PLAN**

The following description of The Crosby Company of New Hampshire, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of The Crosby Company of New Hampshire, LLC and its participating employers (the "Company"). The Plan was established on January 1, 2012 to provide a systematic savings plan for eligible employees (the "participants"). Eligible employees may join the Plan on the first day of the month following their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was amended in 2023 to add AlzForum Foundation, Inc. as a participating employer.

The Company has appointed an investment trustee and custodian, Fidelity Management Trust Company (the "trustee" or "Fidelity"), to hold the Plan's assets, execute investment transactions, and administer the participants' accounts. The Compensation Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Contributions**

Eligible employees who choose to participate are allowed to contribute up to 50% of pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("rollover contributions"). Participants direct the investment of their contribution into various investment options offered by the Plan. These options include professionally managed mutual funds and a brokerage account which allows participants to invest in a wide array of securities. The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or choose to participate at a different deferral rate. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated target date fund until changed by the participant. Auto enrolled participants will have their deferral increased annually by 1% until a deferral rate of 10% is reached, unless the participant affirmatively elects out of the automatic increase. Increases take place on approximately June 23<sup>rd</sup> of each Plan year. Participants who are not auto enrolled may elect into the auto deferral increase program if they choose. Contributions are subject to certain IRS limitations.

The Company may make discretionary matching contributions on all participant deferrals other than catch-up contributions. To be eligible to receive the matching contribution, a participant is required to have completed twelve months of service. For the year ended December 31, 2024, the Company matched 100% of the first 7% of compensation deferred by each participant which totaled \$1,796,166. Additional profit sharing amounts may be contributed at the option of the Company. During the year ended December 31, 2024, the profit sharing contribution totaled \$3,196,124 and was contributed to the Plan subsequent to the Plan year end. The Company reduced this total by applying \$265,959 of forfeitures resulting in an employer profit sharing contribution of \$2,930,165.

**NOTE A – DESCRIPTION OF THE PLAN (continued)**

**Participant Accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administration expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions. All loans must be repaid within five years unless the proceeds are used to acquire a principal residence, in which case a longer repayment period is allowed. A participant may only have one loan outstanding at any one time.

**Vesting**

Participants are fully vested in that portion of their account which represents their contributions and the income earned thereon. Otherwise, a participant's interest in Company contributions vests according to the following schedule:

Years of Service	Vested Percentage
Less than 2 years of service	0%
After 2 years of service	20%
After 3 years of service	40%
After 4 years of service	60%
After 5 years of service	100%

**Payment of Benefits**

On termination of service, a participant shall be entitled to receive a distribution in an amount equal to the value of his or her vested account in the form of a lump sum or in installments.

Hardship withdrawals are allowed under the provisions of the Plan and cannot exceed the amount required to meet the immediate financial need created by the hardship.

**Other Income**

The Plan participates in a revenue-sharing agreement with Fidelity. Under the terms of the agreement, each eligible participant shall receive a participant revenue credit each quarter. The credit is calculated based on basis points and average daily balances of certain investments held in the Plan as stipulated in the agreement. Other income received in 2024 under this agreement totaled \$102,818.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$265,959 and \$147,677, respectively. These accounts are used to reduce future expenses and employer contributions. During the year ended December 31, 2024, the Company used \$143,124 to reduce their 2023 profit sharing contribution, paid out in 2024. Subsequent to year end, the Company used \$265,959 to reduce their 2024 profit sharing contribution, paid out in 2025.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor's Board of Directors determines that Plan's valuation policies utilizing information provided by the trustee and custodian. See Note C for discussion of fair value measurements.

The Plan's shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at each year end. This method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Date of Managements Review**

The Plan has evaluated subsequent events through the report date, the date the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.

**NOTE C – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).
- *Brokerage accounts*: Participant directed mutual funds that are valued on the basis of readily determinable market prices (Level 1).

*Related Parties*

Certain expenses of maintaining the Plan are paid by the Plan Sponsor (and those expenses are excluded from the financial statements). The Plan Sponsor is also part of an affiliated group with FMR LLC. The following subsidiaries of FMR LLC provide the stated services to the Plan, which are related party transactions:

- Fidelity Workplace Services LLC – provides participant recordkeeping, accounting functions and other plan related services at no charge to the Plan
- Fidelity Management Trust Company – provides trustee related services at no charge to the Plan

*Parties in Interest*

Section 3(14) of ERISA defines a party in interest to include, among others, fiduciaries or employees of the Plan or the Plan Sponsor (as applicable), any person who provides services to the Plan or an employer whose employees are covered by the Plan. The Plan invests in shares of registered investment companies managed by Fidelity. A portion of the income or loss of the Plan is derived from these investments. Fees paid by the Plan to Fidelity for certain investment management fees were deducted from the net asset values of the funds held by the Plan.

Certain employees and officers of the Plan Sponsor, who are also participants in the Plan, perform administrative services to the Plan at no cost to the Plan. These transactions are exempt from the prohibited transaction rules. The Plan is administered by the Compensation Committee. In that role, the Compensation Committee has the power to make various administrative determinations as provided for under the Plan documents.

**NOTE F – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE G – TAX STATUS**

The Plan adopted a volume submitter profit-sharing plan with Fidelity Management Trust Company. That Plan obtained its latest determination letter dated June 20, 2023, in which the Internal Revenue Service stated that the Plan and the related trust, as then designed, are in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

**NOTE H – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE I – ADDITION OF PARTICIPATING EMPLOYER**

In 2023, the Plan Sponsor acquired AlzForum Foundation, Inc. and the plan was amended to add this Company as a participating employer. There were no assets transferred in from the participating employers previous 401(k) plan.
