Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.



NOTE 1 DESCRIPTION OF PLAN

The following description of the Allied-Locke Industries, Inc. (the Company) 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a 401(k) qualified retirement plan, originally effective January 1, 1991, covering all full-time employees, except those deemed as excluded employees per the Plan document. The Plan has been amended throughout the years to comply with tax legislation and was most recently restated effective July 31, 2022. The Plan is subject to the Employment Retirement Income Security Act of 1974 (ERISA). For the purpose of this Plan, a Trust has been created by the Plan. The Trust is responsible for the safekeeping of the Plan's assets.

The Plan is administered by a Retirement Committee consisting of at least three persons appointed by the directors of the Company. Among the duties of the Committee are the maintenance of participants' records, the determination of the right of any person to a benefit, the determination of the method of payment of such benefit, and others.

Participation

Participation in the Plan is extended to any individual who is in the service and an employee of the Company, except those deemed as excluded employees. Such individuals will become a participant in the Plan upon completion of 12 months consisting of at least 1,000 hours of service with the Company and the attainment of the age of 19. Upon becoming eligible, participants may enter the Plan on the following January 1 or July 1.

Contributions

Participants' Contribution

Participants may elect to have a minimum of 2%, up to the amount allowed by the Internal Revenue Service (IRS) limits, withheld from their compensation before taxes contributed to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants' elective contributions withheld from their compensation will be paid weekly to the Plan trustee.

Matching Contributions

The Company can make discretionary matching contributions. The matching percentage will be determined each year and applied up to 6% of participant's contributions. The matching percentage for the year ended December 31, 2024 was 35% of the first 6% of participant contributions. Matching contributions are invested in the same options as participant contributions, at the participant's discretion.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution and an allocation of Plan earnings and forfeitures of terminated participants' nonvested accounts, and charged with an allocation of administrative expenses paid by the Plan. Allocations of Plan earnings and administrative expenses are based on participant account balances, as defined. Forfeiture allocations are based on the ratio of the Company's current year matching contribution to total matching contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective contributions plus earnings. Employees are vested in the Company matching contribution, plus earnings based upon a five-year vesting schedule that begins in the second year. A year is a 12 consecutive month period of at least 1,000 hours of service.

If an active participant dies prior to attaining normal retirement age, the participant's vesting percentage shall be 100%. Full vesting also occurs upon attainment of age 65 or termination of employment due to disability.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$12,098 and \$8,589, respectively. These accounts are allocated as a discretionary matching contribution to active participants. There were \$8,589 of forfeitures allocated as discretionary matching contributions for the year ended December 31, 2024.

Benefit Payments

Benefits are payable to the participant upon:

- (a) Death or retirement from the service of Company on or after normal retirement date (age 65) or on account of disability, or
- (b) Resignation or dismissal from the service of Company prior to normal retirement date.

Benefit Payments (Continued)

If the benefits are payable in the event of (a) above, the amount of the benefits would be equal to the then balance in the participant's accounts. However, if (b) is applicable, the benefits payable would be the total of the participant's own contributions, and Company matching contributions, up to the amount of the participant's vested interest in the Company's contributions. Balances of \$1,000 or less will be distributed in a lump sum to the participant. If the balance is more than \$1,000, an election to receive the benefit must be made.

Each participant or former participant may, in writing, designate a beneficiary or beneficiaries to whom distributions of the participant's interest in the Trust shall be made in the event of the participant's death.

In-service withdrawals are available to participants, upon the participant reaching age 59½. The in-service withdrawals may only be withdrawn from accounts where the participant is 100% vested.

Hardship distributions are available to participants. Hardship distributions may only be withdrawn from elective deferrals of the participant.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisers. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through September 10, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFIED INVESTMENTS

Midland States Bank, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Fund: Valued daily at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of Employee Retirement Income Security Act of 1974. In the event of termination, all participants would become fully vested.

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter dated June 7, 2021 from the IRS indicating that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by the qualified institution of the Plan; therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Certain administrative functions are performed by employees of the Company, for which no compensation is received.
