### NOTES TO FINANCIAL STATEMENTS

#### Note 1. Plan Description

The following description of the Hughes & Coleman, LLC 401(k) Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General:

The Plan is a defined contribution plan covering substantially all employees of Hughes & Coleman, LLC; Bell, Hughes & Coleman, PC; Coleman Legal Group, PLLC and J. Marshall Hughes, PLLC (collectively, Employer). As of April 3, 2023, J. Marshall Hughes, LLC is no longer an adopting employer. An eligible employee can join the Plan on any entry date on or following the date of one year of service and obtaining age twenty-one. The Plan's entry dates are January 1 and July 1 of any plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustees are responsible for oversight of the Plan. The trustees and investment adviser determine the appropriateness of the Plan's investment offerings, monitor investment performance and report to the Plan's Board of Directors.

#### Contributions:

The Plan is funded by both safe harbor contributions and discretionary employer profit sharing and participant contributions. Each year, participants may contribute up to 100% of their compensation, as defined by the Plan, up to the maximum permitted by the Internal Revenue Code. Participants are also eligible to make Roth deferral contributions to the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer makes a safe harbor contribution for all eligible employees. In 2024 and 2023, the safe harbor contribution was a match equal to 100% of participant salary deferral contributions up to 3% of compensation, plus 50% of participant salary deferral contributions in excess of 3% of compensation but not in excess of 5% of compensation. The Employer did not make any discretionary profit sharing contributions in 2024 and 2023. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### Participant accounts:

Each participant's account is credited with the participant's elective contributions, employer safe harbor contributions, profit sharing contributions for certain classifications of participants, and allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant contributions, compensation, or account balances, as defined in the plan provisions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## NOTES TO FINANCIAL STATEMENTS

### **Vesting:**

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are also immediately vested in the employer safe harbor contributions, discretionary profit sharing contributions and earnings on those contributions.

### **Forfeited accounts:**

Forfeited, non-vested accounts are used to reduce future employer contributions or reduce future plan expenses. Forfeitures of \$390 resulting from account corrections were utilized to pay plan expenses during 2023. There were no forfeitures used in 2024. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3 and \$2, respectively.

### **Payment of benefits:**

On termination of service due to death, disability, retirement or other reasons, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

### **Notes receivable from participants:**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1-5 years, however, with limited exceptions, can be up to 30 years. The loans are secured by the balance in the participant's account and bear interest as determined by the plan administrator. Interest rates are 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

## **Note 2. Summary of Significant Accounting Policies**

This summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management who is responsible for the integrity and objectivity of the financial statements. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

### **Basis of accounting:**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Contributions:**

Contributions from plan participants and the contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

## NOTES TO FINANCIAL STATEMENTS

### **Use of estimates:**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment valuation and income recognition:**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment adviser and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes receivable from participants:**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

### **Payment of benefits:**

Benefits are recorded when paid.

### **Expenses:**

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### **Subsequent events:**

The Plan has evaluated subsequent events through September 17, 2025, the date the financial statements were available to be issued.

## NOTES TO FINANCIAL STATEMENTS

### Note 3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023 and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by the plan administrator and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

### Note 4. Investments and Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active or inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

All assets have been valued using a market approach. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds – valued at the daily closing price as reported by the fund.

Stable value account – fair value is equal to contract value. Contract value is determined using the effective annual interest rate as determined by the insurance company applied to the deposit liability balance.

## NOTES TO FINANCIAL STATEMENTS

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 5. Related Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are shares of mutual funds and a stable value account managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Fidelity Management Trust Company for record-keeping services totaled \$22,067 and \$16,817 for the years ended December 31, 2024 and 2023, respectively. Fees paid by the Plan to the investment advisor for advisory services totaled \$30,504 and \$27,120 for the years ended December 31, 2024 and 2023, respectively.

Certain administrative functions are performed by officers or employees of the Employer. No officer or employee receives compensation from the Plan.

### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be entitled to 100% of the value of their accounts.

## NOTES TO FINANCIAL STATEMENTS

### **Note 7. Income Tax Status**

Effective July 1, 2021, the Plan is a prototype plan offered by Fidelity (FMR LLC). The prototype plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operating, in compliance with the applicable requirements of the IRS and, therefore, believe the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
