### ***Opinion***

We have audited the financial statements of Sewell Automotive Companies 401(k) Retirement Savings Plan ("Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

In our opinion, the financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### ***Basis for Opinion***

**Note 1. Plan Description**

The following description of the Sewell Automotive Companies 401(k) Retirement Savings Plan (“Plan”) provides only general information. Participants should refer to the plan document for a more comprehensive description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering the associates of Sewell Village Cadillac Company, Inc.; Sewell Corporation; Sewell Corporation of Ft. Worth; Sewell Rings, LLC; Sewell 10, LLC; Sewell FW, LLC; Sewell Houston Company, LLC; SCSA Operating Company, Inc.; Sewell Automotive Companies, Inc.; LWA Operating Company, LLC; UDM Company, LLC; DFW Rings, LLC; GEQ Operating Company; BFOR Company, LLC; BFOR2 Company, LLC; and UDM2 Company, LLC (collectively, “Sewell”). Associates become eligible to participate in the Plan upon hire and attaining the age of 18, as defined in the plan document. Vanguard Fiduciary Trust Company (“Vanguard”) serves as trustee of the Plan. The Plan is subject to the requirements of the *Employee Retirement Income Security Act of 1974* (“ERISA”).

**Investment Options**

Participants direct the investment of their accounts into various investment options offered by the Plan. Participants may change their investment options at any time. The Plan currently offers various mutual funds and a common/collective trust fund as investment options for participants.

**Contributions**

Participants may contribute compensation, as defined in the plan document. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The participant may specify whether the elective deferrals are to be characterized as pre-tax elective deferrals, Roth elective deferrals, or a specified combination. The Plan includes an auto-enrollment provision whereby all newly eligible associates are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. Sewell may also make discretionary matching contributions. For the years ended December 31, 2024 and 2023, Sewell contributed a match of 25% of the first 6% of compensation, up to \$345,000 and \$330,000, respectively, that a participant contributed to the Plan. Contributions are subject to certain limitations.

**Notes Receivable from Participants**

Participants may borrow from their vested fund accounts a minimum of \$1,000 and a maximum of the lesser of \$50,000 or 50% of their vested account balance. Notes receivable terms range from one to five years. The notes receivable are secured by the balance in the participant’s account. Interest is charged at a fixed rate of prime plus 2.00% at the date of note origination and ranged from 4.25% to 10.50% on notes receivable from participants outstanding at December 31, 2024. Principal and interest is paid ratably through payroll deductions.

**Participant Accounts**

Each participant’s account is credited with the participant’s elective deferral, Sewell’s discretionary contribution, and an allocation of the Plan’s earnings or losses and is charged with benefit payments and fees related to notes receivable from the participant. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

Participants are immediately vested in their elective deferral contributions and rollover contributions plus actual earnings thereon. The portion of the participant's account attributable to Sewell's discretionary contributions plus actual earnings thereon vests ratably over the first six years of service. Participant accounts are 100% vested due to normal retirement age, death, disability, or plan termination regardless of years of service.

***Payment of Benefits***

Upon death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested account or annual installments. Upon termination of a participant's employment with Sewell, lump sum distributions must be made on participant accounts with a value of less than \$1,000. Account balances greater than \$1,000 and less than \$5,000 will be automatically rolled over into an Individual Retirement Account if the participant does not make a different distribution election after receiving the required notification. For account balances greater than \$5,000, the funds will remain in the Plan if the participant does not make a different distribution election after receiving the required notification.

In certain hardship situations, as described in the plan document, participants may withdraw part of their account balances while actively employed.

***Forfeitures***

Forfeited balances of terminated participants' nonvested accounts are used to reduce employer contributions or to pay expenses. Forfeited balances totaled \$258,420 and \$197,984 as of December 31, 2024 and 2023, respectively. Forfeitures in the amount of \$356,480 and \$308,671 were used to reduce employer contributions for the years ended December 31, 2024 and 2023, respectively.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

***Estimates***

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as benefits paid based upon the terms of the plan document.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Fees***

Sewell has paid for certain administrative fees on behalf of the Plan for the years ended December 31, 2024 and 2023. Certain administrative functions are performed by Sewell associates, who receive no compensation from the Plan. Expenses relating to specific participant transactions (notes receivable from participants and benefits paid) are charged directly to the participant's account.

***Subsequent Events***

The Plan has evaluated subsequent events through August 20, 2025, the date the financial statements were available to be issued.

**Note 3. Fair Value Measurements**

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions

Assets and liabilities are classified in their entirety based on the lowest level (*i.e.*, least reliable) of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

**Mutual Funds** – Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

**Common/Collective Trust Fund** – This fund is valued at the net asset value (“NAV”) of units of the collective fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. The issuer has specified a redemption notification period of twelve months in order to ensure that securities liquidations will be carried out in an orderly business manner, should the Plan initiate a full redemption of the common/collective trust fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4. Tax Status**

The Internal Revenue Service has determined and informed the plan administrator by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Amendments to the Plan have been made since the determination request. However, the plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

The Plan recognizes income tax benefits only to the extent that the Plan believes it is more-likely-than-not that its income tax positions will be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 5. Exempt Party-in-Interest Transactions**

Certain plan investments are shares of mutual funds and a common/collective trust fund managed by Vanguard. Vanguard is the trustee defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management and administrative services amounted to \$54,816 and \$54,757 for the years ended December 31, 2024 and 2023, respectively.

**Note 6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, Sewell has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts. Sewell may distribute benefits at the time of termination or continue to hold benefits in the trust, payable to a participant no later than allowed by the Plan.
