## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of iQ Credit Union 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by qualified institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter — Supplemental Schedule Required by ERISA***

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. **DECEMBER 31, 2024 AND 2023**

**NOTE 1 – DESCRIPTION OF PLAN**

The following brief description of the iQ Credit Union 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The iQ Credit Union 401(k) Plan is a defined contribution plan available to all employees of iQ Credit Union and subsidiary (the Company) meeting certain age and service requirements. The Plan was established in July 1985. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Amendments** - Effective January 1, 2023, the plan was amended to increase the Qualified Automatic Contribution Arrangement (QACA) safe harbor matching contributions to a 100% match on the first 5% of eligible compensation deferred by a participant and 50% of the next 1%.

**Contributions** - Contributions consist of employee pretax elective deferrals, Roth contributions, QACA safe harbor matching contributions, nonelective employer matching contributions and nonelective profit-sharing contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Contributions from Plan participants and all matching contributions are recorded in the year in which employee contributions are withheld from compensation. Each participant may elect to contribute a percentage of his or her compensation, as defined in the Plan, limited to \$23,000 and \$22,500 in 2024 and 2023, respectively, as prescribed by the Internal Revenue Code (IRC). Participants aged 50 or older may elect to make an additional catch-up contribution up to \$7,500, annually. The Plan includes an auto-enrollment provision whereby 6% of the compensation of newly eligible participants will be automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect to contribute a lower or higher amount. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation which will automatically increase by 1% each year until reaching the 10% maximum auto increase, unless the participant elects differently.

In 2023 and 2024, the Company made QACA Safe Harbor Matching contributions of 100% of each participant's first 5% of eligible compensation, plus 50% of the participant's next 1% of eligible compensation. The Company may also make nonelective employer matching and nonelective profit-sharing contributions. No such contributions were made in 2024 or 2023. In addition, contributions are subject to certain limitations as prescribed by the IRC.

**Participant Accounts** - A separate account is maintained for each participant, which is credited with the participant's contributions, the Company's contributions, and an allocation of Plan earnings. Allocation of Plan earnings are based upon participant account balances. The benefit to which a participant is entitled is the vested amount in their individual account.

**Vesting** - All participants are immediately vested in their contributions and actual earnings thereon. Participants entering the Plan vest at 25% per year, commencing after one year of service, and become fully vested after four years of service in their accounts attributable to employer nonelective profit sharing and employer matching contributions and earnings thereon. Employees are 100% vested in QACA Safe Harbor matching contributions after two years.

**Expenses** - Administrative expenses may be paid by the Company. Administrative and investment expenses not paid by the Company are charged to participant accounts based upon relative account values on a quarterly basis. Participant loan and distribution fees are charged to the borrower's account. In addition, certain expenses of Plan Administration including computer services, professional fees, office supplies and payroll expenses of administrative and clerical personnel, are provided by the Company without charge to the Plan.

**Payment of Benefits** - Upon termination of service, participants may elect to receive the value of their accumulated benefits in a lump-sum distribution or installments as defined in the Plan. Specific guidelines are provided for benefits to be paid in the event of death, disability, termination other than retirement, or financial hardship, as defined in the Plan. The Plan further provides for notes receivable from participants.

**Forfeitures** - Forfeitures may be used to reinstate previously forfeited account balances or used to pay Plan expenses. The remaining forfeitures, if any, shall be used to reduce employer contributions. Forfeited accounts amounted to \$9,066 and \$22,904 at December 31, 2024 and 2023, respectively. Administrative fees were reduced by \$25,361 and \$20,822 in 2024 and 2023, respectively. Employer contributions were reduced by \$7,737 and \$0, in 2024 and 2023, respectively. The Plan also at times has a balance of excess employer contributions. These excess funds are used to reduce employer contributions or pay Plan expenses. At December 31, 2024 and 2023, there was \$0 and \$2,871, respectively, in the excess employer contribution account. Contributions were reduced by \$3,314 in 2024 through the use of these unallocated accounts. These funds were not used to reduce contributions or pay Plan expenses in 2023.

## **NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The financial statements of the Plan are prepared under the accrual method of accounting.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

**Investment Valuation and Income Recognition** - Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and management and operating expenses associated with the Plan's investments in mutual funds.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan

Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Benefit Payments** - Benefits are recorded when paid. Accordingly, benefits payable to persons that have elected to withdraw from the Plan but are not yet paid at year-end have not been accrued. At December 31, 2024 and 2023, there were no amounts payable to participants.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Subsequent Events** - The Plan's management has performed an evaluation of subsequent events through September 16, 2025, which is the date these financial statements were available to be issued.

### **NOTE 3 – FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

#### **Basis of Fair Value Measurement**

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access at the measurement date.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following is a summary of the comparative unaudited information regarding the Plan, included in the Plan's financial statements and supplemental schedule, that was certified by the custodians of the Plan, Reliance Trust Company, and Standard Insurance Company, as of and for the years ended December 31, 2024 and 2023, and furnished to the Plan Administrator. #### **NOTE 5 – GROUP ANNUITY CONTRACT WITH STANDARD INSURANCE COMPANY**

The Plan is invested in a traditional fully benefit-responsive, group annuity contract with Standard Insurance Company (Standard), The Standard Stable Asset Fund A. Standard maintains the contributions in a general account. The group annuity contract provides for preservation of principal, maintains a stable interest rate, and provides daily liquidity at contract value for participant withdrawals and transfers in accordance with the provisions of the Plan. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The account is credited

with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

This contract meets the fully benefit-responsive contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of a contract issuer or otherwise. The contract value of the group annuity contract at December 31, 2024 and 2023, respectively, was \$2,034,653 and \$1,242,546. The crediting interest rate is based on a formula agreed upon with the issuer. The average yield was 3.04% and 2.78% for the years ended December 31, 2024 and 2023, respectively. On a quarterly basis, Standard declares a crediting rate for financial activity in the coming quarter.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) termination of the contract, (2) spin-offs, (3) divestitures, (4) layoffs, (5) corporate relocation, (6) partial or total plan termination, (7) retirement incentive programs, and (8) the liberalization of plan withdrawal or transfer rules. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The Plan may terminate the contract at any time with 30 days advance written notice to Standard. Standard may terminate the contract with 30 days advance written notice to the Plan for reasonable cause, which includes the Plan's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the Plan in a reasonable period of time. Upon termination by either party, the payout value may be subject to adjustment, either in a lump sum payment or in installment payments.

#### **NOTE 6 – NOTES RECEIVABLE FROM PARTICIPANTS**

The Plan makes loans to participants based on their vested account balance. The minimum loan amount is \$1,000 and is limited to 50% of their vested account balance or \$50,000, whichever is less. Loans must be repaid within five years, except for loans made for the purchase of a primary residence. Interest is fixed at the time of the loan at prime plus 2.0% and ranges from 5.25% to 10.50% with various maturities through April 15, 2033 on loans outstanding at December 31, 2024.

## **NOTE 7 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

## **NOTE 8 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are managed by Standard Insurance Company. Standard Insurance Company is the recordkeeper and a custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for services by the custodian were \$91,472 and \$74,607 for the years ended December 31, 2024 and 2023, respectively.

## **NOTE 9 – CONCENTRATIONS, RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits, and therefore participants' account balances. There were two and three investments that individually represented more than 10% of the investments held as of December 31, 2024 and 2023, respectively. See the Supplemental Schedule of Assets (Held at End of Year) for the complete listing of investments held at that date.

## **NOTE 10 – INCOME TAX STATUS**

The Plan is an adoption of a Non-Standardized Pre-Approved Profit-Sharing Plan sponsored by Standard Retirement Services, Inc. The Plan document obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since the opinion letter was issued, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
