We have performed audits of the financial statements of Batteries Plus, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Batteries Plus, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

***General***

The Plan is a qualified automatic contribution arrangement (QACA) 401(k) defined contribution plan covering all employees of Batteries Plus, LLC (the Company or Employer) who have at least one month of service and have reached the age of 18 or older. Eligible employees can begin participating in the Plan the first day of each month following when the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

***Contributions***

Each year, participants may contribute up to the maximum amount allowed under the Internal Revenue Code (IRC). Participants may elect to have any portion, or all of their contributions, designated as Roth 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible participants are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation through December 31 of the second Plan year following their Plan entry date. Deferral rates are increased by 1% each January 1 thereafter, up to a maximum of 15%. These automatic deferral rates will remain unchanged until an election is made by the participant. Such contributions are invested in a qualified designated investment account until changed by the participant.

The Company makes a QACA safe harbor matching contribution equal to 100% of the first 1% of eligible compensation deferred by each participant and 50% of the next 5% of eligible compensation deferred by each participant. In addition, the Company may contribute each year a discretionary profit-sharing contribution at the option of the Company's board of directors. No such discretionary profit-sharing contribution was made to the Plan during 2024 or 2023.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, Company contributions and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are fully vested after two years of credited service in the Company's QACA safe harbor matching contributions. Vesting in the Company's discretionary profit sharing contribution is 20% per year fully vested after six years of credited service.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. For the period of January 1, 2023 through October 1, 2024, principal and interest is paid ratably through payroll deductions. Effective October 1, 2024, the Plan was amended to allow principal and interest payments from the participant's personal bank account.

***Benefit Payments***

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution, partial distribution or installments for required minimum distributions. If a participant terminates employment and the participant's account balance does not exceed \$7,000 and \$5,000 for the years ended December 31, 2024 and 2023, respectively, the Plan administrator will authorize the benefit payment without the participant's consent. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to the Plan's provisions.

***Forfeited Accounts***

Forfeited nonvested accounts are used to reduce future Company contributions or pay administrative expenses. Forfeited nonvested accounts as of December 31, 2024 and 2023 were \$364 and \$806, respectively. There were \$136,387 and \$153,715 of forfeitures used to reduce employer contributions for the years ended December 31, 2024 and 2023, respectively. No forfeitures were used to pay administrative expenses for the years ended December 31, 2024 and 2023.

***Expense Budget Account***

The Plan maintains an unallocated expense budget account (EBA) which is used to pay allowable expenses of the Plan. The EBA is funded through deductions of participants' account balances. Administrative expenses of \$108,469 and \$99,998 for the years ended December 31, 2024 and 2023 are net of \$39,567 and \$38,383 in Plan expenses paid from the EBA, respectively. The balance in the expense budget account was \$21 and \$9 as of December 31, 2024 and 2023, respectively.

***Administration***

The Company is the administrator of the Plan and has appointed Lincoln Financial Group Trust Company, Inc. as the trustee and recordkeeper and Merrill Lynch Wealth Management Services as the ERISA 3(21) registered investment advisor. The trustee is responsible for investing and safekeeping all of the assets of the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported

amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value (except for guaranteed investment accounts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to guaranteed investment accounts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Administrative expenses may be paid either by the Plan or by the Company. Expenses paid by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are included in administrative expenses. In addition, certain investment related expenses are included in net appreciation in fair value of investments.

**NOTE 3 - CERTIFICATION OF INVESTMENT INFORMATION**

The Plan administrator has elected the method of annual reporting compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the directed trustee has certified that the following data included in the financial statements and supplementary schedule are complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

**NOTE 4 - FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

***Mutual Funds***

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

**NOTE 7 - PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter from the IRS on the prototype plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore not subject to tax under current income tax law. The prototype plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - GUARANTEED INVESTMENT ACCOUNT**

The Plan has entered into a fully benefit-responsive investment contract with the Lincoln National Life Insurance Company (Lincoln National), which includes the Lincoln Stable Value Account (guaranteed investment account). Lincoln National contracts are group fixed annuity contracts, not synthetic contracts. The contract is part of and backed by the general accounts assets of Lincoln National.

The investment objective of the guaranteed investment option is to maximize investment income with long-term preservation of capital. The guaranteed minimum interest rate was 2.30% and 2.10% as of December 31, 2024 and 2023, respectively.

As described in Note 2, because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals. Generally, there are no events that could limit the ability of the Plan or Plan participants to transact at contract value with issuer.

**NOTE 9 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Lincoln National. Lincoln National is a related party to the qualified institution of the Plan and, therefore, these investment transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management, trust services and other administrative services were \$108,469 and \$99,998 for the years ended December 31, 2024 and 2023, respectively.

Certain employees and officers of the Plan Sponsor, who are also participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

**NOTE 10 - NONEXEMPT TRANSACTION**

As required by ERISA Section 2510.3-102, the Plan Sponsor is required to segregate participant contributions from its general assets as soon as practicable. During 2024, the Company failed to remit timely to the Plan's trustee's certain participant contributions totaling \$3,013, within the period prescribed by DOL regulations. The delayed contributions are considered prohibited, or nonexempt, transactions. The Plan Sponsor has corrected the prohibited transactions during 2024, and the associated lost earnings in 2025, in accordance with applicable DOL guidelines.

**NOTE 11 - SUBSEQUENT EVENTS**

The Plan evaluated its December 31, 2024 financial statements for subsequent events through September 12, 2025, the date the financial statements were available to be issued. Plan management is not aware of any subsequent events which would require recognition or disclosure in the accompanying financial statements except as noted below.

Effective January 1, 2025, the definition of "compensation" under the Plan has been amended to exclude retention bonuses.

Effective January 1, 2025, the plan was amended to update provisions related to In Plan Roth Conversions.
