Note 1. Description of Plan

The following description of the Riemer & Braunstein LLP 401(k) and Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide all U.S. employees of Riemer & Braunstein LLP (the "Firm") with retirement benefits in accordance with Sections 401(a) and 401(k) of the Internal Revenue Code ("IRC"). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* ("ERISA").

Eligibility

All eligible employees, as defined by the Plan, who have attained age twenty-one and completed three months of service are eligible to participate in the Plan.

The Plan includes an automatic enrollment provision. Therefore, when an employee becomes eligible to be a participant in the Plan, the Firm will automatically, on behalf of that participant, defer 5% of the participant's eligible compensation, as defined. Absent an affirmative election by the participant, these deferrals will be invested in a target date retirement fund based on the participant's age at the time of enrollment. Participants may cancel, modify, or otherwise change any of the automatic elections.

Effective December 1, 2024, the Plan was amended to add related employers to the Plan.

Participant Contributions

Eligible participants may make voluntary contributions through salary reductions from 1% to 100% of eligible pre-tax annual compensation, as defined by the Plan, limited to the maximum amount allowable under the provisions of the IRC (\$23,000 in 2024). Further, participants who are 50 years of age or older as of December 31, 2024, can contribute an additional "catch up" contribution (\$7,500 in 2024). The Plan also allows for participants to defer funds into a "Roth 401(k)". These deferrals are subject to federal income taxes, and the maximum allowable participant contribution is \$23,000 combined between both the Roth and the pre-tax deferral. The Plan also allows rollover contributions from other qualified plans as defined in the plan document. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a stable value fund as investment options for participants.

Employer Contributions

The partners of the Firm determine, at their sole discretion, the amount (if any) of discretionary profit sharing contributions for any given plan year. Employees who have attained age twenty-one will become eligible for the profit sharing portion of the Plan on the earlier of either January 1 or July 1 following completion of a full year of service. For the year ended December 31, 2024, there was no profit sharing contribution.

Participants' Accounts

Each participant's account is credited with their respective contribution and its allocation of (a) employer contributions and (b) Plan earnings or losses.

Vesting

Participants' voluntary contributions, rollover contributions and any earnings thereon vest immediately. Participants vest in the Firm's profit sharing contributions and the cumulative earnings thereon as follows: less

than two years of service, 0%; after two years of service, 20%; after three years of service, 40%; after four years of service, 60%; after five years of service, 80%; after six years of service, 100% (as defined). In the event of death or disability, or attainment of retirement age, as defined, participants' accounts become fully vested.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Participants may borrow up to 50% of their vested account balance with a minimum of \$1,000 and a maximum of \$50,000. Loans are subject to approval by the Plan Administrator and terms range from one to five years. However, if the loan is to acquire the principal residence of the participant, the plan administrator may permit a longer repayment term. Further, loans will bear interest at a rate commensurate with local prevailing rates and are secured by the balance in the participant's account. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon termination of employment, retirement, attainment of age 59½, death, or disability, the participant or the participant's beneficiary is entitled to receive the vested portion of the participant's account in a single lump-sum, installments, or partial withdrawals for terminated participants, in accordance with Internal Revenue Service ("IRS") regulations and Plan provisions.

A participant may also elect to defer payments that would be distributed in the form of equal installments over a period specified by the participant. Withdrawals from the Plan before leaving the Firm are also available for special "hardship" reasons (as defined). Distributions to participants are recorded when paid. There is a benefit payment totaling approximately \$2,900,000 that was processed and approved for payment prior to December 31, 2024 but not yet paid as of that date and therefore not recognized as a benefit paid to participant in these financial statements.

Forfeitures

The Plan provides that forfeitures, the unvested portion of employer discretionary profit-sharing contributions for terminated participants, will be used to reduce Firm contributions for the Plan year and can also be used to pay plan expenses. As of December 31, 2024 and 2023, the balance in the forfeiture account was \$3,564 and \$9,320, respectively. Forfeitures for the year ended December 31, 2024 totaled \$1,343 and income on forfeiture money totaled \$175 and the Plan used forfeitures of \$7,275 to reduce administrative expenses for the year ended December 31, 2024.

Other Income

The Plan includes a revenue sharing agreement. Certain mutual fund expenses that are charged by the mutual fund companies to the individual participants (e.g. 12b-1, sub transfer agent), are recaptured by the Plan and held in a reserve account in the Putnam Stable Value Fund. These funds are then used to pay for Plan expenses of the Plan as approved by the IRS, Department of Labor ("DOL") and ERISA, such as administration and auditing fees. During the year ended December 31, 2024, the Plan recaptured \$116,049, which is classified as other income in the accompanying statement of changes in net assets available for benefits. An amount of \$134,707 was used during 2024 to pay Plan expenses. As of December 31, 2024 and 2023, the balance in the reserve account was \$229,394 and \$241,020, respectively.

Note 2. Summary of Significant Accounting Policies

The following is a summary of significant accounting policies followed by the Plan.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Investment Valuation and Income Recognition

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 8 for discussions of fair value measurements.

Realized gains and losses on investments sold and the unrealized appreciation and depreciation of investments held are reported on an average current cost basis, based on fair market value of the investments at the beginning of the Plan year or at the time of purchase during the Plan year.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Use of Estimates

The preparation of the financial statements, in conformity with GAAP, requires Plan management to make estimates and assumptions that could affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Administrative Expenses

Expenses incident to administering the Plan are paid by the Plan, unless the Firm, in its sole discretion and without obligation, determines to pay some of those Plan expenses in any given year.

Subsequent Events

The Plan has evaluated subsequent events through September 17, 2025, which is the date the financial statements were available to be issued.

Note 3. Financial Information Certified by The Plan's Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Bank of America N.A (Custodian and Bank of America), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule, is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024, and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Tax Status

On June 30, 2020, the Internal Revenue Service ("IRS") stated that the non-standardized pre-approved plan adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code ("IRC"). The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of both December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Parties-in-Interest

The Firm administers the Plan from its office. Plan investments are managed by Bank of America N.A (d/b/a Merrill Lynch, Pierce, Fenner and Smith) (Bank of America) who is the custodian, as defined by the Plan. HUB Retirement and Wealth Management (HUB), RPW Solutions, LLC (RPW) and Global Retirement Partners LLC (Global), are the advisors to the Plan and provide fiduciary advisory services. Therefore, these transactions with Bank of America, HUB, RPW and Global, qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules, as defined by ERISA. The following is a list of fees paid by the Plan during the year ended December 31, 2024, for recordkeeping and plan management and consulting services:

- Global - \$50,000
- HUB - \$67,268
- RPW - \$9,700

These fees are included in administrative expenses on the statement of changes in net assets available for benefits.

Note 6. Risks and Uncertainties

The Plan provides for various investment options in accounts which invest in investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could, in the near term, materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 7. Plan Termination

Although they have not expressed any intent to do so, the partners of the Firm may, at their discretion, terminate the Plan at any time, subject to the provisions set forth in ERISA. In the event that the Plan and the related trust terminate, all accounts will be valued as of the termination date, and all accounts will be distributed in full to participants.

Note 8. Disclosure About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Composed primarily of investment contracts that are valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
