**A. Description of Plan**

The following description of Richard McNay, Inc. 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**1. General**

The Plan is a defined contribution plan covering all full-time employees of Richard McNay, Inc., and RM Leasing, Inc. (the Company), who have completed six months of service and are aged twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 provisions include both required and optional elements. The Plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions became effective in 2024 and thereafter. Accordingly, there has been no material impact on the December 31, 2024, Plan financial statements.

On December 31, 2024, the Plan was amended effective November 1, 2024, to change the Plan year end to December 31.

**2. Contributions to the Plan**

**Employer Contributions** – The Company may contribute to the Plan discretionary profit-sharing contributions. There were no employer profit-sharing contributions made for the short year ended December 31, 2024.

The Company may also contribute discretionary matching contributions. Matching contributions of \$30,269 were made for the short year ending December 31, 2024.

To be eligible for discretionary contributions, a participant must be 21 years of age, complete at least 6 months of service, and complete 1,000 hours of service.

**Employee Contributions** – This is the total amount of the salary reduction elected to defer by employees. The maximum contribution per employee is \$23,000 and the maximum catch-up additional deferral is \$7,500 for calendar year 2024. Total salary deferrals for the Plan's short year ending December 31, 2024, were \$90,101. The Plan allows a Roth contribution as an elective deferral.

**Employee Rollover Contributions** – The Plan may accept a rollover contribution made on behalf of any eligible employee regardless of whether the employee has met the age and service requirements of the Plan. There were no rollovers into the Plan for the short year ended December 31, 2024. Employees are 100% vested in their "rollover account".

**3. Forfeitures**

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. For the short year ended December 31, 2024, forfeited non-vested accounts totaled \$185. These accounts will be used to reduce Plan expenses or reduce employer contributions. For the short year ended December 31, 2024, employer contributions were reduced by \$8,508 from forfeited non-vested accounts, and Plan expenses were reduced by \$12,844.

**4. Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service for profit-sharing contributions. The following 6-year graded vesting schedule applies to employer matching contributions:

**5. Benefit Payment Options**

Distributions will be in the form of a lump-sum distribution of a participant's total account balances, or selection of an alternate form of payment if allowed by the Plan.

**6. Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings (losses) and (c) forfeitures of terminated participants' non-vested accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**7. Plan Expenses**

The Plan sponsor absorbs significant costs of the Plan administration.

**8. Investments**

Upon enrollment in the Plan, participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan.

**B. Summary of Significant Accounting Policies**

**1. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**2. Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**3. Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**4. Contributions**

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**5. Payment of Benefits**

Benefits payments to participants are recorded when paid.

**C. Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs would be used only when Level 1 or Level 2 inputs were not available.

Observable inputs include quoted prices for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.

*Level 3 Fair Value Measurements -*

Life insurance policies are not actively traded, and significant other observable inputs are not available. Thus, the fair value of the life insurance policies is determined by the cash surrender values provided by the insurance company. **D. Information Prepared and Certified by the Custodian and Managing Agent for the Trustee**

The Plan's investments are held and managed by Empower. Financial information relating to those investments held by the managing agent is included in the accompanying financial statements, in the information presented in this note, and in the supplemental schedule based on information provided by the managing agent. The managing agent has certified that the information provided to the Plan administrator relating to the Plan's participation in invested assets and investment transactions is complete and accurate. This information has not been audited by independent auditors.

Interest income reported by the managing agent totaled \$19,933 for the short year ended December 31, 2024. Dividend income totaled \$620 for the short year ended December 31, 2024.

During the short year ended December 31, 2024, the investments (including investments bought, sold, and held during the year), as reported by the managing agent, appreciated (depreciated) in current value by \$57,214.

**E. Investment Contract with Insurance Company**

The Plan entered into a fully benefit-responsive investment contract with Empower. Empower maintains the contributions in a separate investment account. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

**E. Investment Contract with Insurance Company (Concluded)**

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. However, since this type of investment is considered a deposit liability with no defined maturity, the contract value is fair value. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract on December 31, 2024 was \$2,685,043. The crediting interest rate is based on an agreed-upon formula with the issuer.

Certain events limit the Plan's ability to transact at contract value with Empower. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with Plan participants, is probable. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**F. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

**G. Tax Status**

The Company has adopted a non-standardized plan pre-approved by the Internal Revenue Service (IRS). The IRS issued an opinion letter dated June 30, 2020, that the non-standardized plan is acceptable with the applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Company and the Plan administrator believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**H. Party-In-Interest Transactions**

Certain Plan investments are shares of mutual funds managed by Empower and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the managing agent and custodian were included as a reduction of the return earned on each fund. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party-in-interest transactions.
