Notes to Financial Statements

NOTE 1 DESCRIPTION OF THE PLAN

The following description of the Total Quality Logistics, LLC Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, established on January 1, 2006, is a defined contribution plan covering substantially all employees of Total Quality Logistics, LLC and its subsidiary, TQL Global, LLC, and its parent company, KGBO Holdings, Inc. and common ownership entity, Victory Equipment & Services, LLC (the "Company" or "Employer"). Employees become eligible immediately upon employment and reaching age 21. They may enter the Plan on the first day of the month after they have met the eligibility requirements. The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

A participant may contribute up to 60% of eligible compensation on either a pre-tax or Roth after-tax basis. Contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code ("IRC") of 1986 as amended (\$23,000 at December 31, 2024). For 2024, Section 414(v) of the IRC of 1986 as amended allowed a maximum catch-up contribution of \$7,500 for employees aged 50 and over.

The Company may, in its discretion, match participants' 401(k) contributions, up to the limit determined by the Company. During 2024, the Company contributed 50% of employee contributions up to 6% of their eligible compensation. The Company may also, in its discretion, elect to make a profit-sharing contribution. The participant must be employed on the last day of the Plan year and have completed at least 1,000 hours of service during the Plan year to be eligible for the discretionary contribution. Discretionary matching contributions totaled \$9,765,783 during 2024. There was no profit-sharing contribution for the year ended December 31, 2024.

The participants designate the percentage of their total contribution to be invested in any of the Plan's investment funds on a pre-tax basis or Roth after-tax basis. Participants may change the percentage of contributions invested in each account and may make transfers between accounts anytime during the year. A participant may change the amount of his or her elective deferred contributions anytime.

Rollover Contributions

Participants may rollover to the Plan a distribution they receive from an eligible retirement plan if the distribution qualifies as a rollover amount under the Internal Revenue Service ("IRS").

Participant Accounts

Each participant's account is credited with the participant's and Company's contributions and a pro-rata allocation of the Plan's earnings. The pro-rata allocation is calculated daily based upon the proportion of individual account balances to total participants' account balances in the respective investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

NOTE 1 DESCRIPTION OF THE PLAN (CONTINUED)

Vesting

Participants are vested immediately in their rollover contributions, pre-tax contributions, Roth after-tax contributions and qualified non-elective contributions made on their behalf, plus actual earnings thereon. Participants vest in Company matching contributions in accordance with the terms of the Plan. Participants become partially vested, in increments of 20%, after two years of service with 100% vesting being attained after six years. Forfeitures of matching contributions are used to reduce future matching contributions, or to pay the Plan's administrative expenses. Forfeited balances remaining in the Plan totaled \$829,676 and \$802,193 at December 31, 2024 and 2023, respectively. Forfeitures used to reduce employer contributions were \$842,227 during 2024. During 2024, the Company used \$14,100 of Plan forfeitures to pay Plan administrative expenses.

Payment of Benefits

Upon a participant's retirement, death, disability, termination of employment with the Company, or termination of the Plan, the participant's account is distributed as a lump sum cash payment equal to the value of the participant's vested interest in his or her account or is rolled over into an IRA or other qualifying retirement plan to avoid current taxation.

In-service distributions are permissible from all vested account balances for participants that have attained the age 59 ½. Rollovers are eligible for distribution at any time.

In conditions of financial hardship, a participant may apply to the Plan administrator for approval to withdraw the portion of their elective deferrals and the vested portion of their match or profit sharing accounts necessary to meet the financial hardship, subject to the limitations of the Plan and the IRC.

Upon termination of the Plan, the assets will be distributed to participants in accordance with the Plan's provisions and existing laws and regulations.

Administrative Expenses

Certain plan expenses are paid by the Company and accordingly, are not reflected in the Plan's financial statements. Certain investment related expenses are included in net appreciation of fair value of investments.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and may not exceed the lesser of \$50,000 reduced by the participant's highest outstanding loan balance during the previous 12 months or one-half of the participant's vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate that is set 1% above the prime rate, as defined. Principal and interest is paid ratably through payroll deductions or other reasonable means acceptable by the Plan administrator.

Related Party Transactions

Certain Plan investments are managed by the Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the asset custodians of the plan assets as defined by the Plan and, therefore, these transactions qualify as party-in-interest. The Plan pays administrative fees to various parties-in-interest which totaled \$434,873 for the year ended December 31, 2024.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Investment Valuation and Income Recognition

Investments, except for the fully benefit-responsive investment contract which is reported at contract value, are reported at fair value and are valued daily. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Purchases and sales of securities are recorded on a trade-date basis. The cost of investments sold is computed on an average cost basis for all realized gains and losses. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments

Benefit payments are recorded when paid.

Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability. The Plan distributed the 2024 excess contributions to the applicable participants before March 15, 2025.

Subsequent Events

The Company has evaluated subsequent events through September 15, 2025 which is the date these financial statements were available to be issued.

NOTE 3 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") *Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 3 FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: The NAV of the pooled separate accounts are based on the market value of the underlying investments. The NAV of the pooled separate accounts are not publicly-quoted prices in an active market. The pooled separate accounts invest in various mutual funds, equity and debt securities and commercial real estate to generate their investment return.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 TAX STATUS

The Plan has adopted a prototype plan which has received an opinion letter from the IRS dated November 14, 2022. The letter states the providers' prototype, as then designed, was in compliance with the applicable requirements of the IRC. The Plan itself has not received a determination letter from the IRS. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 5 INFORMATION CERTIFIED BY QUALIFIED INSTITUTION

The following information provided by Empower Trust Company, LLC, and Empower Annuity Insurance Company of America, the trustees of the Plan, for the years ended December 31, 2024 and 2023 was certified by them to be accurate and complete with respect to the following:

- (a) The assets held by Empower Trust Company, LLC and Empower Annuity Insurance Company of America at December 31, 2024 and 2023 as well as the transactions involving these assets for the year ended December 31, 2024.
- (b) The amount of investment income for the year ended December 31, 2024.
- (c) The Schedule H, Line 4i – Schedule of Assets (Held at End of Year) at December 31, 2024.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

NOTE 7 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

In 2016, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Great-West Trust Company, LLC and Great-West Life & Annuity Insurance Company ("Great-West"). Great-West maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is reviewed on a quarterly basis for resetting. Either party may terminate the contract with at least 60 days advance written notice to the other party.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Great-West, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

NOTE 7 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (CONTINUED)

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan, (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with participants.
