## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the  
High Falls Operating Company, LLC Hourly Employees 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the High Falls Operating Company, LLC Hourly Employees 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

## **NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023**

### ***Note 1*** **Description of Plan**

The following brief description of the High Falls Operating Company, LLC Hourly Employees 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

#### **General**

The Plan is a defined contribution benefit plan sponsored by High Falls Operating Company, LLC (the Company or the Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. American Trust Company (American Trust) is the trustee, custodian and recordkeeper of the Plan.

#### **Eligibility**

Non-excluded classes of employees employed as of May 1, 1995 are eligible to participate in the Plan. After that date, employees of the Company who are at least 21 years old, have completed six months of service, and who are not considered non-union, leased or other specified classes of employees, are eligible to participate in the Plan. Participation in the Plan is allowed starting the first day of the month coincident with or following the date the requirements are satisfied.

#### **Contributions**

Participants may elect to make pretax and Roth contributions to the Plan up to a maximum of 50% of compensation, subject to Internal Revenue Code (IRC) limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans after meeting eligibility requirements. The Plan provides a Company match contribution equal to 50% of each participant's contributions up to a maximum of 2% of participant compensation.

On an annual basis, elective deferrals are automatically increased by 1% until the participant reaches a 15% deferral, unless the participant opts out of auto escalation.

The Company may also make annual profit-sharing contributions in an amount to be determined by the Plan Sponsor. No annual profit sharing contributions were made to the Plan for the years ended December 31, 2024 and 2023.

### ***Note 1***    **Description of Plan - Continued**

#### **Participant Accounts**

Each participant's account is credited with salary-reducing contributions, Company matching contributions, profit sharing contributions and earnings (losses) as allocated. The account is reduced by the payment of benefits and an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefits to which a participant is entitled are the benefits that can be provided from the participant's vested account.

#### **Vesting**

Each participant is fully vested in his or her salary reduction account and profit-sharing contributions. Participants become 100% vested in employer matching contributions upon completion of three years of service.

#### **Investments**

Participants direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan. Participants may change their investment options at any time.

#### **Payment of Benefits**

The Plan provides for normal retirement benefits upon reaching age 65 and has provisions for early retirement, disability, death, obtaining age 59½, hardship and termination benefits for those participants who are eligible to receive such benefits. If the value of a terminated employee's account does not exceed \$5,000, including rollover contributions, the participant's balance will be distributed or subject to automatic rollover at that time.

#### **Plan Expenses**

Administrative expenses may be paid for by the Company or the Plan.

### ***Note 2***    **Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### **Subsequent Events**

In preparing the financial statements, management has evaluated events and transactions for potential recognition or disclosure through August 21, 2025, the date the financial statements were available to be issued.

#### **Use of Estimates**

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Payment of Benefits**

Distributions of benefits to participants are recorded when paid.

#### **Risk and Uncertainties**

The Plan invests in investment securities which are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as inflation, a pandemic or international conflict. Due to the level of risk associated with these investment securities, it is at least reasonably possible that changes in their values will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### ***Note 3***    **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan follows the fair value measurement guidance required by accounting principles generally accepted in the United States of America for financial and nonfinancial assets and liabilities. This guidance defines fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements.) The three levels of the fair value hierarchy are described below:

Level 1    Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value.

**Common/Collective Trust Fund:** Valued at net asset value (NAV) based on the underlying assets of the trust. The NAV is used as a practical expedient to estimate fair value and is obtained from information provided by the investment advisor using the audited financial statements of the common/collective trust at year end.

**Registered Investment Companies:** These investments are valued using the NAV provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

***Note 5***     **Federal Tax Status**

The Plan adopted a non-standardized pre-approved profit sharing plan document sponsored by AT Retirement Services LLC. The profit sharing plan provider has received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, as to the non-standardized profit sharing plan's qualified status. The non-standardized profit sharing plan opinion letter has been relied upon by the Plan. The Plan has been amended since receiving the non-standardized profit sharing plan opinion letter. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

***Note 6***     **Plan Termination**

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, the accounts of all participants become fully vested and nonforfeitable.
