NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following is a brief description of the Lactalis American Group, Inc. Retirement Plan (the Plan) provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan with salary reduction features as permitted under Section 401(k) of the Internal Revenue Code. The Plan is funded by employee and employer contributions and covers substantially all eligible employees of Lactalis American Group, Inc. (the Company and Plan Sponsor). The assets of the Plan are maintained in a trust held by John Hancock Trust Company LLC (John Hancock). Investment fees are paid by the Plan. Administrative expenses not paid by the Plan are paid by the Plan Sponsor. The Plan is intended to conform to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent legislation, where applicable.

Eligibility

All employees of the Company, other than leased employees, non-resident aliens, seasonal employees, employees on assignment from a parent company and participating in the parent company's retirement plan, and employees covered by a collective bargaining agreement (unless the terms of the bargaining agreement otherwise provides), are eligible to participate in the Plan. Employees may elect to become participants of the Plan upon the first of the month coinciding with or next, following the completion of six months of service with the Company. Effective January 1, 2024, the Plan was amended to allow interns, who were eligible for the Plan as of December 31, 2023, to participate in the Plan.

Contributions

Participants may authorize a pre-tax or Roth elective deferral contribution rate between 1% and 85% of compensation, up to the maximum annual limitations as provided by the Internal Revenue Code. Employees who are age 50 or older by the end of the calendar year are allowed to make an additional "catch-up" contribution. This contribution was limited to \$7,500 in 2024 and 2023. The "catch-up" contribution is not subject to the employer matching contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company may contribute a discretionary matching contribution to those participating employees who have elected to make employee contributions, up to a maximum of 2% of employee compensation. The Company may also make a base contribution to the Plan equal to 5% of employee compensation. However, an employee who is a member of Teamsters Local 264 will receive a base contribution equal to 6% of employee compensation, which is deposited into another qualified plan as outlined in the Union Agreement. An employee who is a member of the Teamsters Local 264 will receive a service contribution into the Plan equal to \$10 for each year of accrued service.

The Company may also make an annual discretionary contribution to the Plan. No additional discretionary contributions were made to the Plan during 2024 and 2023.

1. DESCRIPTION OF THE PLAN (Continued)

Contributions (Continued)

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment allocation and transfer funds amongst investments daily.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions, (b) plan earnings and losses, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may receive their accumulated vested benefits held by the Plan's trustee upon termination of employment or elect to keep their vested balance in the Plan until the earlier of normal retirement age, death, or disability if their account balance is in excess of \$5,000. Effective January 1, 2024, this amount increased to \$7,000. If the participant elects to keep their interest in the Plan, the participant's account will continue to receive its share of earnings or losses.

Vesting

All participants are immediately 100% vested in their employee deferral contributions, employer matching contributions, base contributions, and service contributions, plus actual earnings (losses) thereon. Any participant who is employed by the Company on or after October 1, 2006 shall at all times have a vested right to their account derived from employer discretionary contributions.

Forfeited Accounts

Forfeitures of nonvested separated participants are first used to pay certain administrative expenses and then applied toward future employer contributions. During 2024 and 2023, forfeitures of non-vested accounts and earnings on unused amounts totaled \$285 and \$275. No forfeitures were used to reduce employer contributions or to offset administrative expenses during 2024 and 2023.

Hardship Withdrawals

Participants who have suffered a financial hardship, as defined in the Plan Document, may take withdrawals up to the value of their vested account balance.

Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum amount, which is the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, but may exceed five years for the purchase of a primary residence, in which cases may not exceed ten years. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits

Participants are eligible for retirement benefits upon reaching age 65. Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or distributions based on various annuity options or fixed income payments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants who have reached age 59½ may take in-service distributions.

1. DESCRIPTION OF THE PLAN (Continued)

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan prepares its financial statements on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's assets are held in a trust maintained by John Hancock. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized gain on investments and net unrealized gain on investments include the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan Document.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan's assets include various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to the value of such investments, changes in the values of investments will occur and such changes could materially affect the amounts reported in the financial statements.

Income Taxes

The Internal Revenue Service has determined and informed the Company by a letter dated November 15, 2022 that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Administrative Expenses

The Plan's administrative and investment advisor expenses are paid by both the Plan and the Company.

3. FAIR VALUE MEASUREMENTS

The Plan uses various valuation techniques in determining fair value. FASB ASC Section 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued based on quoted market prices in active markets.

Pooled Separate Account: The pooled separate account (PSA) is made available to participating plans through a group annuity contract. The group annuity contract provides for the following account:

- New York Life Insurance Anchor Account III Stable Value Fund - is the underlying investment account in which all contributions are invested. This is a book value record of the amounts deposited to and withdrawn from the PSA. That is, the stable value fund is at all times equal to the contributions made to the contract, plus interest credited, plus dividends, if any, minus expenses withdrawn and minus withdrawals made from the account.

The assets in the PSA are invested primarily in fixed income securities. The assets in the PSA are priced by independent third parties. If a price is not available from an outside vendor and two independent dealer quotes are not available, a price will be derived as follows:

3. FAIR VALUE MEASUREMENTS (Continued)

The value of any security for which market quotations are not readily available shall be determined based on a consideration of all available facts and all available information, including, but not limited to, the following: (i) the fundamental analytical data relating to the investment, (ii) the value of other relevant financial instruments, including derivative securities, traded on other markets or among dealers, (iii) an evaluation of the forces which influence the market in which these securities are purchased and sold (e.g., the existence of merger proposals or tender offers that might affect the value of the security), (iv) the type of the security, (v) the size of the holding, (vi) the initial cost of the security, (vii) trading volumes on markets, exchanges, or among dealers, (viii) price quotes from dealers and/or pricing services, (ix) values of baskets of securities traded on other markets, exchanges, or among dealers, (x) changes in interest rates, (xi) information obtained from the issuer, analysts, other financial institutions and/or the appropriate stock exchange (for exchange-traded securities), (xii) an analysis of the company's financial statements, (xiii) government (domestic or foreign) actions or pronouncements, and (xiv) other news events.

Interest is accrued daily and credited monthly to the stable value account and reflects the investment experience of the PSA. Interest rates are guaranteed to be no less than 0%, before any deduction for expenses. The contract provides that, subject to certain restrictions, withdrawals for benefit payments at death, retirement, disability and termination of employment, and for loans, hardship withdrawals or in-service withdrawals as permitted by the plan. At contract termination, a participating plan may receive a book value distribution of the plan's interest in the stable value account, provided the plan sponsor provides twelve months' advance written notice. Transfers to a competing fund must first go through a non-competing investment option for at least 90 days. There are no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
