NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following brief description of The Chautauqua Center, Inc. 403(b) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan available to all employees of The Chautauqua Center, Inc. (the Center) who meet certain eligibility requirements. The Plan is administered by the Center. Plan investments are participant directed and maintained in investment funds held by Hand Benefits & Trust Company (HB&T), the custodian. Benefit Plans Administrative Services, LLC (BPAS) is the recordkeeper of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees are eligible to begin making elective deferrals on their date of hire. Employees covered by a collective bargaining agreement, certain nonresident aliens, and per diem employees are excluded from employer matching eligibility. Employees must be at least 21 years of age and have completed one year of service and 1,000 hours of service in order to be eligible for Plan Sponsor matching contributions.

Contributions

The Plan operates as a defined contribution plan with a 403(b) provision. Participants may contribute an elective deferred contribution on a pre-tax and/or after-tax basis not to exceed the limits imposed by the Internal Revenue Code. All eligible employees are automatically enrolled in the Plan and have elective deferrals withheld in the amount of 4% of compensation unless they elect otherwise. If participants do not make a deferral election, the automatic deferral amount will increase by one percent of compensation after the second year and each January 1st thereafter until a maximum of 8% of compensation is reached. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions as of January 1, of that calendar year. Participants may also contribute amounts representing distributions from other qualified plans (rollover).

The Center will make a matching contribution equal to 50% of the first 8% of the employee's deferrals. The Center's matching contributions amounted to \$300,718 and \$186,440 for the years ended December 31, 2024 and 2023, respectively. Employees must have earned 1,000 hours of service during the Plan year and must be employees on the last day of the Plan year. At its discretion, the Center may also contribute a profit-sharing contribution to the Plan for each employee that meets the eligibility requirements. The Center made profit-sharing contributions in the amount of \$21,000 and \$20,000 for the years ended December 31, 2024 and 2023, respectively, which are included within employer contributions on the statements of changes in net assets available for benefits. Total employer contributions for the years ended December 31, 2024 and 2023 amounted to \$321,718 and \$206,440, respectively. The Center can also make non-elective contributions to the Plan. There were no non-elective contributions for the years ended December 31, 2024 and 2023.

1. DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution, the employer's contributions, and Plan earnings/losses on all contributions. Allocations of earnings/losses and administrative expenses are based on account balances, according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately fully vested in their voluntary contributions to the Plan. Employer matching contributions made by the Center are vested at the following percentages:

Forfeitures

Forfeited account balances are used to reduce future employer contributions. Forfeitures amounted to \$9,758 and \$10,176 for the plan years ended December 31, 2024 and 2023, respectively. The Company used \$9,867 and \$10,251 of forfeitures to reduce employer contributions during the years ended December 31, 2024 and 2023, respectively. Net earnings on forfeited balances amounted to \$110 and \$91 for the years ended December 31, 2024 and 2023, respectively. Unused forfeitures as of December 31, 2024 and 2023 amounted to \$17 and \$16, respectively.

Notes Receivable from Participants

Participants may borrow an amount of at least \$1,000, and not in excess of 50% of their vested account balance up to a maximum of \$50,000. Loans are repayable over not more than five years except in the case of a loan taken out for the purpose of purchasing a primary residence. All loans bear interest at a reasonable rate of interest as determined by BPAS. The maximum number of loans you can have outstanding at any time is one, which includes any previous loans taken that were not paid back in full.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expenses when they are incurred. Principal and interest is paid by check or other method prescribed by the Plan.

Payment of Benefits

Upon termination of service due to retirement, death disability, or as required by law, a participant may elect to receive installment distributions or a lump-sum distribution in an amount equal to the vested value of their account. The Plan permits in-service distributions for participants older than age 59½.

Hardship Withdrawals

Participants who have suffered a financial hardship as defined in the Plan document may take withdrawals up to the value of their vested account balance. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

1. DESCRIPTION OF PLAN (Continued)

Plan Termination

Although it has not expressed any intent to do so, the Center has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the accompanying financial statements.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain administrative expenses are paid by the Center and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Income Taxes

The Plan is exempt from federal income tax under Section 403(b) of the Internal Revenue Code. The Plan is required to operate in conformity with the Internal Revenue Code in order to maintain its tax exempt status for Plan participants. The Plan obtained its latest determination letter on March 31, 2017, in which, the Internal Revenue Service states that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Estimates

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

4. FAIR VALUE MEASUREMENTS (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Funds: The stable value funds are calculated as accumulated cash contributions and interest credited to the Plan's contracts, less any expenses and withdrawals. The fund has observable pricing inputs, including quoted prices for similar assets in the active or non-active markets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
