## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the  
Communities In Schools of Houston, Inc. 403(b) TDA Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Communities In Schools of Houston, Inc. 403(b) TDA Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (collectively, the financial statements).

Plan management (Management), having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion on the Financial Statements***

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (US GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that Management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with US GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect Management's responsibility for the financial statements.

### NOTE 1: DESCRIPTION OF THE PLAN

The following description of the Communities In Schools of Houston, Inc. 403(b) TDA Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions, which is available from the plan administrator.

#### *General*

The Plan is a tax deferred annuity plan covering all full-time and part-time nonstudent employees of Communities In Schools of Houston, Inc. (the Organization, the Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Contributions*

Each year, Participants may contribute a percentage of pretax annual compensation, as defined in the Plan document. In addition, participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Contributions and catch-up contributions up to 5% of pre-tax annual compensation are held in the Communities In Schools Houston, Inc. 403(b) DC Plan, any amounts in excess of 5% are held in the Communities in Schools Houston 403(b) TDA Plan. Participants may also rollover amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations. There are no employer contributions in the Plan.

#### *Participant Accounts*

Each participant account is credited with the participant's contribution and allocations of Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are vested immediately in their contributions plus actual earnings thereon.

#### *Plan Loans*

Participants may borrow directly from their fund accounts at the Teachers Insurance and Annuity Association - College Retirement Equities Fund (TIAA-CREF). The maximum loan amount is the lesser of \$50,000 or 45% of a participant's combined Teachers Insurance and Annuity Association of America (TIAA) Traditional and College Retirement Equities Fund (CREF) account balances. Funds borrowed must be collateralized by setting aside 110 percent of the loan amount in a Retirement Loan Certificate, which is a separate TIAA Traditional Annuity account. As of December 31, 2023 and 2022, approximately \$18,431 and \$38,577, respectively, of annuity account values (110 percent of outstanding loans from TIAA-CREF) are held as collateral for the related loans, which are included as Investments in the accompanying Statements of Net Assets Available for Benefits.

During 2024, no plan loans went into default. If a loan were to default, the IRS would consider the outstanding balance a taxable distribution at the time of default, which may also be subject to early withdrawal penalties.

### *Payment of Benefits*

Upon separation of service due to death, disability, retirement or termination of employment, a participant may elect to receive lump-sum, partial payments, installment payments, or annuity equal to the value of the participant's vested interest in his or her account. Effective October 1, 2013, the Plan allows participants to make in-service withdrawals at age 59 ½. The Plan also allows for the forced distribution of accumulations less than or equal to \$1,000.

### *Plan Termination*

Although it has not expressed an intention to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

## NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (US GAAP).

### *Use of Estimates*

The preparation of financial statements in conformity with US GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's assets are invested in variable annuity accounts of the (CREF), an investment company, and TIAA Traditional Annuity Account Group Supplemental Retirement Annuity (GSRA). The Plan's investments in CREF are stated at their fair value as of the financial statement date. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The GSRA investment is fully benefit-responsive and is stated at contract value, which is equal to principal plus accrued interest. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by TIAA-CREF. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. All specific transaction and fund management fees are netted against the investment returns of the respective fund.

### *Payment of Benefits*

Benefits are recorded when paid.

### NOTE 3: INVESTMENTS AND INVESTMENT INCOME (CERTIFIED BY CUSTODIAN)

Information related to investments as of December 31, 2024 and 2023, and the related investment income and realized and unrealized gains for the year ended December 31, 2024, were certified by the TIAA-CREF (Custodian), as permitted by Regulation 29 CFR 2520.103-8 of the Department of Labor (DOL) rules and Regulations for Reporting and Disclosure under ERISA.

### NOTE 4: FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, (FASB ASC 820) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in an active market for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year end.

*Money market fund:* Valued at cost, which approximates fair value.

### NOTE 5: CONTRACT WITH INSURANCE COMPANY

The TIAA Traditional Annuity is a fixed-dollar annuity contract and the contract is issued directly to the participants of the Plan. The TIAA Traditional Annuity is offered through GSRA for the Plan. The TIAA Traditional Annuity within GSRA have no liquidity restrictions and are benefit responsive as defined by FASB ASC 962-325-20.

Contributions to the TIAA Traditional Annuity buys a contractual or guaranteed amount of future benefits for the participant. As a guaranteed annuity backed by TIAA's claims paying ability, the TIAA Traditional Annuity guarantees principal and a minimum interest rate, plus the opportunity for additional amounts in excess of the guaranteed rate. These additional amounts, when declared by the TIAA Board of Trustees, remain in effect for the 12-month "declaration year," which begins each March 1. Additional amounts are not guaranteed for future years.

Interest credited to TIAA Traditional Annuity accumulations includes a guaranteed rate, plus additional amounts that are established on a year-by-year basis. The guaranteed annual interest rate is three percent for all premiums remitted since 1979 under all TIAA Traditional Annuity accumulating contracts.

### NOTE 6: PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments are managed by TIAA-CREF, the custodian of the Plan. Therefore, these transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA. Certain administrative functions are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan for administrative functions he or she performs.

### NOTE 7: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities that are exposed to various risks such as interest rates, market and credit risks. Market values of investments may decline for a number of reasons, including changes in prevailing market and interest rates, increases in defaults and credit rating downgrades. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that some changes could materially affect participant account balances, and the assets reported in the Statements of Net Assets Available for Benefits.

### NOTE 8: PLAN TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (the Code). The terms of the Plan have been prepared to conform with the guidance provided by the Internal Revenue Service (IRS). The Plan Sponsor adopted a pre-approved volume submitter 403(b) plan in 2013. The IRS determined that the volume submitter 403(b) plan, by a letter dated August 07, 2017, is designated in accordance with applicable sections of the IRC. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

The Plan Sponsor believes that the Plan, as amended and restated, and its underlying trust have operated within the terms of the Plan and remain qualified under the applicable provisions of the IRC. The Plan has been amended since receiving the determination letter; Plan management believes that the Plan is currently designed and operating in accordance with the applicable requirements of Section 403(b) of the Code and, therefore, believes the Plan is qualified and the related custodial accounts and tax-deferred annuities are tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

US GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### NOTE 9: DELINQUENT PARTICIPANTS CONTRIBUTIONS

During the year 2022, the Organization determined that, in a few instances, employee deferrals and loan repayment aggregating \$21,957 had not been remitted to the Plan in a timely manner, in accordance with DOL regulations. Although these remittances were made, they fell outside the normal processing time the Company allows.

The Organization calculated the lost earnings associated with these late remittances and deposited the corresponding amounts into the Plan. All late remittances related to the 2023 plan year, previously
