Note 1. Description of the Plan

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Beck Group Retirement Savings Plan (the Plan) is a defined contribution plan available to substantially all qualified full-time salaried employees of HCBeck, Ltd. (collectively, The Beck Group or Employer). The Plan is administered by a committee (the Employee Benefits Committee) appointed by the Management Committee of HCBeck, Ltd. T. Rowe Price Retirement Trust Services (Trustee) serves as the Plan's trustee and T. Rowe Price Retirement Plan Services, Inc. (Recordkeeper) serves as the Plan's recordkeeper.

In October 2023, the Company sold its wholly owned subsidiary Beck Technology, Inc. As a result of its sale, on February 15, 2024, the accounts of all Beck Technology, Inc. employees were transferred out of the Plan to Beck Technology, Inc.'s 401(k) Plan. The transaction is summarized as transfer to other plans in the statements of changes in net assets available for benefits.

Contributions

The Plan provides for participation in a tax-deferred, tax free or "Roth", an after-tax savings program by all full-time salaried employees with 30 consecutive days of employment. Participants in the Plan may contribute up to 100 percent of their earnings on a tax-deferred basis or 100 percent of after-tax earnings or a combination of both. The Plan has an automatic enrollment feature at 6 percent of compensation in the tax-deferred program, requiring employees to opt out should they desire not to participate.

Contributions for participants in the Plan under the automatic enrollment feature are invested in a T. Rowe Price Target Retirement Fund based on the anticipated retirement date of the participant. Effective January 1, 2020, the Plan matched 100 percent of each participant's contributions, limited in the aggregate to 3 percent of pretax earnings, excluding bonuses, pre-participation compensation and expense allowances. Effective July 1, 2022, the discretionary match contribution may be allocated in different uniform percentages for different employee groups of the eligible contributions made by eligible employees within the group. Effective January 1, 2024, employee contributions are no longer subject to true up matching contributions. During 2024, the Plan matched 100 percent of each participant's contributions, limited in the aggregate to 6 percent of pretax earnings, excluding bonuses, pre-participation compensation and expense allowances.

The Beck Group may make additional discretionary matching contributions or Qualified Non-Elective Contributions to eligible participants through its Retirement Income Program. There were no Qualified Non-Elective Contributions and no additional discretionary matching contributions made during the years ended December 31, 2024 and 2023. The amount of the Qualified Non-Elective Contribution varies based upon the age of the participant, a percentage of the "test compensation" (compensation used in applying federal nondiscrimination tests) or a percentage of the compensation for the Plan Year of the participant. Contributions are allocated to the Plan's investment options based upon the participant's election. Participants may change their elections at any time. For Non-Highly Compensated Employee, The Beck Group may make a special "failsafe" Qualified Matching Contributions to participant accounts in order to failsafe federal nondiscrimination rules. Contributions are deposited in a trust account from which benefits are paid. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and the allocations of Company's matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Under the provisions of the Plan, participants are vested immediately in their contributions. The Beck Group's contributions and forfeiture allocations, including attributable earnings, vest as follows:

Notes Receivable from Participants

Participants may obtain loans for an amount not to exceed the lesser of 50% of the participant's vested interest in the Plan balance or \$50,000. The loans are maintained and serviced by the Trustee as investments of the Plan. All loans bear interest equal to the prevailing prime rate of interest in the Dallas, Texas area at the time the loan is granted plus 1% (prime was 7.5% and 8.5% at December 31, 2024 and 2023, respectively). Principal and interest are paid ratably through periodic payroll deductions.

Payment of Benefits

Upon separation of service due to death, disability, retirement or termination of employment, a participant's total vested balance is paid to the participant or designated beneficiary in a lump sum.

Forfeited Accounts

Forfeitures not used to restore amounts previously forfeited by re-employed participants or to reduce plan expenses are allocated to participants' accounts on the basis of annual Employer contributions as defined in the Plan document. For the years ended December 31, 2024 and 2023, forfeitures used to offset employer contributions were \$244,979 and \$539,131, respectively. As of December 31, 2024 and 2023, forfeitures available for future use were \$9,575 and \$2,701, respectively.

Investment Options

Upon enrollment in the Plan, a participant may direct their contributions and any related earnings into a number of distinct active investment options. Employer Safe Harbor matching contributions and discretionary contributions subject to the vesting schedule described above are invested in accordance with the investment choices selected by each respective participant.

Unallocated Assets

Net, unallocated assets consist primarily of a contribution receivable from the employer for the Retirement Income Program, which has not been allocated to the participants' accounts less accrued expenses of the plan. There were no unallocated net assets at December 31, 2024 and 2023, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make significant estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ significantly from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recognized on the accrual basis.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation in the fair value of its investments, which consists of realized gains and losses and unrealized appreciation on those investments.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Plan Management's Review of Subsequent Events

The Plan has evaluated subsequent events through September 15, 2025 the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued using the NAV of the fund shares.

Collective trust funds: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Stable value fund: Valued at the NAV of the shares held by the Plan at year end, which is based on the fair value underlying investments using information reported by the investment advisor at year end. The NAV, as provided by the trustee is used as a practical expedient to estimate fair value.

Note 4. Related Party Transactions and Party in Interest Transactions

Certain Plan investments are shares of mutual funds, money market, stable value and common/collective trust accounts managed by T. Rowe Price. T. Rowe Price is the record keeper and trustee for the Plan and, therefore, these transactions qualify as party in interest transactions. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan.

Note 5. Plan Termination

Although it has not expressed any intent to do so, The Beck Group has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and the Plan assets will be distributed in accordance with the provisions of the Plan.

Note 6. Tax Status

The IRS has determined and informed the Company by a letter dated August 19, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that some changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
