Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of HX5, LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of HX5, LLC 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

NOTE 1 DESCRIPTION OF THE PLAN

The following description of the HX5, LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan generally covering substantially all employees of HX5, LLC (the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is designed to comply with Section 404 (C) of the Internal Revenue Code. The Plan is administered by HX5, LLC. However, various record-keeping, compliance, and financial reporting requirements are performed through the contracted plan administrator, Great-West Life and Annuity Insurance Company as of December 31, 2024.

Contributions – Participants may contribute a percent of their annual compensation to the Plan not to exceed the limits allowable by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options. The Company matches 100 percent of the first 3 percent of contribution and ½ percent on the next 2 percent of contribution of wages. Additional profit sharing amounts may be contributed at the discretion of the Company's board of directors. All contributions are participant directed.

Participant Accounts – Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are vested immediately in their contributions and employer matching contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after five years of credited service. At December 31, 2024 and 2023, the vested benefit for terminated employees was \$17,783,827 and \$12,698,701, respectively.

Participant Loans – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a rate between 4.25 – 9.95 percent, which is commensurate with local prevailing rates.

Payment of Benefits – Benefit payments are made in a lump sum payment, in cash, upon the participant's death, disability, or retirement. Normal retirement is at age 65. Early retirement can be elected at age 59.5. Prior to termination of employment, participants satisfying certain conditions may be allowed certain in-service distributions subject to certain limitations.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The Plan presents in the statement of changes in net assets available for plan benefits, the net appreciation in the fair value of its investments which consists of the realized gains or losses on investments sold during the year and the unrealized appreciation on investments held at year end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when properly executed requests for distribution are received.

Administrative Expenses

Broker fees are paid from the participants' individual brokerage accounts. The Plan permits the payment of Plan administrative expenses to be made from the Plan assets. These expenses will generally be allocated among the accounts of all participants in the Plan based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan.

Subsequent Events

The Plan has evaluated subsequent events through the date the financial statements were available to be issued.

There were no material subsequent events which require disclosure at December 31, 2024.

NOTE 3 UNAUDITED INFORMATION

Great-West Life & Annuity Insurance Company holds the Plan investment assets and executes transactions as of December 31, 2024 and 2023. Financial information for 2024 and 2023 relating to these assets is included in the accompanying financial statements and is based on information provided by the trustees. This financial information presented on pages 3, 4 and in Notes 4 and 8 has not been audited by independent auditors.

NOTE 4 FAIR VALUE MEASUREMENTS—UNAUDITED

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual Funds – Valued using the net asset values provided by Great-West Life & Annuity Insurance Company at year end.

Participant Loans – Valued at amortized cost, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 TAX STATUS

The Plan received a favorable determination letter from the Internal Revenue Service dated June 30, 2020, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The plan tax reports are subject to examination by taxing authorities, generally, for the most recent three years.

NOTE 6 PLAN AMENDMENTS AND TERMINATIONS

The Plan was amended effective January 1, 2012 to provide the effective date of participation. An eligible employee shall become a participant effective as of the day such employee met the eligibility requirements.

The Plan was amended effective December 18, 2012 to provide for mandatory involuntary cash-out distributions. Any distribution to a participant who has a total vested benefit exceeding \$1,000 shall require written consent if the distribution occurs during the time the benefit is immediately distributable. However, if the vested account balance does not exceed \$1,000, then a distribution will be made regardless of consent. Rollovers from other Plans may be distributed to the participant's Rollover Account at any time and the Rollover Account balance shall not be considered when determining whether the \$5,000 threshold has been exceeded.

The Plan was amended effective August 15, 2013 to further define an eligible employee. An eligible employee is any employee except for the employees of affiliated employers who are unaffiliated with the plan, an individual that is not reported on the payroll records of the employer as a common law employee, or an employee that became an employee through an asset or stock acquisition, merger, or similar transaction.

The Plan was amended effective January 1, 2014 to further determine the definition of compensation. Compensation will exclude reimbursements, fringe benefits, moving expenses, welfare benefits, overtime, and bonuses while including both pre-participation compensation and post-severance compensation.

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in all employer contributions.

NOTE 7 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefit.

NOTE 8 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT—UNAUDITED

For the years ended December 31, 2024 and 2023, the Plan had investments in a fully benefit-responsive investment contract with Great-West's Stable Value Fund. Great-West Life and Annuity Insurance Company maintains the contributions in a pooled account. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is not contractually obligated to repay the principal and there is no specified interest rate that is guaranteed to the Plan.

Because the investment contract is fully benefit-responsive, contract value is a relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. The investment contract is presented on the face of the statement of net assets available for benefits at fair value. The balance at December 31, 2024 and 2023 were \$2,475,459 and \$2,442,245, respectively.

Contract value, as reported to the Plan by Great-West Life and Annuity Insurance Company, represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract approximates fair value.

Great-West Life and Annuity Insurance Company does not guarantee a credited rate of interest on the amounts allocated to the Stable Value Option fund. There is no minimum or maximum guaranteed interest rate under the investment contract.

Certain events limit the Plan's ability to transact at contract value with Great-West Life and Annuity Insurance Company. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with Plan participants or the issuer, is probable.
