We have performed audits of the financial statements of Byrne Electrical Specialists, Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). ### 1. Plan Description

The following brief description of the Byrne Electrical Specialists, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering all eligible employees of Byrne Electrical Specialists, Inc. (Plan Sponsor) and the following adopting employers: Byrne Tool & Die, Inc. and Wee Folk Rockford Child Care Center, Inc. (collectively referred to as the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Employees become eligible to participate in the Plan immediately upon hire after attaining the age of 18. There is an additional requirement of 60 days' employment for production workers to be eligible for the Plan.

#### *Contributions*

Each participant may elect to contribute a percentage of their annual compensation, as defined by the Plan, subject to certain limitations. Bonuses are excluded from compensation for all contribution types.

Employees are automatically enrolled into the Plan at a deferral rate of 3%. Employees may elect an alternative deferral amount or elect not to participate. The Plan also allows for Roth and/or after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company makes a matching contribution equal to 25% of the elective contributions made by the participants, up to a maximum of \$500 annually in 2024 and 2023. The Company also may contribute an additional discretionary amount to each participant's account, as determined annually by the Company. The Company did not approve additional discretionary contributions in 2024 or 2023.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions and an allocation of the Company's contributions, forfeitures, and Plan earnings or losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

Participants direct the investment of the contributions into various investment options offered by the Plan.

#### *Vesting*

A participant's interest in his or her elective contribution account and rollover contribution account, plus actual earnings thereon, is 100% vested at all times.

Interest in a participant's matching contribution account and discretionary employer contribution account becomes vested after one year of service.

### ***Forfeitures***

Forfeitures attributable to the Company's matching contributions may be used to reduce future Company contributions or to pay Plan expenses. Forfeitures attributable to the Company's discretionary contributions are reallocated among eligible participants. Forfeitures used to reduce Plan expenses were \$5,363 and \$9,250 during 2024 and 2023, respectively. Unallocated forfeitures as of December 31, 2024 and 2023 were \$446 and \$1,652, respectively.

### ***Payment of Benefits***

Participants, or their beneficiaries, may request payment of benefits at any time after their retirement, termination of employment, or death. The Plan allows for total or partial in-service withdrawal prior to retirement if the participant meets certain age or hardship withdrawal requirements. Such withdrawals are subject to approval by the Plan administrator.

### ***Administrative Expenses***

Fees incurred as a result of participant-directed transactions (e.g., distribution fees) are charged directly to the participant's account. Certain administrative expenses of the Plan are allocated pro-rata to participant accounts.

### ***Subsequent Events***

Subsequent events have been evaluated by management through September 22, 2025, the date these financial statements were available to be issued.

## **2. Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements are prepared under the accrual method of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Actual results could differ from those estimates.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset (an exit price) in the principal or most advantageous market for the asset in an orderly transaction between market participants on the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes gains and losses on investments bought and sold, as well as held during the year.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Contributions Receivable*

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

## **3. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company, a qualified institution.

## **4. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following is a description of valuation methodologies that were used for assets measured at fair value:

*Collective Trust Fund* - The Plan invests in the MetLife Stable Value Fund, a collective trust fund. The fair value of the Plan's interest in the fund is based on net asset value (NAV) as determined by the fund manager based on the underlying investments of the fund (primarily guaranteed investment contracts and fixed-income securities) and as supported by the unit prices of actual purchases and sales transactions occurring as of or close to the financial statement date. The NAV is used as a practical expedient to estimate fair value. This practical expedient will not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The fund provides for daily redemptions by the Plan at reported NAV with no advance-notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date. There are no unfunded commitments related to this investment.

*Mutual Funds and Exchange-Traded Funds* - These assets are valued at quoted market prices in an exchange and active market, which represents the NAV of shares held by the Plan.

The Plan's valuation methods may result in a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although Plan management believes the valuation methods are appropriate and consistent with the market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Related Party and Party-in-Interest Transactions

Matrix Trust Company is the custodian and trustee of the Plan. Participant distribution processing fees are paid to Matrix Trust Company by participants. As described in Note 1, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### 6. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

### 8. Income Tax Status

The Company adopted the pre-approved plan document sponsored by Fort William LLC. Fort William LLC received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan was since amended; however, the Plan administrator believes that the Plan, as amended, is currently designed and operating in accordance with the same sections of the IRC and is, therefore, exempt from tax.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there currently are no audits for any tax periods in progress.


