Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of TOL 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1: Description of the Plan

The following description of the TOL 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of SCI Acquisition Co., Inc. and Subsidiaries (collectively referred to as "the Company"). All Company employees who complete three months of service and are age 21 or older, excluding union employees, nonresident aliens, leased employees, and students of the federal work study program, are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to the federal maximum, as defined by the Plan. Participants may make pretax deferrals and Roth 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Company may elect to make discretionary matching contributions equal to a discretionary percentage of a participant's elective deferrals during each Plan year. The Company may also make employer profit sharing contributions in an amount determined by the Board of Directors for each plan year. For the year ended December 31, 2024, the Company made a discretionary matching contribution totaling \$116,007, net of forfeitures. For the year ended December 31, 2024, the Company did not make discretionary profit-sharing contributions.

Participant Accounts

Each participant's account is credited/debited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings/losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants vest in the Company's discretionary and profit-sharing matching contributions plus actual earnings thereon based on years of continuous service. A participant begins vesting at 20% per year, beginning in the first year of service, and each year after, until the participant is 100% vested in the Company's discretionary and profit-sharing matching contributions after five years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum equal to \$1,000 and a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The transactions are treated as a transfer to (from) the investment fund from (to) the participant notes receivable. The terms of the notes receivable range up to five years or more for the purchase of a primary residence. The notes receivable are secured by the balance in the participant's account and bear a reasonable rate of interest. Principal and interest is paid ratably through payroll deductions. An outstanding note receivable can be paid in full, at any time and can be refinanced, however, only one note receivable may be outstanding at any time.

Investment Options

The Plan provides participants with several investment options. These options consist of various registered investment companies and a Lincoln Guaranteed Return Account (GRA). Plan participants may direct the change of their investments in accordance with the Plan guidelines.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested balance in his or her account, partial lump-sum, and annual installments. Participants that separate from service and have a vested account balance of \$5,000 or less are subject to a lump-sum distribution at the discretion of the plan administrator. For termination of service due to other reasons, a participant may receive or rollover into a qualified plan the value of the vested interest in his or her account as a lump-sum distribution, net of tax withholdings, if applicable. The Plan allows for in-service withdrawals by participants who have attained the normal retirement age of 59 ½. A participant may also receive hardship withdrawals, subject to certain limitations, as defined in the Plan document.

Forfeitures

Forfeitures are made available to pay administrative expenses and reduce employer contributions under the Plan. For the year ended December 31, 2024, forfeitures of \$45,871 were applied to reduce employer contributions.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except the fully benefit responsive contract (GRA) which is recorded at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Plan Administrative Expenses

Administrative expenses are paid by the Company. Certain administrative processing fees are charged to the participants and therefore, are reflected in the accompanying statement of changes in net assets available for benefits as administrative expenses.

Financial Statement Presentation

Certain amounts in the 2023 financial statements have been reclassified to conform to the 2024 presentation.

Note 3: Information Certified by the Plan's Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Lincoln Financial Group Trust Company (LFGTC), the trustee of the Plan, and was not subjected to any auditing procedures by the independent public accountants:

- Investments and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividend income, other income, and interest income on notes receivable from participants for the year ended December 31, 2024, as included on the statement of changes in net assets available for benefits.
- The schedule of assets (held at end of year) as of December 31, 2024, as shown on Schedule H, Line 4i.

At the request of the plan administrator, the Plan's independent certified public accountants did not perform procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule. All other information has been audited in accordance with auditing standards generally accepted in the United States of America.

Note 4: Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). There are three levels of the fair value hierarchy under FASB ASC 820. Level 1 inputs are quoted market prices in active markets for identical investments that the Plan has the ability to access at the measurement date. Level 2 inputs are inputs other than quoted market prices included within Level 1 that are observable for the Plan's investments, either directly or indirectly. Level 3 inputs are unobservable inputs for the Plan's investments. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies – These investments are valued at quoted market prices in an exchange and active market, which represents the fair value of the shares held by the Plan at year-end and the Plan has concluded that these investments should be classified as Level 1.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: Guaranteed Return Account with Insurance Company

For the years ended December 31, 2024 and 2023, the Plan held an investment in a Lincoln Stable Value of \$12,888 and \$67,853, respectively. In addition, for the years ended December 31, 2024 and 2023, the Plan held an investment in YourPath Stable Value of \$340,697 and \$266,780, respectively. These investments are considered a fully benefit-responsive investment contract with LFGTC. Pursuant to this contract, LFGTC maintains a GRA as an investment option for the Plan. Funds in the GRA represent investments in the general assets of LFGTC which consist predominately of fixed income investments (bonds, mortgages, private placements) and are high quality. Payment of principal and interest is guaranteed by LFGTC, subject to a market value adjustment if the contract is terminated by the Plan. The GRA is credited with contributions and interest earnings and is charged for participant withdrawals and administrative expenses. The interest crediting rate for the GRA is set by LFGTC based on historical contributions and withdrawals, and current market conditions. The rate is adjusted quarterly and will range from 1% to 3% for the Lincoln Stable Value Account and YourPath Stable Value. The average crediting rate for the years ended December 31, 2024 and 2023 was 2.30% and 2.20%, respectively.

Note 5: Guaranteed Return Account with Insurance Company, Continued

The GRA is included in the Plan's financial statements at contract value as reported to the Plan by LFGTC. Contract value represents contributions made pursuant to the contract, plus interest earned, less participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of LFGTC or otherwise. LFGTC may terminate the investment contract if the Plan is 1) no longer deemed to be a "qualified plan" under the Internal Revenue code; 2) is terminated; 3) is changed such that LFGTC determines that the contract must be modified and the custodians of the Plan do not consent to such modifications. The plan administrator considers the occurrence of such events to be not probable.

Note 6: Party-in-interest Transactions

Certain Plan investments are managed by LFGTC. LFGTC is the trustee as defined by the Plan, and is a parties-in-interest. The Plan incurred certain LFGTC administrative fees totaling \$68,113 for the year ended December 31, 2024. The Company pays any other fees related to the Plan's operations.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in all their employer contributions.

Note 8: Tax Status

The Plan adopted a Non-Standardized Profit Sharing/401(k) Plan that the Internal Revenue Service (IRS) approved by a letter dated June 30, 2020. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and believes there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10: Excess Contributions

To meet the relevant nondiscrimination provisions of the Plan, excess contributions totaling \$24,381 are recorded as a liability in the statements of net assets available for benefits and as a reduction of participant contributions in the statement of changes in net assets available for benefits for the year ended December 31, 2024. The Plan paid these excess contributions to participants in 2025.
