NOTE 1 DESCRIPTION OF THE PLAN

The following description of the Eastern Shipbuilding Group, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan generally covering substantially all full-time employees of Eastern Shipbuilding Group, Inc. who are age 18 or older and have one month of service. The Plan is a Safe Harbor Plan which is similar to a traditional 401(k) plan, but among other things, must provide for employer contributions that are fully vested when made. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Participants may contribute a percent of their annual compensation to the Plan not to exceed the limits allowable by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options. All employer contributions, both safe harbor and profit sharing, are participant directed.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and charged with an allocation of administrative expenses incurred by the investment company. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their contributions plus actual earnings thereon. The Company makes safe harbor contributions equal to 100% of a participant's salary deferrals that do not exceed 3% of compensation, plus 50% of the participant's salary deferrals between 3% and 5% of compensation. Participants are vested immediately in employer safe harbor contributions. Each year, the Company may make a discretionary profit-sharing contribution to the Plan. This profit-sharing contribution is allocated among participants eligible to share in the contribution for the year based on compensation. Employer profit sharing contributions are subject to a five-year vesting schedule. The total vested amount of terminated employees is approximately \$1,483,019.

Participant Loans - Participants may not borrow from their accounts.

Payment of Benefits - Benefit payments are made in a lump sum payment, in cash, upon the participant's death, disability, or retirement if the sum is less than \$5,000. If the sum is greater than \$5,000, participants may select other options. For termination of service due to other reasons, a participant may receive the value of their vested interest as a lump-sum distribution. Normal retirement is at age 65. Early retirement can be elected at age 60.

Forfeited Accounts - At December 31, 2024, and 2023, there was \$-0- of forfeited non-vested accounts. Forfeited accounts are used in the following year to first to pay Plan expenses, then to reduce future employer contributions.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when properly executed requests for distribution are received.

Administrative Expenses

Broker fees are paid from the participants' individual brokerage accounts. Other administrative expenses, such as the Plan's accounting and auditing fees, are paid by the Company.

Subsequent Events

The Plan has evaluated subsequent events through August 28, 2025, the date the financial statements were available to be issued. There were no material subsequent events which require disclosure at December 31, 2024.

Common/collective trust fund

ASU 2015-07, *Fair Value Measurement (Topic 820): Disclosures for investments in Certain Entities that Calculate Net Asset Value per Share (or its Equivalent)* removes the requirement to categorize within the fair value hierarchy all investments for which fair value is measured using the net asset value (NAV) practical expedient.

**NOTE 3 UNAUDITED INFORMATION FOR 2024**

Fidelity Management Trust Company held the Plan investment assets and executed transactions therein for the year ended December 31, 2024. Financial information for 2024 relating to these assets is included in the accompanying financial statements and is based on information provided by the trustees. This financial information presented on pages 3 and 4 and in Note 5 has not been audited by independent auditors.

**NOTE 4 UNAUDITED INFORMATION FOR 2023**

Ascensus Trust Company held the Plan investment assets and executed transactions therein for the year ended December 29, 2023, except for information noted below. Financial information for 2023 relating to these assets is included in the accompanying financial statements and is based on information provided by the trustees. This financial information presented on pages 3 and 4 and in Note 5 has not been audited by independent auditors.

The Plan transferred trustees from Ascensus Trust Company to Fidelity Management Trust Company effective January 1, 2024. The valuation of assets was completed on December 29, 2023, and the assets were certified by Ascensus as of December 29, 2023. The plan went into a blackout period from December 21, 2023, through January 31, 2024. During this time, participants were not able to access accounts, obtain distributions or change deferral/investment elections. Therefore, there was no activity within the funds from the date of the certification of December 29, 2023, to year end of December 31, 2023.

However, the common/collective trust investment was transferred to Fidelity on December 29, 2023. Due to the trust agreement with Fidelity starting January 1, 2024, Fidelity did not certify the common/collective trust investment as of December 31, 2023, and as such the asset balance presented below was subjected to full-scope audit procedures.

NOTE 5 FAIR VALUE MEASUREMENTS – UNAUDITED

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 5 FAIR VALUE MEASUREMENTS – UNAUDITED (CONTINUED)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual Funds - Valued using the net asset values provided by Ascensus Trust Company at year end.

Common/collective trust – Valued at the NAV of units of a collective trust.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6 TAX STATUS**

The Plan received an opinion letter from the Internal Revenue Service dated June 30, 2020, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The income tax returns of the Plan are subject to examination by taxing authorities generally for three years after they are filed.

**NOTE 7 PLAN CONVERSION AND TRUSTEE CHANGE**

Effective January 1, 2024, the Plan underwent a conversion to a new trustee, Fidelity Management Trust Company. This change involved the transfer of plan assets, participant data, and administrative responsibilities. As part of this process, the Plan's document was converted to Fidelity Management Trust Company's Basic Plan Document Number 17 and Adoption Agreement. The conversion was executed in accordance with the terms of the Plan document and applicable regulations.

The Plan Sponsor has taken the necessary steps to ensure continuity of participant services and compliance with all applicable regulations during and after the transition. This includes providing participants with required disclosures about the change in service providers and any associated impacts, such as blackout periods.

The Company is committed to fulfilling its fiduciary responsibilities related to the Plan, including ongoing monitoring of the new trustee's performance and adherence to service agreements.

**NOTE 8 PLAN AMENDMENTS AND TERMINATION**

The Plan was amended effective October 7, 2024, to allow in-service hardship withdrawals from the participant's safe harbor match account.

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

**NOTE 9 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
