**Basis for Opinion on the Financial Statements**

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**RETIREMENT PLAN**  
**NOTES TO FINANCIAL STATEMENTS**

**A. Description of Plan:**

The following description of the Rocky Mountain Hardware, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. **General** - The Plan is a defined contribution plan covering all eligible full-time employees of Rocky Mountain Hardware, Inc. and Dura-Mark, Inc. dba Blackfoot Brass (Companies/Sponsors). The Plan was adopted on January 1, 2000. Employees become eligible upon attainment of six months of service and are age 18 or older, with the exception of union employees, non-resident aliens and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
2. **Contributions** - Each year participants may make elective deferrals of their pretax or after tax (Roth) annual compensation up to the maximum limits, as defined in the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4 percent of eligible compensation and their contributions invested in a designated target date fund until changed by the participant. The deferral rate will continue to increase annually by 1 percent until a maximum of 10% is reached.

Rocky Mountain Hardware, Inc. 401(k) Plan (the Sponsors) adopted a Safe Harbor matching Formula. Under this formula, the safe harbor contribution is calculated at 100% of a participant's elective deferral up to 4% of compensation (as defined in the Plan). At their discretion, the Sponsors can make additional contributions to the Plan in the form of discretionary profit-sharing contributions. During the years ended December 31, 2024 and 2023 the Companies did not make any discretionary contributions to the Plan. Contributions are subject to certain IRS limitations.

3. **Participant Accounts** – Each participant's account is credited with the participant's contributions and Company's matching contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. **Vesting** – Participants are 100% vested in all contributions except for Sponsors Non-Safe Harbor Matching Contributions. Sponsors Non-Safe Harbor Matching Contributions vest based on a graduated vesting schedule which is determined by continuous years of service. The Plan utilizes a graduated vesting schedule allowing a participant to become 100% vested after five years of credited service.
5. **Forfeited Non-vested Accounts** – When a participant terminates prior to fully vesting, the non-vested portion of the participant's account is used to reduce employer contributions. At December 31, 2024 and 2023, there were no forfeited non-vested account balances, respectively. In 2024 and 2023, there were no forfeited accounts used to reduce employer contributions.

**A. Description of Plan (continued):**

6. **Payment of Benefits** – Upon attaining normal retirement age of 62, termination of employment, or disability or death, a participant may receive a lump-sum amount or installments equal to the vested interest of his or her account. In-service distributions are allowed upon reaching age 59 1/2, hardship, qualified reservist distributions and deemed severance distributions.

**B. Summary of Significant Accounting Policies:**

The following are the significant accounting policies followed by the Plan:

1. **Basis of Accounting** – The financial statements of the Plan are prepared using the accrual method of accounting.
2. **Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
3. **Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Custodians determine the Plan's valuation policies utilizing information provided by the investment advisers, Trustees, and insurance company. See Note I for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. **Payments of Benefits** – Benefits are recorded when paid.
5. **Contributions** – Contributions from the Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.
6. **Subsequent Events** – The Plan has evaluated subsequent events through August 21, 2025, the date the financial statements were available to be issued.
7. **Costs of Plan Administration** – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer, Rocky Mountain Hardware, Inc. 401(k) Plan. Expenses that are paid by the employer are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

**C. Plan Termination:**

Although it has not expressed any intent to do so, the Sponsors have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

**D. Tax Status:**

The IRS has determined and informed the Companies by a letter dated June 30, 2020, that the Plan and related trust, are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### G. Concentration of Credit Risk:

Financial instruments that potentially subject the Plan to concentrations of credit risk consist of cash and short-term investments and marketable securities. The amount of exposure to any one specific investment has been limited by investing in mutual funds that use a diverse investment portfolio to limit risk.

### H. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially alter participants' account balances and the amounts reported in the statement of net assets available for benefits.

### I. Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none"><li>• Quoted prices for similar assets or liabilities in active markets;</li><li>• Quoted prices for identical or similar assets or liabilities in inactive markets;</li><li>• Inputs other than quoted prices that are observable for the asset or liability;</li><li>• Inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li></ul> If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**J. Plan Amendments:**

The Plan was restated effective August 25, 2021, to comply with the requirements for Cycle 3 Restatement.

The Plan was restated effective October 1, 2022, to change in service distribution age to 59 1/2 and to change the safe harbor matching time period to each Plan year, previously each pay period.

The Plan was amended effective January 1, 2024 to only include participating compensation.

**K. Nonexempt Party-in-Interest Transactions:**

During the year ended December 31, 2022, the Companies remitted participant deferrals totaling \$5,326 to the custodian later than required by the Department of Labor Regulation 2510.3-102. The Companies filed a form 5330 with the IRS and paid the required excise tax on the transactions. In addition, participant accounts were credited with the amount of investment income that would have been earned had the participant contributions been remitted on a timely basis.

In 2023, the Companies reimbursed the Plan for lost earnings of \$12 related to these contributions.

**L. SECURE 2.0:**

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act Secure Act 2.0. Many of the provisions have different effective dates, with some changes impacting 2023, 2024, 2025 and beyond. Plan documents are required to be formally amended for mandatory and any nonmandatory provisions adopted on or before the last day of the 2025 plan year. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.
