NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following brief description of Starbridge Services, Inc. 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a 403(b) defined contribution retirement plan, sponsored by Starbridge Services, Inc. (the Company or Plan Sponsor). The Plan covers all eligible employees of the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan sponsor completed a merger in May 2015 and as part of the merger changed its legal name from Learning Disabilities Association of the Genesee Valley, Inc. to Starbridge Services, Inc. The Plan name was subsequently amended on October 5, 2015 from Learning Disabilities Association of the Genesee Valley, Inc. 403(b) Plan to Starbridge Services, Inc. 403(b) Plan.

Administration

The Plan is administered by the Company. VOYA Retirement Insurance and Annuity Company (Voya) and Newport Trust Company, LLC (Newport) are the custodians of the Plan. USI Consulting Group is the Plan's third-party administrator.

Eligibility

Employees are eligible to participate in the Plan and may begin making salary deferrals on the first day of the first payroll period pursuant to a properly completed and valid salary deferral agreement entered into by the employees. Employees are eligible to receive employer fixed matching, discretionary matching, and nonelective contributions after completing one year of service. Subsequent to becoming eligible for employer contributions, the participant must complete 500 hours of service within a Plan year and be employed on the last day of the Plan year in order to receive employer discretionary matching and nonelective contributions. Employees hired under the Fiscal Intermediary (FI) Program are not eligible for employer discretionary matching or nonelective contributions.

Contributions

Each year participants may make voluntary pre-tax and/or roth contributions in the form of salary reductions at a maximum contribution of the lesser of 100% of the participant's total compensation for the plan year or the maximum amount permitted by Section 415(d) of the Internal Revenue Code (IRC). Participants, who attain the age of 50 before the end of the Plan year, are eligible to make catch-up contributions, subject to certain limitations of the Plan and the IRC.

The Company provides fixed matching contributions equal to 100% of participants' salary deferrals, up to 4% of a participant's compensation. The Company may also make an additional discretionary matching contribution to the Plan for those employees meeting eligibility requirements. For the years ended December 31, 2024 and 2023, the Company's Board of Directors approved a discretionary match of up to an additional 2%. The Company may also make a discretionary nonelective contribution. The Company did not elect to make a discretionary nonelective contribution in 2024 or 2023.

Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan.

1. DESCRIPTION OF PLAN (Continued)

Rollover Contributions

The Plan will accept direct rollover contributions from a qualified plan, as defined by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions, an allocation of Plan earnings/losses, and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Notes receivable from participants are not permitted under the Plan.

Payment of Benefits

The Plan provides for benefit payments upon termination of employment, attainment of normal retirement age, death or disability. Benefit payments are made in the form of a partial payment, lump sum distribution, a rollover to another qualified investment, or annual installments. Additionally, the Plan provides for in-service withdrawals once a participant reaches age 59 ½ even if still employed. Participants whose vested account balance is \$1,000 or less at the time of termination are subject to the involuntary cash-out provisions of the Plan.

Hardship Withdrawals

The Plan permits hardship withdrawals for participants who meet specified criteria, as defined by the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Employer matching and nonelective contributions vest at a rate of 20% per year of service after one year and are fully vested in employer contributions upon completing six years of credited service.

Forfeitures

Forfeitures of non-vested account balances can be used to reduce future employer contributions, or to pay for plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$5,120 and \$9,700, respectively. During the years ended December 31, 2024 and 2023, there were forfeitures of \$16,742 and \$4,736 utilized to reduce employer contributions, respectively.

Plan Administration Costs

Certain administrative expenses of the Plan are paid by the Plan out of the Plan's assets and are allocated to the account of each participant based on the account balance of each participant. The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation or depreciation of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Plan Termination

Although the Plan Sponsor has not expressed any intent to do so, it has the right to terminate the Plan subject to provisions set forth by ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investments

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. All investments are participant directed.

Fair Value Measurements - Definition and Hierarchy

The Plan uses various valuation techniques in determining fair value. Accounting Standards Codification (ASC) 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.

Mutual funds: valued based on quoted market prices in active markets.

- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.

Pooled separate accounts: valued daily using accumulation unit value (AUV). AUV represents the underlying fund's daily net asset value, plus any applicable income, less the daily separate account charge. The AUV is first established when a new fund starts (typically, the beginning AUV is \$10.00) and is then determined daily. The fund's daily net asset values are available from the custodian. The contract's daily asset charge (separate account charge) is communicated to Plan management in the contract and applicable notice of change.

- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy is determined based on the least reliable input that is significant to the fair value measurement.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurements - Definition and Hierarchy (Continued)

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Risks and Uncertainties

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Payment of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in accordance with GAAP requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and notes. Actual results could differ from these estimates.

Reclassifications

Management continuously reassesses plan investments to determine appropriate valuation. During 2024, the Plan reclassified certain investments previously presented as pooled separate accounts (measured at fair value, using net asset value as a practical expedient) to pooled separate accounts (measured at fair value, using Level 2 inputs) due to clarification of the inputs being more consistent with Level 2 inputs and to more accurately reflect the nature of these investments. There was, however, no change in the actual inputs utilized to value the pooled separate accounts. Reclassifications have been made in the prior year financial statements to conform to the current year presentation. There were no other changes in the valuation methodologies used during 2024 and 2023.

4. GUARANTEED INVESTMENT CONTRACTS

The Plan has guaranteed investment contracts (GICs) with Voya. The Plan's GICs are considered fully benefit responsive and are stated at contract value on the accompanying statements of net assets available for benefits. Voya maintains plan contributions in a separate account. The account is credited with earnings on the underlying investments and are charged for Plan withdrawals. Earnings on the underlying investments are guaranteed by Voya at a guaranteed minimum interest rate. The guaranteed minimum returns are supported by Voya's General Account portfolio. The assets and earnings from this portfolio are used to pay the guaranteed interest rate associated with the fully-benefit responsive fixed insurance contracts. Certain events may limit the ability of the Plan to transact at contract value. Examples of such events include the following: (1) amendments to plan documents, including complete or partial plan termination or merger with another plan, (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exception under ERISA. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable. There are no reserves against contract values for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a contractually guaranteed interest rate that may not be less than one percent.

5. TAX STATUS

The Plan utilizes a 403(b) volume submitter plan document. The Plan has relied on a favorable opinion letter from the Internal Revenue Service, dated March 31, 2017, as to the volume submitter plan's qualified status. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

6. PARTY-IN-INTEREST TRANSACTIONS

Voya and Newport are the custodians of the Plan's investment assets. The Company serves as the Plan Sponsor. Consequently, transactions between Voya, Newport, the Company, and the Plan qualify as party-in-interest transactions.
