**NOTE A - DESCRIPTION OF PLAN**

The following description of the Fond du Lac Regional Clinic, S.C. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering substantially all employees of Fond du Lac Regional Clinic, S.C. (the "Employer" or "Plan Sponsor") who have signed associate or shareholder employment contracts and have completed one year of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

***Contributions***

The Plan allows employees to make pre-tax contributions and/or Roth contributions of no less than 1% and no more than 75% of their annual compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Employer may make annual contributions to the Plan at the discretion of the board of directors. Such contributions for any year may not exceed 15% of the total eligible compensation of all participants for the year. These contributions are allocated to the accounts of the participants based upon compensation levels.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of the Employer's discretionary contributions, plan earnings, and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan.

The Plan allows participants to invest their account balances between or among separate investment funds within the trust. The Plan also allows for participants to segregate their account balances and individually direct their investments. Participant loans are not permitted.

***Vesting***

Contributions made by the participant, as well as the related income earned, are 100% vested. A participant is 20% vested in the Employer contributions after one full year of service, 60% vested after two full years of service and 100% vested after three full years of service.

***Investment Options***

Upon enrollment in the Plan, a participant may direct contributions in 1% increments in a variety of different investment options. Participants may change their investment options at any time.

***Payment of Benefits***

The benefit to which a plan participant is entitled is the benefit that can be provided by the contributions and income thereon (including net investment income and administrative expenses) allocated to such participant's account. Upon disability, death, termination or retirement, the participant or beneficiary will receive, at the sole discretion of the participant, either: (i) a lump sum equal to the vested value of the funds allocated to their account, (ii) equal periodic installment payments for a period of time as determined by the Plan agreement, (iii) an annuity or (iv) a rollover to another eligible plan.

***Forfeitures***

Forfeited non-vested accounts from employer contributions shall be used to pay Plan administrative expenses, allocated to eligible participants as a profit-sharing contribution, used to reduce Employer contributions under the Plan, used to restore previously forfeited amounts or used to correct errors, omissions and exclusions. During the Plan year ended December 31, 2024, no forfeitures were used. At December 31, 2024 and 2023, the outstanding balance of forfeited non-vested accounts was \$10,972 and \$10,652, respectively.

**NOTE B - SUMMARY OF ACCOUNTING POLICIES**

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows.

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attributable for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The statements of net assets available for benefits and statement of changes in net assets available for benefits are prepared on a contract-level basis.

Except for the New York Life ("NYL") Group Annuity Contract, the Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Administrative expenses are expensed when incurred and are paid by the Plan to the extent not paid by the Employer.

**December 31, 2024 and 2023**

The Plan provides that revenue sharing earned in connection with Plan investments that exceeds recordkeeping fees will be returned to the Plan on a quarterly basis and placed in an "EBA Account." The Plan allows for any excess in the EBA Account to be allocated to eligible participant accounts pro rata in proportion to their applicable account balances.

**NOTE C - INVESTMENTS**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that the changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan has entered into an insurance contract with NYL through contributions to the NYL Group Annuity Contract. See Note E.

**NOTE D - FAIR VALUE MEASUREMENTS**

There is a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Mutual Funds***

Valued at the net asset value (“NAV”) of shares held by the Plan at year end, by reference to quoted market data.

The Plan provides participants with various actively traded mutual fund investment options, as well as mixed fund options. The mixed funds are separately managed funds comprised of other mutual funds held by the Plan. The percentage allocation to each underlying mutual fund of each mixed fund varies. All of the underlying assets in the mixed funds are mutual funds which are stated at fair value based on quoted market prices reported by the trustee. The mixed funds are unitized for participant recordkeeping purposes, and quoted market prices of the underlying assets determine the NAV of the separately managed mixed funds.

***Brokerage Accounts***

Valued based on the underlying investments held in the account at year end. These accounts may include mutual funds, common stocks, money market funds and corporate bonds. Mutual funds and common stocks are valued at the closing price reported in the active market in which the securities are traded. The fair value of money market funds approximates the carrying value due to the short term nature of the investments. For corporate bonds, if quoted market prices are not available or accessible, then fair values are estimated using pricing models, matrix pricing or discounted cash flow models.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan has a fully-benefit responsive investment contract with NYL. NYL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements as reported to the Plan by NYL. Contract value represents contributions made by participants, plus interest at a specified rate determined semi-annually, less withdrawals or transfers by participants. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There is no redemption notice period, and the investment contract can be redeemed daily.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the contract issuer; however, no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the participants.

In addition, the issuer may terminate the contract with the Plan and settle at an amount different from contract value provided they give the Plan written notice 30 days prior to the intended termination date.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

**NOTE F - INCOME TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Employer by a letter dated September 21, 2011, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has adopted certain discretionary amendments. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified and the related trust is tax exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 or 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE G - TERMINATION OF PLAN**

Although the Employer has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, distribution of the Plan assets shall be made to the participants according to the provisions for such distribution in the Plan document.

**NOTE H - RELATED PARTY TRANSACTIONS**

The Employer pays certain administrative expenses not paid by the Plan.
