**NOTE 1 PLAN DESCRIPTION**

The following description of the Bismarck Motor Company 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

Bismarck Motor Company established the Plan effective May 1, 2019. The Plan is a defined contribution plan and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is administered by the sponsor, Bismarck Motor Company (the Company). Bravera Wealth (the Trustee) serves as the trustee of the Plan, maintains the records of the participant data, and holds the Plan assets.

**Eligibility**

Substantially all employees are eligible to participate in the Plan after three months of service and attainment of age 21. To receive discretionary matching contributions, an employee must complete six months of service, be 21 years of age and be contributing to the Plan. To receive discretionary profit-sharing contributions, an employee must complete one year of service (1,000 hours of service during the latest 12 month period), be 21 years of age and be employed on the last day of the plan year. Employees may enroll in the Plan immediately following completion of the age and service time requirement.

**Contributions**

Participants may contribute up to the maximum dollar amount allowed under federal regulations for the plan year. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Plan allows for a discretionary match. For the years ended December 31, 2024 and 2023, the Plan matched 100% of the participant's elective deferrals up to 4% of the participant's eligible compensation. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested into the Vanguard Target Date fund based on their date of birth. Discretionary profit-sharing contributions to the Plan are also allowed and are allocated to each employee in the ratio that the eligible compensation of the individual participant is to the eligible compensation of all eligible participants for the plan year. There were no discretionary profit-sharing contributions for the plan years ended December 31, 2024 and 2023.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and the employer contributions. Plan earnings are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan allows for participant-directed investment programs for which separate funds are maintained. The value of each participant's account is determined daily.

**Participants' Investment Options**

Participants must direct their salary deferrals and employer contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options throughout the year by contacting Bravera Wealth, the Trustee.

**Payment of Benefits**

Upon termination of employment, death, disability or retirement, the participant will receive a lump sum amount, installment distributions or ad-hoc distributions equal to the value of the participant's vested interest. Terminated participants with account balances of \$5,000 or less are required to take a lump sum distribution upon termination. Hardship distributions and in-service retirement distributions are also permitted for participants who have not separated from service. Participants must have attained normal retirement age (age 59 ½) or early retirement age (age 55) and 6 years of service to qualify for in-service retirement distributions. Generally, certain minimum distributions are required for participants who have separated from service and have reached required minimum distribution age.

**Vesting**

Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Vesting in the employer's contribution portion of their accounts plus actual earnings thereon is based on years of service with certain exceptions for death, disability and retirement. A participant is 100% vested after six years of credited service, which is defined as the completion of at least 1,000 hours of service during the plan year.

**Forfeitures**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6,215 and \$19,071 respectively. This account is used to reduce employer contributions or pay plan expenses. During the years ended December 31, 2024 and 2023, \$19,071 and \$12,294 of forfeitures were used to reduce employer contributions, respectively.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest equal to the average rate available for similar loans from commercial lending transactions when the loan was obtained. The term of the loan cannot exceed five years, unless it is for the purchase of a principle residence, which must be repaid within fifteen years. Principal and interest are paid ratably through payroll deductions.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

**Basis of Presentation**

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("U.S. GAAP"), as codified by the Financial Accounting Standards Board.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the financial statements and accompanying notes. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by Bravera Wealth. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held and transferred during the year and is reflected in the statement of changes in net assets available for benefits.

**Contributions**

Contributions from Plan participants and contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Payment of Benefits**

Benefit distributions are recorded when paid.

**Administrative Expenses**

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Participant loan accounts are assessed a separate fee for the administration of loans. Fees are paid by the participants of the Plan pro-rata based on participant investment balances. Certain administrative expenses that are paid by the Company are excluded from these financial statements.

**Income Taxes**

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

**NOTE 4 FAIR VALUE MEASUREMENT**

Financial Accounting Standards Board Statement ASC Topic 820 *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds (including money market mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund: A stable value fund that is composed of fully benefit-responsive investment contracts and is valued at the net asset value (NAV) of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily

delay withdrawal from the trust in order to ensure that securities liquidation will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 INCOME TAX STATUS**

The Plan adopted a non-standardized pre-approved plan sponsored by Bravera Wealth. The non-standardized pre-approved plan has received a favorable opinion letter dated June 30, 2020, from the Internal Revenue Service as to the plan's qualification status. This opinion letter has been relied upon by this Plan.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain tax position that more likely than not would be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**NOTE 6 EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Bravera Wealth serves as trustee of the Plan, maintains the records of the participant data, and holds the Plan's assets. For the years ended December 31, 2024 and 2023, the Plan paid fees to Bravera Wealth in the amount of \$55,658 and \$47,909, respectively.

**NOTE 7 RISKS AND UNCERTAINTIES**

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 8 AMENDMENT AND TERMINATION**

Although it has not expressed any intent to do so, the Company reserves the right at any time to amend or terminate the Plan subject to the provisions of the Plan and ERISA. If the Company terminates contributions or the Plan is terminated, all participants become fully vested.

**NOTE 9 SUBSEQUENT EVENTS**

No significant events occurred subsequent to the Plan's year end. Subsequent events have been evaluated through August 13, 2025, which is the date these financial statements were available to be issued.
