We have audited the financial statements of the Kaw Nation 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”), as of and for the year ended December 31, 2024, and we will issue our report thereon dated September 9, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by American Trust Company, the trustee, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated May 1, 2025. Professional standards also require that we communicate to you the following information related to our audit.

Significant Audit Matters

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note B to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements and are based on your knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was management’s estimate of the fair value of investments.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosures affecting the financial statements were:

- Note C – the disclosure of fair value measurements;
- Note D – the disclosure of information certified by the trustee.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. No significant misstatements were identified during the audit.

Disagreements with Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated September 9, 2025.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Other Matters

With respect to the ERISA-required supplemental schedules accompanying the financial statements, we made certain inquiries of management and evaluated the form, content, and methods of preparing the information to determine that the information complies with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the method of preparing it has not changed from the prior period, and the information is appropriate and complete in relation to our audit of the financial statements. We compared and reconciled the ERISA-required supplemental schedules to the underlying accounting records used to prepare the financial statements or to the financial statements themselves.

This information is intended solely for the use of the Plan Trustees and management of the Plan and is not intended to be and should not be used by anyone other than these specified parties.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTE A--DESCRIPTION OF THE PLAN

The following description of the Kaw Nation (the "Nation") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan was established on October 15, 2021 and is a defined contribution plan, which is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers all employees of the Nation who have three months of service and have reached the age of eighteen, as defined in the Plan agreement. Employees may enter the Plan on the first day of the following plan quarter coinciding with the date on which the employee satisfies the applicable eligibility requirements.

Contributions: Each participant may elect to contribute a percentage of their eligible compensation up to the lesser of the participant's eligible compensation or the maximum amount allowed by the Internal Revenue Service (IRS). The IRS' limit was \$23,000 for 2024. Plan participants age 50 and older were eligible to make catch-up contributions of an additional \$7,500 for 2024. The Plan also permits participants to make rollover contributions from other qualified plans.

The Nation may make discretionary matching contributions equal to a uniform percentage or dollar amount of participant elective deferrals. For the year ended December 31, 2024, the Nation matched participant elective deferrals up to 1%, totaling \$44,214.

Participant Accounts and Investment Options: Participants direct the investment of their contributions into various mutual funds offered by American Trust Company ("American Trust") which are registered under the Investment Company Act of 1940, as well as a selection of common collective trust funds and mutual funds that are managed by American Trust or a subsidiary of American Trust.

Each participant's account is credited with the participant's contribution, an allocation of the Nation's contribution (as applicable) and Plan earnings. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's accounts.

Vesting: Participants are immediately vested in their contributions, any elective matching contributions made by the Nation, and any earnings thereon. Nonelective contributions are vested at the following rate:

Less than 3 years of service	0%
More than 3 years of service	100%

NOTE A--DESCRIPTION OF THE PLAN--CONTINUED

Forfeitures Accounts: As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,700 and \$500, respectively. These accounts can be used to pay Plan expenses and/or reduce future employer contributions. Amounts forfeited plus earnings for the year ended December 31, 2024 totaled \$3,600. Forfeiture withdrawals used to reduce employer contributions were \$400 for the year ended December 31, 2024.

Payment of Benefits: Upon termination of employment for reasons other than death, disability, or retirement, the participant is entitled to receive a lump sum payment equal to his or her vested interest. If the participant's vested benefit in the Plan exceeds \$5,000, the participant must consent to the distribution before it can be made. Participants that have a vested benefit that does not exceed \$5,000 will receive a lump sum payment as soon as practicable following the event entitling the participant to a distribution. Certain early distributions made upon termination of employment may be subject to a penalty. At December 31, 2024, net assets available for benefits included approximately \$101,000 relating to former participants who have elected, for the present time, to leave their balances intact with the Plan.

Upon retirement at age 65, retirement due to disability or the death of the participant, the participant or participant's designated beneficiary is entitled to receive the participant's entire account balance.

Hardship withdrawals are permitted up to the amount of the participant's account balance attributable to their contributions and employer profit sharing contributions made to the Plan. Hardship withdrawals are only permitted for certain specific uses as defined in the Plan agreement.

Plan Termination: Although it has not expressed any intent to do so, the Nation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan have been prepared using the accrual method of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits: Benefits are recorded as expenses when paid.

NOTE B –SUMMARY OF SIGNIFICANT ACCOUNT POLICIES--CONTINUED

Administrative Expenses: Certain administrative functions of the Plan are performed by employees of the Nation. Neither the employees nor the Nation receive any compensation from the Plan for these services. The majority of administrative expenses of the Plan are paid by the Nation. Account transaction costs are deducted from participant accounts. Any administrative fees for services are paid from the assets of the funds and therefore reduce the overall return offered by the funds.

Income Tax Status: Effective October 15, 2021, the Plan adopted the AT Retirement Services Prototype Plan. The Prototype Plan obtained an opinion letter dated June 30, 2020 in which the IRS stated that the Prototype Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter, however, the Plan Administrator believes that the Plan is designed and is currently operating in compliance with the applicable requirements of the IRC.

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 740, *Income Taxes*, provides detailed guidance for the financial statement recognition, measurement, and disclosure of uncertain tax positions recognized in an entity's financial statements and requires an entity to recognize the financial statement impact of a tax position when it is more likely than not that the position will be sustained upon examination. The Plan Administrator believes that all significant tax positions utilized by the Plan will more likely than not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits for any tax periods in progress.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Subsequent Events: Subsequent events have been evaluated through September 9, 2025, which is the date the financial statements were available to be issued. There were no subsequent events requiring recognition or disclosure.

NOTE C--FAIR VALUE MEASUREMENTS

FASB ASC 820-10-35-39 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10-35-39 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs consist of unobservable inputs which are used when observable inputs are unavailable and reflect an entity's own assumptions about the assumptions that market participants would use in pricing the assets or liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds: Collective trust funds have the characteristics of a structure similar to a mutual fund and are valued based on the readily determinable quoted market price that each fund publishes at the end of each day. While the underlying assets are actively traded on an exchange, the collective trust funds are not and, therefore, are classified as Level 2 assets in the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D--INFORMATION CERTIFIED BY THE TRUSTEE

The Plan's independent auditors did not perform audit procedures with respect to this information, except for comparing such information per American Trust Company's certified statements to the related information included in the financial statements and supplementary schedule.

NOTE E--INVESTMENT CONCENTRATION, RISKS AND UNCERTAINTIES

In general, the investments provided by the Plan are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE F--TRANSACTIONS WITH EXEMPT PARTIES-IN-INTEREST

Certain Plan investments are managed by American Trust Company or its subsidiaries, which also serves as the Plan's trustee and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.
