NOTE A - DESCRIPTION OF THE PLAN

The following description of the Akrion Technologies, Inc. (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan for all eligible employees of the Company, as defined in the Plan document. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants could elect to defer any amount of their salary up to the maximum contribution allowed by law, which is \$23,000 in 2024. Certain eligible employees are allowed to make additional catch-up elective deferrals of up to \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Company made a discretionary matching contribution as determined by the Company, which was 50% of each participant’s contribution, up to a maximum of 2% of participant’s compensation.

Additional profit-sharing amounts may be contributed at the discretion of the Company. There were no Company discretionary profit-sharing contributions for the year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contribution and Plan earnings (losses). The investment of each participant’s account is directed by the individual participant.

Vesting

According to the Plan document, as amended, participants are immediately 100% vested in their own contributions plus actual earnings (losses) thereon. Participants become vested in Company contributions over a four-year period.

Vesting in the Company’s matching and profit-sharing contribution is determined as follows:

Payment of Benefits

On termination due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a period of not more than the participant's assumed life expectancy. However, if the participant's vested benefit does not exceed \$5,000, it will be distributed as a lump-sum as soon as practicable. In addition, in-service distributions may be made to a participant who has not separated from service from the Company and has attained age 59 1/2.

Forfeitures

Employees who terminate their employment and are not fully vested will forfeit the nonvested portion of their account balance to the Plan. The balance of the unallocated forfeiture balance at December 31, 2024 and 2023 was \$9,025 and \$6,071, respectively. Forfeitures will be applied to reduce employer contributions or pay plan expenses. Forfeitures of \$11,280 were used towards plan expenses and \$5,433 were used to reduce employer match contributions in 2024.

Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate established by determining the rate a commercial lender would charge for a similar loan. The interest rate on outstanding loans at December 31, 2024, ranged from 4.25% to 10.50%. Loans must be repaid by the participant within five years unless the loan is used to acquire a participant's primary residence. Loans used to acquire a primary residence may exceed five years. Principal and interest are paid ratably through payroll deductions.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all amounts credited to participant accounts will become 100% vested.

Plan Amendments

On December 29, 2022, the "Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act" was signed into law in the United States. The Secure 2.0 Act is an expansion of the Secure Act passed during 2019. The Act includes several mandatory and optional provisions that will become effective across several years. The Secure 2.0 Act aims to expand retirement access, increase retirement savings, and simplify plan administration. Plans may choose to operationally implement the provisions of the Secure 2.0 Act, however plan administrators have until December 31, 2026 to officially amend the plan document to reflect the provisions adopted by the plan.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Consequently, Company matching contributions and any discretionary profit-sharing contributions are recorded when received and are not accrued. Accordingly, the accompanying financial statements are not intended to present net assets available for benefits and changes in net assets available for benefits in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except for its investment contracts which are valued at contract value. Purchases and sales of investments are recorded on a trade-date basis and are recorded net of fees. Dividends are recorded when received.

Investment contracts held by a defined contribution plan that are fully benefit-responsive are reported at contract value, rather than fair value, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investments in the Voya Fixed Account and Voya Fixed Account A are fully benefit-responsive investment contracts and are reported at contract value in the statement of net assets available for benefits.

Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Participant accounts are charged with an allocation of certain administrative expenses, such as recordkeeping fees, that are paid by the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Date of Management's Review

Management has evaluated subsequent events through September 16, 2025, the date which the financial statements were available to be issued.

NOTE C - INFORMATION CERTIFIED BY THE CUSTODIAN

The administrator of the Plan chose the method of compliance permitted by Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Act of 1974. Under that section, no auditing procedures are required to be performed with respect to the investment information certified by Voya Retirement Insurance and Annuity Company, the custodian of the Plan, other than comparing such information to that contained in the financial statements and schedule.

NOTE D - FAIR VALUE MEASUREMENTS

Professional accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three broad levels.

Level 1 inputs are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. *Level 2* inputs are other than quoted prices that are observable for the asset or liability, either directly or indirectly through market corroboration, for substantially the full term of the financial instrument. *Level 3* inputs are unobservable inputs based on the Plan's assumptions used to measure assets and liabilities at fair value. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Pooled separate accounts are managed by a registered investment company and are priced daily. These are valued at the net asset value based on the value of the underlying assets. The net asset value is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchased and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instrument could result in a different fair value measurement at the reporting date.

The value shown above reflects the approximate amount that would have been paid if the contract had been terminated as of the last day of the reporting period and potential surrender charges and market value adjustments were applied as of such date. The Voya Fixed Accounts guarantee minimum rates of interest and may credit interest that exceeds the guaranteed minimum rates. Daily credited interest becomes part of principal and the investment increases through compound interest. The Voya Fixed Accounts are intended to be a long-term investment for participants seeking stability of principal, therefore Voya Retirement Insurance and Annuity Company ("VRIAC") may impose restrictions on the ability to move funds into or out of this investment option or among investment options in general. These restrictions help VRIAC to provide stable credited interest rates which historically have not varied significantly from month to month despite the general market's volatility in new money interest rates. The Voya Fixed Account guarantees principal and guaranteed minimum interest rate for the life of the contract, as well as featuring two declared interest rates: a current rate, determined at least monthly, and a guaranteed minimum floor rate declared for a defined period - currently one calendar year.

NOTE F - TAX STATUS

The Plan is a proto-type non-standardized profit-sharing plan with CODA sponsored by CCH Incorporated. The proto-type plan has received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, indicating that the Plan is a qualified plan under Section 401(k) of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan believe it has appropriate support for any tax positions taken, and as such, does not have any uncertain tax positions that are material to the financial statements.

NOTE G - PARTY-IN-INTEREST TRANSACTIONS

NOTE H - RISKS AND UNCERTAINTIES

Investments of the Plan are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect investment assets reported in participant account balances and in the statements of net assets available for benefits--modified cash basis.

NOTE I - SUBSEQUENT EVENTS

Effective as of 1/1/2025 the Adoption agreement has been amended to change the definition of statutory compensation, changed the service requirement for plan participation, implemented automatic enrollment for new participants and automatic enrollment deferral increase.
