### **Notes to Financial Statements**

#### **NOTE A – DESCRIPTION OF PLAN**

The following description of the Sciolex Corporation (“Company”) 401(k) & Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General.** The Plan is a defined contribution plan covering all full-time and part-time and intermittent employees of the Company who are age eighteen or older. The Plan does not cover the employment category of “interns.” It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Administration of Plan Assets.** The Plan is administered under a service agreement with Great West Financial Services (the Trustee).

**Contributions.** During the year, the Company contributes to the Plan 100% of the participant’s elected deferral up to 5% of the participant’s eligible salary. Additional amounts may be contributed at the option of the Company’s board of directors. Participants may contribute up to \$23,000 (\$30,500 with catch-up contribution) of their annual compensation. Participants who have attained age 50 before end of the Plan are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Additional profit-sharing amounts may be contributed at the option of the Company’s board of directors. Contributions are subject to certain statutory limitations.

**Participant Accounts.** Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting.** Participants are immediately vested in their voluntary contributions and the Company contributions portion of their accounts plus actual earnings thereon.

**Notes receivable from participant.** Participants may borrow from their accounts up to \$50,000 or one-half the present value of the participants’ vested interest in their accounts. Loan transactions are treated as transfers between the investment funds and the participant loan fund. The loans are collateralized by the balance in the participant’s account and bear a reasonable rate of interest as determined by the Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years or up to 10 years for loan related to the purchase of a Participant’s primary resident.

## **Sciolex Corporation 401(k) & Profit Sharing Plan Notes to Financial Statements**

### **NOTE A – DESCRIPTION OF PLAN (Continued)**

***Payment of Benefits.*** On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or in annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

***Plan Termination.*** Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

### **NOTE B – SUMMARY OF ACCOUNTING POLICIES**

***Basis of Accounting.*** The financial statements of the Plan are prepared under the accrual method of accounting.

***Use of Estimates.*** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Risks and Uncertainties.*** The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

***Investment Valuation and Income Recognition.*** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's committee determines the Plan's valuation policies utilizing the information provided by the investment advisors and custodians. See Note F for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## **Sciorex Corporation 401(k) & Profit Sharing Plan Notes to Financial Statements**

### **NOTE B – SUMMARY OF ACCOUNTING POLICIES (Continued)**

*Administrative Expenses.* Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. During the years ended December 31, 2024 and 2023, fees totaling \$16,442 and \$17,196 were paid from the participant's account who incurred the fees, respectively. Investment related expenses are included in net appreciation of fair value of investment. During the years ended December 31, 2024 and 2023, fees totaling \$132,810 and \$173,641 were paid for investment related expenses, respectively.

*Payment of Benefits.* Benefits are recorded when paid.

*Notes Receivable from Participants.* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

*Excess Contribution Payable.* Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributes the excess contributions to the applicable participants prior to March 15 of the following year.

### **NOTE C – TAX STATUS**

The IRS has determined and informed the Company by a letter dated March 31, 2014 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audit for any tax period in progress.

#### **NOTE D – CERTIFICATION**

The Company has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, the Trustee, has certified that the following items in the accompanying financial statements are completed and accurate: investment balances at December 31, 2024 and 2023, interest and dividends and net appreciation in fair value of mutual funds for the year ended December 31, 2024 and all related financial information provided in the notes and supplemental schedule.

#### **NOTE E – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTION**

Certain Plan investments are shares of mutual funds managed by Empower Trust Company. Empower Trust Company is the trustee, as defined by the Plan, therefore, these transactions qualify as party-in-interests transactions. Fees paid by the Plan for the investment management services amounted to \$149,252 and \$190,837 for the years ended December 31, 2024 and 2023, respectively.

#### **NOTE F – FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 and Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 input for the periods presented.

##### *Level 1 Fair Value Measurements*

The fair value of mutual funds is based on quoted net assets values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net assets value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.
