The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Flying Food Fare, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note 1. Description of the Plan

The following description of Flying Food Fare, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Flying Food Fare, Inc. (Company), except for union employees, who have completed six consecutive months of service and have attained 18 years of age as defined in the plan document. Effective January 1, 2024, the Plan covers employees, except for union employees, who attained 18 years of age and have completed sixty consecutive days of employment for salaried employees and six consecutive months of employment for hourly employees, as defined in the plan document. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation.

Contributions

Participants may contribute a portion of their annual compensation, as defined in the plan document and up to the amount allowable under current income tax regulations. Contributions to the Plan can be classified as pre-tax or Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Prior to January 1, 2024, eligible employees were automatically enrolled into the Plan at a contribution rate of 4% of pre-tax compensation unless they elected otherwise. Effective January 1, 2024, eligible employees are automatically enrolled into the Plan at a contribution rate of 5% of pre-tax compensation unless they elect otherwise. Effective November 1, 2021, eligible participant's (deferring less than 10% of plan compensation) contributions are automatically increased by 1% of compensation up to a maximum of 10% of compensation on an annual basis. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Discretionary matching contributions may be made on behalf of all eligible participants who made salary deferral contributions to the Plan during the year. However, any salary deferrals that are catch-up contributions will not be matched. The Company may also make an additional discretionary profit-sharing contribution to the Plan. Participants who are employed on the last day of the plan year or have completed 500 service hours during the year are eligible to receive a share of the discretionary profit-sharing contribution.

For the year ended December 31, 2024, the Company elected to make discretionary matching contributions to the Plan in an amount equal to 50% of employee salary deferral contributions up to 4% of eligible compensation. There were no additional discretionary profit-sharing contributions made in 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of applicable administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

The Plan provides that each participant direct the investment of his or her account in any combination into a number of investment funds. The Plan currently offers various registered investment companies and a group annuity contract as investment options for participants.

Vesting

Participants are immediately vested in employee salary and rollover contributions plus actual earnings thereon. Vesting in the Company's discretionary employer match contribution is based on years of continuous service. A participant becomes 20% vested after two years of service and an additional 20% of each year of continuous service thereafter. A participant is 100% vested in these contributions after six years of credited service. Participants become 100% vested in any discretionary profit-sharing contributions after one year of service.

As defined in the plan document, a participant becomes 100% vested in either of the Company's employer contributions through attaining their normal retirement date, permanent disability, or death.

Notes Receivable From Participants

Effective January 1, 2017, the Plan does not allow for new participant loans. All outstanding participant notes receivable continue to be repaid through payroll deductions according to the terms of the respective agreements. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate, as determined by the Plan (4.50% at December 31, 2024).

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities.

The Plan's provisions also provide for hardship and in-service withdrawals if certain criteria are met.

Forfeited Accounts

If a participant is not fully vested on their termination date, the nonvested portion of their account is forfeited. Forfeitures are used to reduce future Company contributions or pay Plan expenses. At December 31, 2024 and 2023, forfeited account balances totaled \$90,710 and \$30,310, respectively. For the year ended December 31, 2024, \$2,657 of forfeitures were used to reduce discretionary employer-matching contributions and qualified nonelective contributions and \$155,203 were used toward Plan expenses.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments, other than fully benefit-responsive investment contracts, are reported at fair value as further described in Note 3.

The Standard Stable Asset 2 Fund is a fully benefit-responsive group annuity contract and is valued at contract value as further described in Note 4.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses may be paid by the Company, plan or the participants, or paid through a revenue sharing arrangement, as defined in the plan service agreement.

Note 3. Fair Value Measurements

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted market prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4. Investment Contract With Insurance Companies

The Plan has entered into a fully benefit-responsive group annuity contract with the Standard Insurance Company (issuer). The issuer maintains the contributions in its general account. The general account is credited with a specified rate of interest and charged for participant withdrawals and administrative expenses. The issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan.

As described in Note 2, because this contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. Contract value, as reported to the Plan by the issuer, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There is no reserve against contract value for credit risk of the investment issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (3) the failure of the Plan to qualify for exemption of federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The contract value of the Standard Stable Asset 2 Fund at December 31, 2024 and 2023, is \$6,892,414 and \$6,620,970, respectively.

Note 5. Information Certified by the Plan's Custodian

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Noninterest-bearing cash, investments, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income components and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 6. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan currently invests in registered investment companies managed by Matrix Trust Company (Matrix). Matrix is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Certain investment related expenses are included in net appreciation of fair value of investments.

The Plan paid administrative expenses, prior to the effect of revenue sharing, in the amount of \$318,258 during 2024. The Company provides certain administrative services at no cost to the Plan.

Matrix receives revenue from certain mutual funds that is reallocated to participant's accounts on a monthly basis. During 2024, revenue credits totaled \$1,513 and have been offset against administrative expenses on the statement of changes in net assets available for benefits. There were no unused credits as of December 31, 2024.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the employer contribution portions of their accounts.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Tax Status

The Plan operates under an adoption agreement in connection with a non-standardized pre-approved profit-sharing plan sponsored by OneAmerica Financial Partners Inc. This non-standardized pre-approved profit-sharing plan has been filed with the appropriate agency and the plan sponsor has obtained an opinion letter dated August 19, 2020, from the Internal Revenue Service (IRS) stating that the non-standardized pre-approved profit-sharing plan constitutes a qualified plan under Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 11. Subsequent Events

Effective January 1, 2025, Voya Financial (Voya) acquired the OneAmerica Financial, Inc. full-service retirement plan business. As part of that transaction, Voya purchased OneAmerica Retirement Services LLC, recordkeeper of the Plan, and OneAmerica Investment Advisory Services. Administrative and recordkeeping services will be provided by Voya Retirement Insurance and Annuity Company or Voya Institutional Plan Services, LLC.

Subsequent events have been evaluated through September 16, 2025, which is the date the financial statements were available to be issued.
