### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of von Briesen & Roper, s.c. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### **1. Description of the Plan**

The following description of the von Briesen & Roper, s.c. 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for more complete information.

#### ***General***

The Plan is a defined contribution plan established by the von Briesen & Roper, s.c (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. All employees who have completed at least one hour of service with the Company, as defined in the Plan, and are age 21 or older are eligible to participate in the Plan as of the first day of the calendar quarter (January 1, April 1, July 1, or October 1) following the date the age and service requirements are satisfied to begin making deferral contributions. Upon enrollment in the Plan, a participant may direct employee contributions to any combination of available investment options. Participants become eligible for the Plan's base contributions (i.e., employer contributions) on the first day of the calendar quarter after they have obtained the age of 21 and completed one year of service. The amount of the base contribution, if any, for a Plan year shall equal the amount determined by the Company.

#### ***Trustee and Administration of the Plan***

State Street Bank and Trust Company serves as the trustee of the Plan and holds all Plan assets in accordance with the service provider contract with the Company. Transamerica Retirement Solutions, LLC acts as the recordkeeper, maintaining participant account records and processing Plan transactions. The Company is the administrator of the Plan and is responsible for its overall management and compliance. The Investment Committee, appointed by the Company, is responsible for determining the appropriateness of the Plan's investment offerings and for monitoring the performance of those investments.

#### ***Contributions***

Each year, participants may contribute up to 75% of their annual compensation, as defined in the Plan Agreement. The Plan allows for two types of contributions (pre-tax or Roth salary reduction contributions). The Plan also provides for automatic enrollment of new participants at 4%, with an annual increase of 1%, until they reach a maximum deferral rate of 10%, unless the participant opts out. An elective contribution is made to the Plan by the participant and cannot exceed the lesser of the limit imposed by the Internal Revenue Code (IRC) Section 401(g) or the amount specified by the Company. A base contribution is a discretionary amount contributed to the Plan, as determined by the Company.

For 2024, discretionary contributions were allocated to participants based on 5.0% of an eligible participant's compensation up to 80.1% of the taxable wage base under the Federal Social Security Act plus 14.91% of an eligible participant's compensation in excess of 80.1% of that taxable wage base, subject to IRC limitations.

Any participant who is eligible to make elective contributions and who has attained age 50 before the end of the year, may elect to make catch-up contributions in accordance with and subject to certain limitations.

The Plan also accepts rollover contributions (i.e., amounts which can be rolled over into a tax qualified plan from another employer's qualified plan), as defined in the Plan Agreement.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts. Participants may direct the investment of their account balances into various investment options offered by the Plan. Participants may change their investment options at any time.

### ***Vesting***

Participants are immediately vested in their elective and rollover contributions, plus earnings thereon. Participants who leave the Plan because of death, early or normal retirement, or disability retirement, as defined in the Plan, are considered 100% vested. Employer contributions and earnings thereon vest in accordance with provisions of the Plan as follows:

Participants earn one year of service for each plan year they are employed with 1,000 hours of service completed.

### ***Forfeited Accounts***

As of December 31, 2024, and 2023, forfeited non-vested accounts totaled \$568,640 and \$56,367, respectively. Forfeitures can be used to pay administrative expenses and, to the extent any remain, the Plan allocates participant forfeitures as if the forfeitures were Company base contributions. During the year ended December 31, 2024, forfeitures of \$4,242 and \$47,945 were allocated to reduce Plan expenses and employer contributions, respectively.

### ***Payment of Benefits***

Benefits may be paid to the participant or beneficiary upon death, disability, retirement, age 70½, or termination of employment, as defined in the Plan Agreement. The Plan provides for normal retirement at age 65. The form of payment is joint and survivor annuity if married. If not married, the form of payment is a life annuity to be paid out in monthly payments, unless the participant elects to have his or her benefits paid as a single lump sum, direct rollover or equal monthly, quarterly, semi-annual, or annual installments. Participants experiencing financial hardship may withdraw a portion of their account balance as defined in the Plan Agreement. Participant accounts are charged for an administrative expense per termination, hardship, in-service or installment distribution.

Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$1,000 or less. For terminated participants with vested balances greater than \$1,000, but less than \$5,000, their vested balance may be automatically rolled into an IRA unless otherwise elected.

#### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The \$50,000 limit is reduced by the highest outstanding loan balance during the one-year period before the new loan is made. Loans are repayable in installments over a period of up to five years, with the exception of the purchase of a primary residence. Loans are secured by the balance in the participant's account and carry a fixed, commercially reasonable rate of interest, which ranged from 3.25% to 10.50% at December 31, 2024. Participant loan administrative fees are payable by the participant. Principal and interest is paid ratably through payroll deductions. Also, each participant may not have more than two loans outstanding at any time.

#### ***Contributions Receivable***

Participant contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective/Profit sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

#### ***Termination of Plan***

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## **2. Summary of Accounting Policies**

#### ***Basis of Accounting***

The financial statements of the Plan have been prepared on the accrual basis of accounting, except for benefit payments which are recorded upon distribution.

#### ***Use of Estimates***

The preparation of the financial statements, in conformity with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to net assets and deductions from net assets during the reporting period. Actual results could differ from these estimates.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Brokerage fees are added to the acquisition costs of assets purchased and subtracted from the proceeds of assets sold.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. According to the Plan, a note receivable from participant is collectible upon termination and any portion of the note receivable from participant that is not collected is deemed to have defaulted. Defaulted loans are deemed distributed and recorded as benefits paid to participants in the accompanying statement of changes in net assets available for benefits.

#### ***Payment of Benefits***

Benefits are recorded upon distribution to participants.

#### ***Administrative Expenses***

Expenses incurred in the administration of the Plan shall be paid from the Plan; however, the Company may elect to pay expenses directly. In addition, the Company may, on a uniform basis, charge certain reasonable Plan administrative expenses to the accounts of participants who utilize the service(s) attributable to the expense. Participant accounts are charged for any expenses attributable to the investments in their account within the Plan.

### **3. Investment Information Certified by the Plan's Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, State Street Bank And Trust Company, the Plan's trustee and a qualified institution has certified that the following data included in the accompanying financial statements and ERISA required supplemental schedule is complete and accurate:

- Investments, accrued income, and notes receivable from participants as shown in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Total investment income and interest income on notes receivable from participants as shown in the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Investment information included in Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown in the ERISA-Required supplemental schedule.

At the request of the Plan Administrator, the Plan's independent accountants did not perform auditing procedures on the above information, except for comparing such information included in the accompanying financial statements and ERISA required supplemental schedule.

### 4. Fair Value Measurements

U.S. GAAP established a framework for measuring fair value. The framework provides for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurements*, are described as follows:

*Level 1* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

*Level 2* Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liabilities; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### ***Mutual Funds***

Mutual funds represent investments with various investment managers. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

#### ***Common Collective Trust Funds***

Common collective trust funds are valued at the last reported price when the fair value per share (unit) is determined and published and is the basis for current transactions. If no published price exists, the common collective trust funds are valued at the NAV as a practical expedient to estimate fair value.

The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

### 5. Party-in-Interest and Related Party Transactions

Transactions resulting in plan assets being transferred to or used by a related party are prohibited under ERISA unless a specific exemption applies. The Plan is administered by the Company. Certain administrative functions are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan.

Notes receivable from participants also qualify as exempt party-in interest transactions.

### 6. Tax Status

The Plan obtained its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan and related trust, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. The Plan Administrator believes that the Plan, as amended, is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified, and the related trust was tax-exempt at the financial statement date. No provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Refund of Excess Contributions

In order to ensure favorable tax treatment of participant accounts, the Plan may not exceed certain maximums for employee elective contributions and employer matching contributions of highly compensated employees as defined in the IRC. The Plan is required to take appropriate actions if IRC requirements are not met. For the year ended December 31, 2024, the plan was considered "top-heavy" and corrective actions have been made in 2025.
