22) The Plan has satisfactory title to all owned assets, which are recorded at fair value, [and all liens, encumbrances, or security interests requiring disclosure in the financial statements have been properly disclosed.

23) We have no—

- a) Plans or intentions that may materially affect the carrying value or classification of assets and liabilities.
- b) Intentions to terminate the Plan.

24) Amendments to the Plan instrument, if any, have been properly recorded or disclosed in the financial statements.

25) The methods and significant assumptions used to estimate fair values of financial instruments, including non-readily marketable securities, are as follows:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trusts and pooled separate accounts: Stated at fair value as determined by the issuer of the collective investment trusts based on the fair market value of the underlying investments, which is valued at the NAV. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

26) All required amendments to and filings of plan documents with the appropriate agencies have been made.

27) The Plan (and the trust established under the Plan) is qualified under the appropriate section of the Internal Revenue Code and we intend to continue them as a qualified plan (and trust). The Plan sponsor(s) has operated the Plan (and trust) in a manner that did not jeopardize this tax status. Required nondiscrimination testing related to Code Section 401(k) and 401(m) arrangements, as applicable, has been completed for the Plan, and any excess deferrals or contributions have been disposed of in accordance with regulations.

28) The Plan has complied with the DOL's regulations concerning the timely remittance of participant contributions to trusts containing assets for the Plan.

29) The Plan has complied with the fidelity bonding requirements of ERISA.

30) We have apprised you of all communications, whether written or oral, with regulatory agencies concerning the operation of the Plan.

31) We have obtained appropriate fee disclosures from covered service providers and have concluded the fees are reasonable. The Plan is in compliance with DOL regulations regarding ERISA Section 408(b)(2).

32) We acknowledge our responsibility for presenting the Schedule of Assets Held at End of Year, in accordance with U.S. GAAP and in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA and we believe the Schedule of Assets Held at End of Year, including its form and content, is fairly presented in accordance with U.S. GAAP and in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The methods of measurement and presentation of the supplemental schedule has not changed from those used in the prior period, and we have disclosed to you any significant assumptions or interpretations underlying the measurement and presentation of the supplemental schedule.

33) In regard to the financial statement preparation services performed by you, we have—

- 1) Assumed all management responsibilities.
- 2) Designated a Plan Administrator who has (have) suitable skill, knowledge, or experience to oversee the services.
- 3) Evaluated the adequacy and results of the services performed.
- 4) Accepted responsibility for the results of the services.
- 5) Ensured that the data and records are complete and we have sufficient information to oversee the services.

34) We acknowledge our election to have an ERISA Section 103(a)(3)(C) audit does not affect our responsibility for the financial statements and for determining the following:

- 1) The circumstances permit an ERISA Section 103(a)(3)(C) audit.
- 2) A qualified institution has prepared and certified the investment information as described in 29 CFR 2520.103-8.
- 3) The certification meets the 29 CFR 2520.103-5 requirements.

4) The certified investment information is appropriately measured, presented, and disclosed in accordance with U.S. GAAP.

35) We have obtained the SOC 1 report from our service organizations Principal Life Insurance Company, ADP, Inc. and Paylocity Corporation. We have reviewed such reports, including the complementary user controls. We have implemented the relevant user controls, and they were in operation for the year ended December 31, 2024.
