#### **A. Description of Plan**

The following description of the Xencor, Inc. ("Company") 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution 401(k) plan covering all employees of the Company who are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Administration Committee oversees governance of the Plan. The Plan's 401(k) Planning Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Administration Committee.

##### **Contributions**

Each year, participants may contribute up to the maximum amount allowed, subject to limitations set forth by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions (rollovers) from other qualified plans. The Plan allows the Company to make discretionary matching contributions. During 2024, the Company elected to make contributions based on 100% of first 2% and 50% of next 5% of an employee deferral (matching up to 4.5% of an employee's eligible compensation). Maximum eligible compensation for the Company's discretionary matching contribution in 2024 is \$200,000 (maximum Company discretionary match for an employee in 2024 is \$9,000). Participants may contribute up to 92% of their gross pay (bonuses may be included) subject to limitations set forth by the Internal Revenue Service ("IRS"). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants.

##### **Participant accounts**

Each participant's account is credited with the participant's contributions and Company discretionary matching contributions, as well as allocations of the Plan earnings. The participant is responsible for directing the investments of all assets in his or her individual account. Participants may change their investment options daily. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**A. Description of Plan, continued**

**Vesting**

Participants are immediately vested in their contributions plus actual earnings or losses thereon. Vesting in the employer contribution portion of their accounts is based on years of credited service, as defined in the Plan's provisions. Participants are 100% vested after three years of credited service.

**Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms are generally from 1-5 years, or up to 10 years for the purchase of a primary residence. All loans shall bear a reasonable rate of interest as determined by the Plan Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The interest rate shall remain fixed throughout the duration of the loan. The loans are secured by the balance in the participant's account. Principal and interest is paid ratably through semi-monthly payroll deductions. Loans are reported at their unpaid principal balances.

**Payment of benefits**

On termination of service, participants with a vested interest in the Plan of more than \$5,000 may elect to receive a lump-sum or installment payments equal to the vested value of their account or to defer distribution until retirement, as defined in the Plan's provisions. Employees choosing to defer their distribution continue to participate in investment gains and losses but are no longer eligible for matching contributions by the Company. Terminated employees with a vested account value in the Plan of \$5,000 or less may receive benefits only in a lump-sum distribution.

**Forfeitures**

At December 31, 2024 and 2023, forfeited nonvested accounts were \$118,241 and \$90. These amounts may be used to reduce future employer contributions or may be used to pay any administrative expenses of the Plan. For the year ended December 31, 2024, \$153,752 of employer contributions were reduced by forfeited nonvested accounts.

**B. Summary of significant accounting policies**

**Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note C for discussion of fair value measurements.

**Payment of benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to administration are charged directly to the participant's account and are included in administrative expenses. Starting March 1, 2023, the Company pays for all administrative fees. Investment-related expenses are included in net appreciation of fair value of investments. The plan has a revenue credit arrangement through ownership of investment products managed by the third-party administrator. For the year ended December 31, 2024, total net expenses were a credit of \$9,947, of which \$41,878 were credited and netted in administrative expenses.

**Date of Management's Review of Subsequent Events**

The Plan has evaluated subsequent events through September 17, 2025, which is the date the financial statements were available to be issued.

#### **C. Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

##### Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

##### Level 2 Fair Value Measurements

Inputs other than quoted prices for identical assets that are observable for the asset or liability, either directly or indirectly.

##### Level 3 Fair Value Measurements

Unobservable inputs for the asset or liability.

#### **H. Tax status**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

#### **I. Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **A. Description of Plan**

The following description of the Xencor, Inc. ("Company") 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution 401(k) plan covering all employees of the Company who are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Administration Committee oversees governance of the Plan. The Plan's 401(k) Planning Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Administration Committee.

##### **Contributions**

Each year, participants may contribute up to the maximum amount allowed, subject to limitations set forth by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions (rollovers) from other qualified plans. The Plan allows the Company to make discretionary matching contributions. During 2024, the Company elected to make contributions based on 100% of first 2% and 50% of next 5% of an employee deferral (matching up to 4.5% of an employee's eligible compensation). Maximum eligible compensation for the Company's discretionary matching contribution in 2024 is \$200,000 (maximum Company discretionary match for an employee in 2024 is \$9,000). Participants may contribute up to 92% of their gross pay (bonuses may be included) subject to limitations set forth by the Internal Revenue Service ("IRS"). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants.

##### **Participant accounts**

Each participant's account is credited with the participant's contributions and Company discretionary matching contributions, as well as allocations of the Plan earnings. The participant is responsible for directing the investments of all assets in his or her individual account. Participants may change their investment options daily. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**A. Description of Plan, continued**

**Vesting**

Participants are immediately vested in their contributions plus actual earnings or losses thereon. Vesting in the employer contribution portion of their accounts is based on years of credited service, as defined in the Plan's provisions. Participants are 100% vested after three years of credited service.

**Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms are generally from 1-5 years, or up to 10 years for the purchase of a primary residence. All loans shall bear a reasonable rate of interest as determined by the Plan Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The interest rate shall remain fixed throughout the duration of the loan. The loans are secured by the balance in the participant's account. Principal and interest is paid ratably through semi-monthly payroll deductions. Loans are reported at their unpaid principal balances.

**Payment of benefits**

On termination of service, participants with a vested interest in the Plan of more than \$5,000 may elect to receive a lump-sum or installment payments equal to the vested value of their account or to defer distribution until retirement, as defined in the Plan's provisions. Employees choosing to defer their distribution continue to participate in investment gains and losses but are no longer eligible for matching contributions by the Company. Terminated employees with a vested account value in the Plan of \$5,000 or less may receive benefits only in a lump-sum distribution.

**Forfeitures**

At December 31, 2024 and 2023, forfeited nonvested accounts were \$118,241 and \$90. These amounts may be used to reduce future employer contributions or may be used to pay any administrative expenses of the Plan. For the year ended December 31, 2024, \$153,752 of employer contributions were reduced by forfeited nonvested accounts.

**B. Summary of significant accounting policies**

**Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note C for discussion of fair value measurements.

**Payment of benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to administration are charged directly to the participant's account and are included in administrative expenses. Starting March 1, 2023, the Company pays for all administrative fees. Investment-related expenses are included in net appreciation of fair value of investments. The plan has a revenue credit arrangement through ownership of investment products managed by the third-party administrator. For the year ended December 31, 2024, total net expenses were a credit of \$9,947, of which \$41,878 were credited and netted in administrative expenses.

**Date of Management's Review of Subsequent Events**

The Plan has evaluated subsequent events through September 17, 2025, which is the date the financial statements were available to be issued.

#### **C. Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

##### Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

##### Level 2 Fair Value Measurements

Inputs other than quoted prices for identical assets that are observable for the asset or liability, either directly or indirectly.

##### Level 3 Fair Value Measurements

Unobservable inputs for the asset or liability.

**H. Tax status**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**I. Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
