INDEPENDENT AUDITORS' REPORT

To the Urban One, Inc. Employee Retirement Plan
and its Participants:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Urban One, Inc. Employee Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Urban One, Inc. Employee Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Urban One, Inc. Employee Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Urban One, Inc. Employee Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

and its Participants:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Urban One, Inc. Employee Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 1. DESCRIPTION OF THE PLAN

The following description of the Urban One, Inc. Employee Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Urban One, Inc. (the Company) effective January 1, 1992. The Plan covers substantially all employees of the Company, as defined by the Plan. Eligible employees may enter the Plan on the first day of the month following the attainment of age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was most recently amended effective September 28, 2023 to add Community Connect, Inc. and Cox Media as participating companies in the Plan.

The Plan includes the following participating companies: Radio One of Texas II, LLC, Radio One of Boston, Inc., Charlotte Broadcasting, LTD., Bell Broadcasting Company, Radio One of Indiana, Inc., Interactive One, LLC, Reach Media, Inc., TV One, LLC (TV One), Blue Chip Broadcasting, LLC, Community Connect Inc., and Cox Media.

Contributions

Participants may elect to defer up to 100% of their eligible annual compensation, as defined by the Plan, or a flat dollar amount, not to exceed the maximum allowable contribution under the Internal Revenue Code (the Code), which totaled \$23,000 for the year ended December 31, 2024. Participants may also contribute after-tax compensation as Roth elective contributions. A participant's Roth elective contributions are allocated to a separate account maintained for such contributions. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions, subject to limitations imposed by the Code, which totaled \$7,500 for the year ended December 31, 2024. Participants may also roll over funds into the Plan from other qualified plans. The Plan allows for automatic enrollment for all new eligible employees. All eligible employees are automatically enrolled in the Plan on the first day of the month following one month of service at a contribution level of 3% of pre-tax annual compensation, unless they elect not to contribute or contribute a different amount. Elective deferral increases for participants that are automatically enrolled will occur July 1st of each Plan year. The increase will continue each year by 1%, up to a maximum of 10%, unless the participant elects to not participate in the automatic increase.

On an annual basis, the Company may make a discretionary matching contribution, which shall be a percentage of the eligible contributions made by the eligible participant during the contribution period. To be eligible for the discretionary matching contribution, an employee must make salary deferrals into the Plan. In addition, the Company may make a discretionary non-elective contribution, as defined by the Plan. In order to be eligible for the discretionary non-elective contribution, the participant must be employed at the end of the Plan year and have earned at least 1,000 hours of service during the Plan year. During the year ended December 31, 2024, the Company did not elect to make any discretionary contributions to the Plan.

1. DESCRIPTION OF THE PLAN – cont'd.

Participant Accounts

Each participant's account is participant-directed and contributions are credited with the investment options selected by each participant. Plan earnings, losses and administrative expenses are allocated to each participant's account based upon the balance in each account. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance, not to exceed \$50,000, without regard to the intended use of the funds. The minimum note amount is \$1,000 and a participant may have no more than one note outstanding at any given time. Notes are collateralized by the participant's vested account balance. Note repayments are to be made at least quarterly with interest at a fixed rate of prime plus 1% at the time of loan issuance. Notes for reasons other than the purchase of a primary residence are to be repaid within five years. Notes receivable for the purchase of a primary residence must be repaid in ten years or less.

Payment of Benefits

Upon termination of service, death, disability, retirement, or attainment of age 59 ½, a participant (or their beneficiary, in the event of death) is entitled to a distribution of their vested account balance. Distributions from the Plan are payable in the form of a lump sum or in the event of retirement, installments over a period not to exceed the participant's assumed life expectancy. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed by the participant may be withdrawn for a hardship purpose. In-service withdrawals may be requested by a participant upon attainment of age 59 ½. Certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½. Distributions and withdrawals are subject to the applicable provisions of the Plan agreement. Upon termination of service or retirement, participants with a vested account balance equal to or less than \$5,000 that have not elected to distribute their balance will have their balance rolled over into an individual retirement account or distributed as a lump sum designated by the Plan administrator. As of December 31, 2024 and 2023, there were no net assets available for benefits of the Plan allocated to participants who had elected to withdraw from the Plan but had not yet received the funds prior to year-end.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contributions, plus earnings thereon, is based on years of service according to the following schedule:

2	50%
3	75%
4	100%

Former participants in the TV One Plan are 100% vested in any prior safe harbor matching contributions upon transfer of the related assets to the Plan. Upon death, disability, or normal retirement (age 65), a participant becomes 100% vested in their Company contributions.

Forfeitures

All forfeitures resulting from the withdrawal of participants prior to vesting are retained in the Plan and used to pay administrative expenses or reduce Company contributions. A forfeiture will occur in the Plan year that a participant receives a distribution of their entire vested balance or, if they do not receive a distribution, after five consecutive one-year breaks in service. The amount of forfeitures available totaled \$21,934 and \$22,440 as of December 31, 2024 and 2023, respectively. Forfeitures used to pay administrative expenses totaled \$1,280 during the year ended December 31, 2024.

Plan Expenses

All administrative expenses are required to be paid by the Trustee with assets of the Plan, unless paid by the Company, at its discretion. During the year ended December 31, 2024, the Company elected to pay a portion of the Plan’s direct expenses. Expenses that are paid directly by the Company are excluded from the Plan’s financial statements. Loan and distribution fees are paid by the Plan and its participants. Investment related expenses are included in net appreciation of fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to net assets available for benefits and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in assets that are exposed to risks such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities may occur that materially affect participant account balances and amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Interest income is recorded on the accrual basis. Delinquent notes are treated as distributions based on the terms of the Plan agreement.

Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Interest bearing cash: Valued at amortized cost, plus accrued interest, which approximates fair value.

Interest in common/collective trust (CCT): Valued at the net asset value (NAV) practical expedient of the CCT as provided by the CCT managers. The NAV practical expedient is based on the value of the underlying assets owned by the fund, less its liabilities, and divided by the number of units outstanding.

Interests in registered investment companies: Valued at the closing price reported in the active market in which the funds are traded.

Fair Value Measurement – cont’d.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Fair Value Measurement – cont’d.

The Plan’s fund measured at NAV is composed of a common/collective trust account, which is measured daily and may be redeemed daily with a twelve month restriction related to the redemption notice period, with no unfunded commitments. The fund invests primarily in high-quality guaranteed investment contracts and security-backed investment contracts, including similar contracts issued by insurance companies, banks, and other financial institutions and other short-term investments.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan evaluated for disclosure any subsequent events through August 18, 2025, the date the financial statements were available to be issued, and determined there were no material events that warrant disclosure.

3. INVESTMENTS

All investment data contained in the accompanying financial statements and supplemental schedule, including assets held at December 31, 2024 and 2023, interest and dividend income and net realized and unrealized appreciation in fair value of investments for the year ended December 31, 2024 was obtained or derived from the information supplied to the Plan administrator and certified as complete and accurate by the Trustee of the Plan, Fidelity Management Trust Company.

4. PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in shares of mutual funds managed by Fidelity Investments Institutional Operations Company, Inc. (FIIOC), who acts as Custodian for the Plan. The Custodian is a related party to the Trustee. The Plan loans funds to its participants according to the applicable provisions of the Plan agreement. The Company provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all contributions to the Plan would cease and all affected participants would become 100% vested in their accounts.

6. INCOME TAX STATUS

The Plan adopted a non-standardized pre-approved profit sharing plan which received an opinion letter from the IRS dated June 30, 2020 stating that the Plan is qualified under Section 401(a) of the Code and therefore, the related trust is exempt from taxation. Subsequent to the date of the opinion letter, the Plan has been amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification.

The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan's financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued related to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the IRS and Department of Labor; however, there are currently no audits for any periods in progress.

On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security (CARES) Act was passed in order to help the United States economy and workers in the midst of the COVID-19 pandemic. The CARES Act included numerous provisions related to retirement plans. The Plan decided to adopt provisions to allow for COVID-19 penalty-free distributions for qualified individuals through December 31, 2020 and provide a temporary waiver of required minimum distributions required to be paid in 2020. In addition, the Plan adopted a loan provision allowing the maximum loan amount to be taken by a qualified individual to be temporarily increased to the lesser of \$100,000 or 100% of the participant's vested balance from the date the CARES Act was enacted and continuing for 180 days. The CARES Act also delayed loan repayments from the date of the Act through December 31, 2020 for qualified individuals. As of the report date, the Plan has not been formally amended for these provisions.
