**Note 1. Description of the Plan**

The following description of Templeton & Companies Profit Sharing & 401(k) Plan (Plan) provides only general information. Participants should refer to the *Summary Plan Description* for a more complete description of the Plan's provisions, which is available from the Plan Administrator. The Plan was established on February 1, 2004, as a result of the merger of the Company's separately sponsored plans.

**General**

The Plan is a defined-contribution plan sponsored by Templeton Coal Company, Inc. (Company) for the benefit of its employees who have at least three months of service and are age 21 or older.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company (Fidelity) is the trustee of the Plan. The following related employers have adopted the Plan under the qualified separate lines of business provisions of ERISA:

- Templeton Coal Company, Inc. (Plan Sponsor)
- Dicksons, Inc.
- Glas-Col, LLC
- Templeton Mineral Lands, LLC
- Physitemp Instruments LLC
- Sincerely Hers, LLC

**Contributions**

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 90% of eligible compensation. Employee rollover contributions are also permitted. Participants may also make Roth elective deferrals. For 2024 and 2023, Templeton Coal Company, Inc.; Glas-Col, LLC; and Physitemp Instruments LLC made discretionary matching contributions of 100% of the first 2% of employee's contributions plus 50% of the next 4% contributed, while Dicksons, Inc. made discretionary matching contributions of 25% of the first 6% of employee's contributions and Sincerely Hers, Inc. made discretionary matching contributions of 50% of the first 6% of employee's contributions.

Company profit-sharing contributions are discretionary as determined by the respective Companies' Boards of Directors. The Plan provides each participating employer the authority to determine the discretionary matching contribution for their respective employees. Contributions are subject to certain limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings; the account is also charged with an allocation for administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Participant Investment Account Options***

Investment account options include various funds. Each participant has the option of directing his contributions into any of the separate investment funds and may change the allocation daily.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise. The Plan Document also includes an automatic deferral feature in which participants are automatically enrolled into the Plan at a rate of 5% and an automatic increase of employee deferrals at a rate of 1% each year will occur until a maximum of 10% is reached.

***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after six years of service, with 20% vesting after two years, 40% after three years, 60% after four years, and 80% after five years. The nonvested balance is forfeited upon termination of service. Forfeitures are used to pay administrative fees.

***Payment of Benefits***

Upon termination of service, an employee may elect to receive either a lump-sum amount equal to the vested value of his account or an installment payment or a combination of the two. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

***Forfeited Accounts***

At December 31, 2024 and 2023, the balance in the forfeited nonvested accounts totaled \$37,987 and \$18,480, respectively. This amount will be used to offset administrative expenses. For the years ended December 31, 2024 and 2023, \$19,957 and \$10,023, respectively, of forfeited nonvested accounts were used to pay Plan expenses.

***Notes Receivable From Participants***

Participants may borrow a minimum of \$1,000 from their fund accounts, and the maximum is the lesser of 50% of their vested account balance or \$50,000. The loans are secured by the balance in the participant's account and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the Plan Administrator.

Delinquent participant loans are reclassified as benefit payments based upon the terms of the Plan Document.

***Plan Termination***

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

***Subsequent Events***

Subsequent events have been evaluated through August 15, 2025, which is the date the financial statements were available to be issued.

## **Note 2. Summary of Significant Accounting Policies**

### ***Method of Accounting***

The accompanying financial statements are prepared on the accrual method of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### ***Valuation of Investments and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds and the prime money class fund are valued at the net asset value (NAV) of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Plan Tax Status***

The Plan operates under an adoption agreement in connection with a prototype retirement plan and trust document sponsored by FMR LLC. The Plan has not been submitted to the Internal Revenue Service (IRS) for an individual determination letter as the volume submitter document has a favorable opinion letter from the IRS. The Plan has been amended since the prototype received a favorable opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

### ***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

### ***Administrative Expenses***

Administrative expenses are paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 2 or Level 3 securities held by the Plan.

**Note 5. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invests in various mutual funds of the Plan trustee.

The Company provides certain administrative services at no cost to the Plan. The Plan paid \$29,722 and \$23,809 of administrative and trustees fees to Fidelity during 2024 and 2023, respectively. The Plan paid fees of \$20,000 and \$10,000 to Old National Wealth Management, the Plan's investment advisor, during 2024 and 2023, respectively.

**Note 6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
