Defined Contribution Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

NOTE A - DESCRIPTION OF PLAN

The following description of the Hunt Midwest Enterprises, Inc. Defined Contribution Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. This documentation is available from the Plan's Administrator. The Plan Administrator has the full power to decide what the plan provisions mean, to answer all questions about the plan (including those about eligibility and benefits, and to supervise the administration of the plan).

General

The Plan is a defined contribution plan sponsored by Hunt Midwest Enterprises, Inc. and its subsidiaries and affiliates: Hunt Financial Group, LLC and Unity Hunt, Inc. (collectively, the Companies and Plan Sponsors) for the benefit of substantially all eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Retirement Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Under the Plan document, participants are eligible to participate in the Plan and make salary deferral contributions as of the next quarterly entry date after their employment date and attaining age 21. In addition, participants are eligible for discretionary employer contributions as of the next quarterly entry date following the date they have completed one year of service and attained age 21. The Plan document provides for participant direction of all investments.

Contributions

Each year, participants are entitled to contribute up to 100% of pretax eligible compensation, as defined in the Plan, or up to the annual limit of \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively, in accordance with the IRS regulations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. In addition, participants who have attained age 50 and who are making contributions to the Plan are allowed to make additional catch-up contributions to the Plan up to an annual maximum of \$7,500 and \$7,500 for the years ended December 31, 2024 and 2023, respectively.

The Companies may contribute an annual matching contribution of 50% of participant salary reduction contributions. The matching contribution is limited to 2% of eligible participant compensation and is participant-directed. The Companies may also make discretionary contributions to the Plan which are determined annually by the Companies' Board of Directors. Discretionary contributions are allocated first by the ratio that a participant's compensation in excess of the social security wage base bears to the excess compensation of all eligible participants, subject to a maximum allocation. Any remaining discretionary contributions are allocated to participants in the ratio that their compensation bears to the total compensation of all participants eligible to share in the allocation for that plan year. The Companies' discretionary match and profit-sharing contributions to the Plan during the years ended December 31, 2024 and 2023 were \$984,768 and \$929,294, respectively. Contributions are subject to certain limitations as determined by the IRS.

Investment Options

Participants direct their investment contributions into various investment options offered by the Plan. As of December 31, 2024 and 2023, the Plan offers a variety of mutual funds, pooled separate accounts, and a collective trust as investment options for participants.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Companies' contributions and (b) plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participant contributions plus actual earnings thereon are 100% vested immediately. The Companies' matching and discretionary contributions are subject to the following schedule:

Less than 3	0%
3 or more	100%

The Companies' matching and discretionary contributions are also 100% vested on the date the recipient should die, become fully disabled, or reach the retirement age of 65.

Payment of Benefits

On termination of service, a participant will receive a lump-sum payment equal to the value of the participant's vested interest in their account or, if the vested account balance is greater than \$5,000, leave the account invested in the Plan on an inactive basis.

The Plan allows for lump-sum distributions. Upon termination of service a participant may receive a distribution of their vested balance. Participants who have attained age 59½ and continue to work may elect early withdrawal.

Forfeited Accounts

At December 31, 2024 and 2023, the Company had \$17,527 and \$9,131, respectively, of forfeited, non-vested account balances outstanding, which are reflected in the investments on the statements of net assets available for benefits. Forfeited amounts are reallocated to active participants or offset plan expenses in the same manner as employer discretionary contributions. During the years ended December 31, 2024 and 2023, forfeitures of \$0 and \$0, respectively, were allocated to participants.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Companies and are not included in the financial statements. Expenses, such as recordkeeping expenses, bonding expenses required by ERISA, direct costs incurred by the Companies with respect to the Plan, or other administrative fees, to the extent the employer does not pay such expenses, may be paid out of the assets of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Subsequent Events

The Plan has evaluated subsequent events through July 29, 2025, the date the financial statements were available to be issued. There have been no subsequent events identified through the date of the financial statements.

NOTE C - FAIR VALUE MEASUREMENTS

Fair value is determined based upon a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access;
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability; and
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts - Units held in the pooled separate account (PSA) are valued using the Net Asset Value (NAV) practical expedient of the PSA as reported by the account manager. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding.

Collective trust - Valued at the NAV of the underlying investments at year end as a practical expedient to fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

NOTE D - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee and Trust Company (d/b/a Principal Trust Company), the trustee of the Plan, has certified that the following data included in the financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023; and
- Schedule H, line 4i - the schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedules.

NOTE E - PLAN TERMINATION

Although the Companies have not expressed any intent to do so, they have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their account balances.

NOTE F - TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in these financial statements.

NOTE H - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain plan investment options are funds managed by Principal Trust Company with transaction services performed by Morgan Stanley, the trustees and the investment advisor of the Plan, respectively. These transactions qualify as party-in-interest transactions. Fees paid to Principal Trust Company and Morgan Stanley amounted to \$101,256 and \$66,338 for the years ended December 31, 2024 and 2023, respectively.

As reported on the supplemental schedule of delinquent participant contributions for the year ended December 31, 2024, the Company failed to remit to the Plan's trustee certain participant contributions totaling \$26,274 within the period prescribed by the Department of Labor regulations. On September 5, 2024, the Plan fully corrected the 2024 delinquent contributions and remitted lost earnings to the affected participant's accounts.

NOTE I - EXCESS CONTRIBUTIONS

To comply with certain discrimination testing rules, the Plan may be required to refund a portion of the contributions made by highly compensated employees during 2024 and 2023. There were no amounts due to highly compensated employees at December 31, 2024 and 2023.
