### 1. PLAN DESCRIPTION

The following is a description of the First Realty Management Co., Inc. 401(k) Plan (the Plan) provided for general informational purposes. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution plan covering substantially all employees of First Realty Management, Inc. (the Company) upon attaining age 21, as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan has been amended and restated effective January 1, 2024. At December 31, 2023, the Plan's assets were maintained in an investment trust held by Mid Atlantic Trust Company (Mid Atlantic). Effective July 1, 2024, the Plan's assets were transferred into an investment trust held by Alerus Financial, N.A. (Alerus).

**Contributions** – Participants may elect to make tax deferred contributions of their annual pre-tax compensation, subject to limitations imposed by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6%, automatically increasing annually by 1% up to a maximum of 10% of eligible compensation until changed by the participant. Such contributions are invested in a designated balanced fund, until changed by the participant. The Company may make a discretionary matching contribution of 25% of participants' deferrals up to 6% of eligible compensation. In addition, the Company may also make discretionary profit-sharing contributions in an amount equal to the ratio of each participant's eligible compensation to total eligible compensation, as defined in the Plan. There were no Company discretionary profit-sharing contributions made in 2024 and 2023.

**Participant Accounts** – Each participant's account is credited with his or her contributions, the Company's contributions, and actual earnings thereon. Each participant's account is reduced by the actual amount of benefits paid on his or her behalf, investment losses and an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – Participants are fully vested in their contributions and earnings thereon at all times. Vesting in the Company's contributions is based on years of continuous service as follows:

**Notes Receivable From Participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 reduced by the highest outstanding loan balance within the past 12 months or 50% of their vested account balance, as defined. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1% per annum (8.5% at December 31, 2024). Loan terms are to be repaid over a period not to exceed five years, or longer for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions.

### 1. PLAN DESCRIPTION (*Continued*)

**Forfeitures** – In accordance with the Plan document, forfeitures of non-vested discretionary employer contributions may be used to pay plan expenses or applied to reduce employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,791 and \$315, respectively. During the year ended December 31, 2024, administrative expenses were reduced by approximately \$23,681 from forfeited non-vested accounts.

**Payment of Benefits** – The Plan provides for normal retirement benefits upon reaching age 65 and has provisions for early retirement, hardship, disability, in-service, death and termination benefits for those participants who are eligible to receive such benefits. Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of his or her account, or periodic installments over a period not to exceed the life expectancy of the participant or their beneficiary.

**Administrative Expenses** – The Plan’s administrative expenses are paid by either the Plan or the Company as defined in the Plan document.

**Plan Termination** – Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes both realized and unrealized gains and losses incurred during the year.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded at December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Contributions** – Contributions from Plan participants and the Company contributions are recorded in the year in which the participants compensation is earned.

**Benefit Payments** – Benefits are recorded when paid.

**Administrative Expenses** – Certain costs of administering the Plan are paid by the Company and are excluded from the accompanying financial statements. Fees related to the administration of notes receivable are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation in fair value of investments.

**Subsequent Events** – The Plan has evaluated events and transactions that occurred between January 1, 2025 and September 17, 2025, which is the date these financial statements were available to be issued, for possible disclosure and recognition in the financial statements.

### 3. FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- *Level 1* – Inputs to the valuation methodology that consist of unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2* – Inputs to the valuation methodology that include: (1) quoted prices for similar assets or liabilities in active markets, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability; and (4) inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- *Level 3* – Inputs to the valuation methodology that are unobservable and are significant to the overall fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for Plan assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Common/collective trust* – Valued at NAV based on the underlying assets of the trust. The NAV is used as a practical expedient to estimate fair value and is obtained from information provided by the investment advisor using the audited financial statements of the common/collective trust at year end. There are no restrictions on redemptions or unfunded commitments related to these investments.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. ### 5. INCOME TAX STATUS

The Plan has adopted a non-standardized form of a prototype plan sponsored by Alerus Financial, N.A. The prototype plan provider has received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by the Plan. The Plan has been amended since the prototype plan received the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has concluded that as of December 31, 2024 or 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any periods in progress.

### 6. PARTY-IN-INTEREST TRANSACTIONS

The Plan utilizes a number of service providers which qualify as party-in-interest transactions. Additionally, the notes receivable from participants qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA. Fees incurred by the Plan for the investment management and other services amounted to \$52,371 for the year ended December 31, 2024.

### 7. RISKS AND UNCERTAINTIES

The Plan invests in multiple investment securities that are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investments will occur in the near-term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
