A. Description of the Plan

The following description of the GTS Technology Solutions, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan that was established January 1, 2016, by GTS Technology Solutions, Inc. (the Company) and is maintained for the benefit of eligible employees, as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan's sponsor and serves as plan administrator.

Secure 2.0 Act. The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and included mandatory and optional provisions with varying effective dates in 2024, and later. The Company has until the end of the first plan year beginning on or after January 1, 2025, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Eligibility. Employees of the Company are eligible to participate in the Plan upon reaching age 21 and after completing three months of service. Employees enter the Plan on the first day of the following eligible month.

Contributions. A Participant may contribute to the Plan through payroll deductions up to the maximum amount allowed by the Internal Revenue Code. Annual participant salary deferrals are limited by the Internal Revenue Code to \$23,000 for 2024. In addition, participants who have attained age 50 are permitted to contribute additional "catch-up" salary deferrals.

Eligible employees are allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans.

Any participant who elects to make a contribution is eligible to receive a discretionary matching contribution. For the period January 1, 2024, to February 28, 2024, the Company matched 25% of employee deferrals. The employer match was stopped effective March 1, 2024. For the year ended December 31, 2024, the Company made Employer Matching Contributions to the Plan of \$79,852.

In addition to the above Employer Matching Contributions, the Company may, in its discretion, make a Profit Sharing Contribution on behalf of eligible participants. The Plan did not declare or fund a Profit Sharing Contribution for the year ended December 31, 2024.

A. Description of the Plan (continued)

Vesting. Participants are immediately and fully vested in their Elective Deferral contributions and earnings thereon. The vested balance of the employer match and employer profit sharing contributions, if any, and earnings thereon, is based on years of vesting service completed, in accordance with the following:

<u>Years of Vesting Service Completed</u>	<u>Percentage Vested</u>
1 Year	25%
2 Years	50%
3 Years	100%

Participant Accounts. Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution and Plan earnings and may be charged with an allocation of Plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Payment of Benefits. Upon termination of employment, a participant may elect to receive the value of the vested interest in his or her account in either a lump-sum distribution or substantially equal installments. The Plan does not permit distributions prior to termination of service except for participants who have attained age 59½ or for hardship withdrawals in the event of immediate and heavy financial need for the purchase of a principal residence, the payment of medical expenses, payment of post-secondary education, payment of burial or funeral expenses, or payment for the cost of preventing eviction from or foreclosure on the mortgage of a principal residence.

Forfeited Accounts. The forfeited nonvested accounts totaled \$9,069 and \$8,982 as of December 31, 2024, and 2023, respectively. Forfeitures of \$0 were used to reduce Employer Matching Contributions for 2024.

Notes Receivable from Participants. Participants may borrow from their fund accounts up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Principal and interest are repaid ratably through payroll deductions over a period not to exceed five years, except in the case of a loan used to acquire a principal residence. Interest earnings on loans are allocated to the participant's account.

A. Description of the Plan (continued)

Expenses of the Plan. Expenses incurred in the administration and operation of the Plan may be paid by the Company or from the assets of the Plan. Additionally, non-employee participants of the Plan pay their portion of the per participant fee. Administration and operation expenses in 2024 were \$17,908.

B. Summary of Significant Accounting Policies

Basis of Accounting. The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Pooled Separate Accounts. Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the term of the Plan.

Investment Valuation and Income Recognition. The Plan's investments, other than fully benefit-responsive investment contracts which are stated at contract value, are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D. for a further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits. Benefits are recorded when paid.

B. Summary of Significant Accounting Policies (continued)

Use of Estimates. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Contributions. Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which participant compensation is earned.

Recent Accounting Pronouncements.

Management is not aware of any new accounting pronouncements that have been released, and are not yet effective, which will have a significant impact to its financial position or results of operations in future periods.

Subsequent Events. The Plan has evaluated subsequent events through September 17, 2025, the date the financial statements were available to be issued. See further documentation in Note J. Subsequent Events below.

C. Certified Investments

Certain information in the accompanying financial statements related to certain investments held as of December 31, 2024, and 2023, totaling \$8,601,700 and \$7,559,605, respectively, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, totaling \$1,056,392 was obtained by management agreed to or derived from information certified as complete and accurate by Voya, the Plan custodian.

D. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques and used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

There have been no changes in the methodologies used at December 31, 2024, and 2023.

Mutual Funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. As such, they are classified as Level 1 investments.

Pooled Separate Accounts: The Voya variable funds are pooled separate accounts that invest directly in designated mutual funds or, in some cases, collective investment trusts. The separate account owns and holds the underlying mutual fund or collective trust shares which are valued daily at their net asset values (NAV). The credited interest rate, account balance and formulas upon which payments may be based are observable through the contract and related communications. Therefore, we believe they should be classified as Level 2 investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumption to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

E. Investment Contract

The Plan also invests in fully benefit-responsive investment contracts (pooled separate accounts via the Voya Fixed Account. Under the Voya program the Plan does not hold individual stocks, bonds, or other assets. The Plan holds the Voya Retirement Insurance and Annuity Company (VRIAC) contract and/or a trust or custodial account with Voya Institutional Trust Company. VRIAC or Voya Institutional Trust Company own the underlying assets.

The Voya Fixed Accounts are credited with declared rates of interest and the Fixed Accounts are subject to a minimum rate described in the contract. Amounts allocated to the Fixed Account are held in the Voya's general account which supports insurance and annuity obligations. VRIAC's general account is managed on an aggregate basis and supports all of Voya's financial commitments. No portion of the general account is attributable to a particular plan nor do plans have any undivided ownership interest in general account assets.

E. Investment Contract (continued)

The variable funds are pooled separate accounts that invest directly in designated mutual funds or, in some cases, collective investment trusts. The separate account owns and holds the underlying mutual fund or collective trust shares which are valued daily at their net asset values (NAV). Plans and participants hold “units of participation” in the separate account.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) plan termination; (ii) layoffs; or (iii) bankruptcy or reorganization, (iv) merger, (v) tax disqualification, or (vi) early retirement incentive programs. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan’s ability to initiate transactions with the fund at contract value with participants, is probable.

The Voya Fixed Account declared crediting rate will never be below 1 percent annually.

F. Related Party Transactions and Party in Interest Transactions

Certain Plan investments are invested in guaranteed investment funds managed by Voya. Voya is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Participant loans also qualify as party-in-interest transactions. These transactions are exempt from the prohibited transactions rules. Fees paid by the Plan for investment management services to the trustee were \$17,908 for the year ended December 31, 2024.

G. Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified.

G. Tax Status (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

H. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

I. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and distributions will be made as soon as administratively practicable after the Plan terminates.
