As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at and of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1—DESCRIPTION OF PLAN**

The following description of The Milford Bank 401(k) Profit Sharing Plan with Cash or Deferred Arrangement (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

***General***

The Plan is a defined contribution plan for covering substantially all employees of The Milford Bank (the “Bank”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Employees are eligible to participate in the Plan on the first day of the quarter coinciding with or following the date they have completed 3 months of service and have attained age 18.

***Contributions***

Each year, Plan participants may make pre-tax contributions up to 100% of pre-tax annual compensation, as defined in the Plan, subject to the statutory dollar limit. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate, with a default deferral rate of 3% of eligible compensation. Participants may also contribute amounts from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Bank makes safe harbor contributions equal to 3% of annual compensation and a discretionary matching contribution currently equal to 50% of up to 6% of compensation the participant contributes to the Plan. Additional profit-sharing amounts may be contributed at the option of the Bank’s Board of Directors for participants who are active on the last day of the Plan year and who are credited with at least 750 hours during the Plan year.

***Participant Accounts***

Each participant’s account is credited with the participant’s contributions and the Bank’s safe harbor contributions, and discretionary matching contributions, and an allocation of the Bank’s profit-sharing contributions, and plan earnings (net of investment expenses). The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

Participants are immediately vested with respect to their voluntary contributions, employer contributions and actual earnings thereon.

***Investment Options***

All investments are made as directed by Plan participants. Participants may direct employee contributions into a variety of mutual funds and a guaranteed investment contract.

**NOTE 1—DESCRIPTION OF PLAN** (CONTINUED)

***Notes Receivable from Participants***

Participants may borrow from their accounts in accordance with the provisions and interest rates set forth by the Plan's loan policy. The minimum amount that can be borrowed is \$1,000 up to 50% of the participant's vested balance, with a maximum of \$50,000. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expenses when they are incurred. Participants may have only one loan outstanding at any time. The loans are secured by the balance in the participant's account.

***Payment of Benefits***

Eligible employees are entitled to the value of their accounts beginning at age 65, the normal retirement age. In addition, participants may receive in-service distributions upon obtaining age 59½, for hardship reasons and for childbirth and adoption purposes. Benefits shall be distributed to participants in a single lump sum or in annuity payments over a period of time. When a participant becomes permanently disabled or dies, the beneficiary will be entitled to the participant's account balance in the same manner as if the participant had retired at the normal retirement date.

***Forfeited Accounts***

There were no forfeited accounts at December 31, 2024 and 2023. These accounts, if any, may be used to reduce future employer contributions or plan administration expenses. During 2024, forfeited amounts of \$2,094 were allocated to reduce employer contributions.

**NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value, except for the guaranteed investment contracts (GIC) issued by insurance companies and other financial institutions at fixed rates, which are carried at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

***Payment of Benefits***

Benefits are recorded when paid.

***Operating Expenses***

Administrative costs for the day-to-day operation of the Plan are covered, in whole or in part, by investment fees that are deducted directly from the net assets. Personnel within the Bank perform various administrative services for the Plan, including maintenance of participant records. The payroll and related overhead costs associated with these services are not included as Plan expenses.

**NOTE 3—INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

The following information included in the accompanying financial statements and ERISA-required supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by Principal Trust Company (“Principal”) as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

**NOTE 4—FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

**NOTE 4—FAIR VALUE MEASUREMENTS (CONTINUED)**

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis:

*Mutual funds:* The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. The funds must to publish their daily net asset value (“NAV”) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued at the fair value per share (unit) based upon the number of shares held by the Plan at year end as reported by the fund managers. The Plan considers the fair value per share (unit) to be a readily determinable fair value which is disclosed and used as the basis for current transactions.

**NOTE 5—INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan maintains a fully benefit-responsive guaranteed investment contract with Principal. The investment is a group annuity contract with a guarantee backed by the assets in Principal’s multi-billion dollar general account. The fixed income option provides a guaranteed rate of return for a certain period of time. All amounts in the fixed income account are credited with the current interest rate in effect at the time. Currently subject to a contractual floor of 2%, Principal retains the right to change this rate after advance notice to sponsors. For the years ending December 31, 2024 and 2023, the rates were 1.90% to 2.55% and 1.90% to 2.05%, respectively.

**NOTE 5—INVESTMENT CONTRACT WITH INSURANCE COMPANY** *(CONTINUED)*

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

The contract may pay benefits at the direction of the contract holder to a participant who becomes entitled to them under the terms of the plan. A plan fiduciary may elect to have the Plan's Interest in the Principal Guaranteed Option paid out in six installments. The first installment payment will be made six months after the plan's notice to terminate its interest. Each of the following five installment payments will be made on the anniversary of the first payment dates. In lieu of installment payments, the plan fiduciary may elect at any time after providing notice to terminate the Plan's Interest and have the Plan's Interest paid as a single sum, subject to an early termination charge. An election of the single sum payout is irrevocable. The single sum payment will be made on a date that is at least 90 days, but no more than 180 days, from the plan fiduciary's election of this payment.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

The contract value of the investment contract is certified by Principal.

**NOTE 6—RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Plan investments held during the years ended December 31, 2024 and 2023 were managed by Principal. Transactions involving these investments and administrative and service fees qualify as exempt party-in-interest transactions under ERISA. The Plan allows participants to take loans against their account balances, which are also considered exempt party-in-interest transactions.

**NOTE 7—TAX STATUS**

The Plan is a pre-approved profit-sharing plan of Principal Life Insurance Company, which received an opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code (the “IRC”). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

The Plan accounts for uncertainty in income taxes in accordance with FASB ASC 740, *Income Taxes*. Federal tax years 2021 through 2023 remain open for audit under the statutes of limitations.

**NOTE 8—PLAN TERMINATION**

Although it has not expressed any intent to do so, the Bank has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

**NOTE 9—RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE 10—SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through September 15, 2025, the date on which financial statements were available to be issued.
