#### Note 1. Description of Plan

The following description of the Invictus International Consulting, LLC 401(k) Plan (the Plan) provides only general information. A complete description of the Plan is contained in the Plan Document which governs the operation of the Plan.

##### General

The Plan is a defined contribution plan covering substantially all employees of Invictus International Consulting, LLC (the Company), who are at least 18 year old and who have completed one month of service, except for temporary and casual employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was originally effective on January 1, 2016 and was most recently restated on January 1, 2022.

The Plan's investments are held with Ascensus Trust Company, the Plan custodian. The assets held by the custodian are comprised of mutual funds and money market funds. Vanguard provides investment and record keeping services to the Plan.

The Secure 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, many of which became effective in 2023 and 2024.

##### Contributions

Participant contributions are determined by each individual participant. Participants may contribute up to 90% of their eligible compensation subject to the limits established by the Internal Revenue Code (\$23,000 for 2024 and \$22,500 for 2023). Participants who are age 50 or older may make additional catch-up contributions up to the maximum amount allowed (\$7,500 for both 2024 and 2023). Participant rollover contributions are also allowed. Participants elect to have their contributions invested in various investment options offered by the Plan's custodian. Each participant's account is credited with the participant's contributions and earnings on these contributions. Allocation of plan earnings is based on the investment types and account balances and is allocated based on the proportion of each participant's account balance as it relates to all participant account balances in that investment type.

The Company may elect to make matching contributions. During 2024 and 2023, the Company contributed 50% of the first 6% of compensation that a participant contributed to the Plan. Matching contributions are calculated based on a participant's eligible compensation and elective deferrals for each pay period.

Matching employer contributions totaled \$802,810 and \$591,566 for the years ended December 31, 2024 and 2023, respectively. The employee deferral contributions totaled \$2,813,468 and \$2,037,926, while rollover contributions totaled \$359,313 and \$175,741 for the years ended December 31, 2024 and 2023, respectively.

##### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions, if any, and Plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Note 1. Description of Plan (Continued)

##### Vesting

Participants are immediately vested in their 401(k) elective deferral and rollover contributions to the Plan plus actual earnings thereon. Vesting in employer discretionary matching contributions is based on years of continuous service of at least 1,000 hours per year. At December 31, 2024 and 2023, the vesting schedule for employer discretionary matching contributions is as follows:

##### Benefit Payments

The Plan provides for benefit payments upon termination, death, disability, age 59 1/2 in-service distributions or normal retirement at the age of 65, based on the vested balance in the participant's account. Hardship withdrawals are also permitted if certain conditions are met as outlined in the Plan Document. Benefit payments are recorded when paid. There were no significant benefits payable to terminated participants who have withdrawn from the Plan as of December 31, 2024 or 2023.

##### Notes Receivable – Participant Loans

Participants may borrow up to one-half of their vested account balance, with a minimum of \$1,000 and up to a maximum of \$50,000. Loans terms range from one to five years or up to ten years for the purchase of a primary residence. The loans are secured by a portion of the participant's vested account balance and bear interest at the prime interest rate plus two percent. Principal and interest are paid through payroll deductions.

##### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company. Transaction expenses, such as loan and distribution administrative fees, are charged directly to the participant's account and are included in administrative expenses. Certain investment advisory and recordkeeping fees are allocated to participants based on account balances.

##### Forfeitures

A participant who terminates and has vested in the employer non-elective discretionary contributions retains the vested portion and the nonvested portion is forfeited when vested amounts are distributed. Forfeitures may be used to reduce future Company contributions, or to pay Plan expenses. Forfeitures applied to offset Company contributions and pay administrative fees were \$48,675 and \$68,713 in 2024 and 2023, respectively. Forfeitures available to offset administrative expenses and Company contributions were \$10,911 and \$35,670 at December 31, 2024 and 2023, respectively.

#### Note 2. Summary of Significant Accounting Policies

##### Basis of Accounting

The Plan's financial statements are prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### Note 2. **Summary of Significant Accounting Policies (Concluded)**

#### **Investment Valuation and Income Recognition**

The Plan's investments in mutual funds are stated at fair value using quoted market prices. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis, dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable- Participant Loans**

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

#### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### Note 3. **Income Tax Status**

The Plan adopted a non-standardized, pre-approved profit sharing plan designed by CCH, Incorporated which received an opinion letter on June 30, 2020 in which the Internal Revenue Service stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code (Code). The Plan has been amended since receiving the opinion letter, however, the Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize an adjustment to taxable income if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan sponsor has analyzed the tax positions taken by the Plan, and is not aware of any uncertain tax positions that would require an adjustment to taxable income or disclosure in the financial statements as of December 31, 2024 or 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there is no audit in progress for any open tax period.

### Note 4. **Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement* (ASC 820), establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of inputs other than quoted prices in an active market that are observable; and Level 3 inputs are unobservable and significant to the fair value measurement, and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits.

### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 9. Party-in-interest Transactions**

The Plan paid service providers for recordkeeping and other services in 2024 and 2023. These transactions qualify as exempt party-in-interest transactions.

### **Note 10. Subsequent Events**

The Plan has evaluated events through September 15, 2025, the date that the financial statements were available to be issued and has determined that no event occurred subsequent to December 31, 2024 that requires recognition or disclosure in these financial statements.
