

## Schedule SB, Line 25 – Change in Method

The valuation software used to produce the actuarial information submitted on this schedule is different than used for the previous valuation due to a change in both the enrolled actuary for the plan and the organization providing actuarial services to the plan, and such change in software may be considered to be a method change.

The new method is substantially the same as the method used by the prior enrolled actuary and is consistent with the description of the method contained in the prior actuarial valuation report and Schedule SB of Form 5500. The funding target and target normal cost, as determined for the prior plan year by the new enrolled actuary (using the actuarial assumptions of the prior enrolled actuary) are both within 3% of those values as determined by the prior enrolled actuary.
