Note 1. Description of Plan

The STAR Financial Group, Inc. 401(k) Savings Plan (the "Plan") is a defined contribution plan covering employees of STAR Financial Group, Inc. (the "Company") and its subsidiaries for employees who are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The provisions of the Plan are included in the official Plan document which legally governs the operations of the Plan and is available for more detailed information.

Contributions

Participants may make voluntary pre-tax or Roth contributions of eligible compensation in whole percentages or specified dollar amounts, up to the dollar limits set by the Internal Revenue Code. Employee rollover contributions and in-plan Roth rollover contributions are also permitted.

The Company may make discretionary matching contributions based on a participant's elective deferrals. The amount and form of employer matching contributions are determined by the Company's Board of Directors. Additionally, the Company may elect to make a discretionary profit-sharing contribution. The Company matching contributions to the Plan for the year ended December 31, 2024 were \$1,137,370. There were no discretionary profit-sharing contributions during 2024.

The Plan document also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral begins at 6% and increases at 1% per year, until the election reaches 10%, unless the participant elects otherwise.

Participant Accounts

Each participant's account is credited with the participant's contribution, if any, and an allocation of the Company's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations of the earnings are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus the earnings thereon. The Plan was amended effective January 1, 2023, to change the vesting schedule for Company discretionary match contributions plus the earnings thereon to 100% after one year of service. Prior to January 1, 2023, participants were immediately vested in their Company discretionary match contributions plus the earnings thereon. Vesting in the Company's profit-sharing contributions plus the earnings thereon is based on years of service. A participant is 100% vested after five years of credited service.

Note 1. Description of Plan (Continued)

Forfeitures

Participants who terminate from the Plan prior to becoming fully vested must forfeit a percentage of their Company contribution amount. These forfeitures are used to reduce future Company contributions. During the year ended December 31, 2024, no forfeitures were used to reduce Company contributions. The amount of forfeitures held by the Plan at December 31, 2024 and 2023, was approximately \$8,300 and \$1,100, respectively.

Benefit Payments

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or installment payments. Mandatory cash-out payments occur without the consent of the participant if their balance is less than \$5,000 upon termination. Hardship and in-service distributions are also allowed from the fully vested portion of a participant's account balance with certain restrictions, as outlined in the Plan document.

Termination of the Plan

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time, subject to the provisions set forth in ERISA.

Note 2. Significant Accounting Policies

Basis of Financial Statements

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

The Plan holds investments in common trusts that are considered to be fully benefit-responsive investments. Fully benefit-responsive investments held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. However, these funds qualify for measuring fair value using the net asset value (NAV) practical expedient. This NAV represents the Plan's fair value since this is the NAV at which the Plan transacts with the funds.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Note 2 Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales transactions are recorded on a trade-date plus one-day basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Management of the Plan has evaluated events and transactions for possible recognition or disclosure through September 12, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by the Plan's Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by the trustee, T. Rowe Price Trust Company, and was not subjected to any auditing procedures performed by the independent public accountants:

- a. Investments as shown in the accompanying Statements of Net Assets Available for Benefits.
- b. Net investment income, as shown in the accompanying Statement of Changes in Net Assets Available for Benefits, including interest and dividend income and net realized and unrealized appreciation in fair value of investments.
- c. Schedule of assets (held at end of year).

Note 4. Fair Value Measurements

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

- Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

The asset's or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at quoted market prices, which represent the net asset values (NAV) of shares held by the Plan at year end.

Common investment trusts (CIT): Valued at the net asset value (NAV) provided by the administrator of the funds. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6. Related Party Transactions

The Company provides certain accounting, recordkeeping, and administrative services to the Plan for which it receives no compensation. Administrative expenses for legal, accounting, and other services are rendered by parties-in-interest and are paid by the Company. The Plan invests in mutual funds affiliated with, and collective investment trusts sponsored by the trustee.

Note 7. Income Tax Status

The Plan, which is a prototype plan, obtained its latest opinion letter on August 19, 2020, stating the prototype plan is a qualified plan under Section 401 of the Internal Revenue Code. The Plan has been amended since receiving the letter. The Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan Administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a liability if the Plan has taken an uncertain tax position that more likely than not would not be sustainable upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, the Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 8. Risks and Uncertainties

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
