Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Oklahoma Christian University Defined Contribution Retirement Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution or an agent on behalf of a qualified institution or qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution or an agent on behalf of a qualified institution or qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified to by a qualified institution or an agent on behalf of a qualified institution or institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule listed in the table of contents is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution or an agent on behalf of a qualified institution or qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution or an agent on behalf of a qualified institution or institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1. Description of the Plan

Oklahoma Christian University (University) sponsors the Oklahoma Christian University Defined Contribution Retirement Plan (Plan). The following description provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by the University for the benefit of its employees, except for students or those employees who normally work less than 20 hours per week. The Plan is intended to satisfy all of the requirements for a 403(b) plan under the appropriate provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

The Plan is administered by the University's Chief Human Resources Officer with oversight by the Purpose and HR Committee, which is appointed by the University's Board of Trustees. State Street Bank and Trust Company (SSBT) serves as custodian of the assets record-kept by Transamerica Retirement Solutions Corporation (Transamerica), the trustee of the Plan. SSBT has appointed Transamerica as its agent to provide certain necessary duties and functions on its behalf and has entered into a Servicing Agent Agreement for these services. The Plan also holds certain investments that are managed by the Teachers Insurance and Annuity Association of America (TIAA). TIAA and the College Retirement Equities Fund (CREF), together TIAA-CREF, are custodians of certain plan assets, including annuity contracts. Effective July 15, 2023, TIAA Trust, N.A. serves as directed custodian for certain non-annuity investments of the Plan. Prior to July 15, 2023, the directed custodian for certain non-annuity investments of the Plan was TIAA, FSB. Transamerica and TIAA-CREF process and maintain the records of the participant data.

Contributions

The Plan permits eligible employees through a salary deferral election to have the University make annual contributions of up to 100% of eligible compensation. Employee roth and rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows for special code Section 403(b) catch-up contributions for those participants with 15 years of service.

The Plan document includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature also provides for an annual 1% increase in the percentage deferred and is ultimately capped at 6%. The automatic deferral feature is effective for new participants hired after January 1, 2010.

The Plan also provides for discretionary employer contributions to eligible employees. During 2024, the University matched 100% of deferrals at a minimum of 2% up to a maximum of 6% of a participant's eligible compensation, as defined. Employer matching contributions are based on deferrals made each payroll period.

Effective January 1, 2025, the University amended the Plan to provide for nondiscretionary Employer contributions and modified the matching formula to an amount equal to 6% of eligible compensation, if the participant contributes at least 2% of eligible compensation.

Effective January 1, 2025, the University amended the Plan to allow eligible participants to receive Employer matching contributions on qualified student loan payments, as defined. Matching contributions on qualified student loan payments will be made annually following the end of the plan year.

Contributions to the Plan are subject to certain limitations.

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation to the extent permitted by the individual agreements. Investment account options available include various annuity accounts, a pooled separate account, a stable asset fund, and mutual funds.

Participant Accounts

Each participant's account is credited with the participant's contributions, the University's contributions, and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and employer contributions plus earnings thereon.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is based on the prime rate plus 1%, as determined by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions and are repayable over a period not to exceed five years, except for loans for the purchase of a principal residence. Principal and interest are paid through direct payments from participants to SSBT.

Plan Loans With TIAA

The Plan does allow TIAA to issue loans directly to Plan participants. These loans are issued from funds directly owned by TIAA and not from participant accounts and are considered outside the scope of the Plan. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their balance in the TIAA Traditional Annuity account. To secure Plan loans, participants are required to pledge as collateral their TIAA Traditional Annuity account value equal to 110% of the outstanding loan balance in the event of default. Principal and interest are paid by the participant directly to TIAA.

Loan balances outstanding between TIAA and Plan participants were approximately \$86,000 as of December 31, 2023. Approximately \$94,000 of TIAA Traditional Annuity account balances as of December 31, 2023, serves as collateral for the related loans. No loans were outstanding between TIAA and plan participants as of December 31, 2024.

In the event of default, such loans are reportable to Plan participants as taxable income but remain outstanding and continue to accrue interest until repaid by the Plan participant or the participant becomes eligible to receive a distribution under the terms of the Plan. As of December 31, 2023, loans in default amounted to approximately \$73,000. No loans were in default as of December 31, 2024.

The Employee Benefits Security Administration (EBSA) has expressed concern that the pledging of collateral of a participant's balance could be considered a prohibited transaction; however, formal guidance has yet to be issued by EBSA.

Effective November 15, 2019, the Plan no longer allows TIAA to issue loans directly to Plan participants.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or annuity payments over varying time periods. Upon termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution.

Participants who have invested in a TIAA Traditional Annuity account are limited in their ability to elect a lump-sum distribution depending upon the year in which contributions were made; however, they may receive the value of their accumulated benefits over a 10-year period.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value (see Notes 5 and 6). Quoted market prices, if available, are used to value investments. Mutual funds and variable annuities in mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. Variable annuities in pooled separate accounts are valued at estimated fair value as provided by TIAA-CREF.

The TIAA Traditional Annuity is a fixed-dollar annuity and investment product offered by TIAA and includes benefit-responsive and nonbenefit-responsive accounts. The nonbenefit-responsive TIAA Traditional Annuity is recorded at fair value as estimated by TIAA, which approximates contract value. The benefit-responsive TIAA Traditional Annuity is recorded at contract value as discussed in Note 5.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the University or the Plan at the University's discretion.

Note 3. Certification of Plan Custodians

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA, an agent on behalf of a qualified institution, and SSBT and TIAA-CREF, both qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) is complete and accurate:

- Investments, notes receivable from participants, and accrued interest as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information except for comparing such certified investment information to the related investment information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year).

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and significant to the fair value of the assets

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

Investments

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of investments with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such investments are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy. See the table below for inputs and valuation techniques used for Level 3 investments.

Level 3 Activity

Purchases of Level 3 investments totaled approximately \$465,000 and \$453,000 for 2024 and 2023, respectively. There were no issuances or transfers into or out of Level 3 during the year ended 2024.

Note 5. Fully Benefit-Responsive Investment Contract With TIAA

The Plan has a fully benefit-responsive investment contract with TIAA in the form of a traditional annuity contract. TIAA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. TIAA is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The guaranteed investment contract meets the fully benefit-responsive criteria and, therefore, is reported at contract value. Contract value, as reported to the Plan by TIAA, represents contributions under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

The type of contract through which a participant owns the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional amounts paid, the degree of liquidity of the participant's account, and the options for receiving income upon retirement. Certain contract types

contain liquidity restrictions on the redemption of TIAA Traditional Annuity accumulations, which could impact the value realized upon exiting the contract. The guaranteed annual interest rate is 3% for all premiums remitted since 1979 under all TIAA Traditional Annuity accumulating contracts.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: 1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), 2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, 3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemptions under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The carrying value of the fully benefit-responsive investment contract with TIAA, considered to be a traditional investment contract, was approximately \$381,000 and \$422,000 at December 31, 2024 and 2023, respectively.

Note 6. Fully Benefit-Responsive Investment Contract With Standard Insurance Company

The Plan has a fully benefit-responsive investment contract with Standard Insurance Company (Standard) in the form of a stable asset fund. Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Standard is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan.

The guaranteed investment contract is fully benefit-responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at market value, as defined by the contract.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: 1) termination of the contract, 2) spinoffs, 3) divestitures, 4) layoffs, 5) corporate relocation, 6) partial or total plan termination, 7) retirement incentive programs, 8) the liberalization of plan withdrawal, and 9) transfer rules and total withdrawals and transfers exceeding 25% of the total fund at January 1. Standard may terminate the contract with 30 days' advance written notice for reasonable cause, which includes the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the Plan in a reasonable period of time. Upon occurrence of any of these events, a market value adjustment or other withdrawal restriction may apply. Also, if the total amount of withdrawals and transfers exceeds 25% of the contract at January 1, the withdrawal will be subject to a market value adjustment. The Plan administrator does not believe that any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The carrying value of the fully benefit-responsive investment contract with Standard, considered to be a traditional investment contract, was approximately \$1,485,000 and \$2,053,000 at December 31, 2024 and 2023, respectively.

Note 7. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain Plan investments are shares of mutual funds, annuity contracts, or a pooled separate account managed by Transamerica and TIAA-CREF, cash held by SSBT, or Plan assets held by TIAA, FSB or TIAA Trust, N.A (see Note 1). The Plan's traditional annuity contract is maintained in the TIAA general account. Transamerica is the trustee and TIAA-CREF, SSBT, and TIAA, FSB or TIAA Trust, N.A. are the Plan's custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Certain fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments as they are paid through revenue sharing rather than a direct payment. The Plan sponsor directly pays any other fees related to the Plan's operations.

The Plan paid record-keeping fees of approximately \$76,000 to Transamerica during the year ended December 31, 2024. Certain administrative functions are performed by officers and employees of the University. The University does not expect reimbursement from the Plan for these expenses. No officer or employee receives compensation from the Plan for these services.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

TIAA and CREF issue various types of contracts as funding vehicles for retirement plans. Certain contract types contain liquidity restrictions on the redemption of the contract accumulations, which could impact the value realized upon exiting the contract.

Note 9. Plan Termination

Although it has not expressed any intent to do so, the University has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 10. Tax Status

The Plan operates under a volume submitter agreement in connection with a volume submitter plan and trust document sponsored by Transamerica. This volume submitter plan document has obtained an advisory letter from the Internal Revenue Service (IRS) stating that the volume submitter satisfies the requirements under section 403(b) of the Internal Revenue Code (IRC). Although the Plan has been amended since the volume submitter plan document received the advisory letter, the University and the University's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
