To the Board of Trustees of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Grafika Retirement Savings Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above, related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the financial Statements section of our report. We are required to be independent of Grafika Retirement Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Grafika Retirement Savings Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. A. Description of Plan

The following description of the Grafika Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

- 1. General.** The Plan is a defined contribution pension plan covering all full-time employees of Grafika Commercial Printing, Inc. (Company or Plan Sponsor) who have completed at least three (3) months of service and attained age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The 401(k) Plan Committee is responsible for the oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions. Participants may defer the lesser of 90% of pre-tax annual eligible compensation or \$23,000 (in 2024; thereafter as adjusted by the U.S. Secretary of the Treasury) in a calendar year. Effective April 4, 2023, the Plan includes an auto-enrollment contribution provision at 4% pre-tax deferrals. Participants may also make Roth elective deferrals and contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants may also elect to make after-tax voluntary contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Company may make discretionary matching contributions equal to a uniform percentage of each participant's salary deferrals. At the discretion of the Board of Directors, the Company may make additional contributions to the Plan. Effective August 3, 2023, the matching contributions were suspended.

Participants direct the investment of their contributions and the Company's contribution into various investment options offered by the Plan. The Plan currently offers various mutual funds and one common collective trust as investment options for participants.

- 2. Participant Accounts.** Each participant's account is credited with the participant's contribution and allocation of (a) the Company's discretionary matching contribution, (b) any additional Company contributions, and (c) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

- 3. Vesting.** Participants are vested immediately in their salary deferrals, rollover, after-tax and qualified nonelective contributions, plus actual earnings thereon. Vesting in the Company's nonelective and matching contributions is based on years of continuous service. On termination of service due to disability or death during military service, participants become 100% vested in all of their accounts under the Plan. A participant is 100% vested after five (5) years of credited service and is determined as follows:

- 5. Payment of Benefits.** On termination of service due to death, disability or retirement, participants (or their designated beneficiaries) who have a balance greater than \$5,000 may elect to receive the total vested balance in a lump sum distribution or installments or may leave the balance in the Plan until a minimum distribution is required. Participants with a vested balance of less than \$5,000 will receive a mandatory lump sum distribution. A distribution of vested balances between \$1,000 to \$5,000 will be rolled over to an IRA unless the participant makes an affirmative election to either receive or roll over the distribution. Balances under \$1,000 will be paid as a lump sum distribution.

In-service distributions are allowed for participants upon attainment of age 59 ½. Additionally, in-service distribution may be available from elective deferral accounts to participants who are qualified members of the military service and meet certain conditions set forth in the Plan.

Financial hardship withdrawals are permitted set forth in the Plan to satisfy an immediate and heavy financial need.

- 6. Forfeited Accounts.** At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,005 and \$1,239, respectively. Forfeitures may be used to pay Plan expenses or to reduce the employer's contributions. For the year ended December 31, 2024, \$158 of plan expenses were funded from these accounts. For the year ended December 31, 2023, no forfeitures were used to fund the employer's contributions or reallocated to participants.
- 7. Revenue Credit Account.** Under the Plan Services Agreement between Fidelity Workplace Services, LLC (Fidelity) and the Plan Sponsor, the Plan has a Revenue Credit Account (RCA) to fund ERISA-qualified administrative expenses of the Plan. Fidelity makes a payment in the amount of the revenue credit calculated for each quarter to a suspense account within the Plan and it is invested in the specified mutual fund. Any unused RCA funds at the end of the Plan year are accumulated and used to offset future Plan expenses or may be allocated to Plan participants. For the year ended December 31, 2024, \$13,044 of credits were deposited and \$15,750 of Plan expenses were paid from the RCA. At December 31, 2024 and 2023, the Plan's RCA had a total balance of \$21,259 and \$21,764, including interest.

8. Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50,000 or 50% of their vested account balance. Generally, the term of the loan may not exceed five (5) years unless the proceeds are used for the purchase of a primary residence. The loans are secured by the participant's account balance and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid through payroll deductions. Loans are considered in default if any scheduled loan repayment is not made as required.

9. Plan Amendments.

Effective April 4, 2023, the Plan was amended to include the automatic enrollment contribution option at 4% pre-tax deferrals.

SECURE 2.0 Act of 2022: The Plan Sponsor has implemented operational updates to comply with applicable provisions of the SECURE 2.0 Act, including the increase in the required minimum distribution age, expanded eligibility for long-term part-time employees, elimination of pre-death RMDs for Roth accounts, and Roth treatment of catch-up contributions for certain participants. Although the Plan has not yet been formally amended, the amendment is expected to be executed by December 31, 2026, in accordance with IRS guidance.

B. Summary of Significant Accounting Policies

Basis of Accounting: The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Net investment returns reflect certain fees paid by the investment funds to their affiliated investment advisors, transfer agents, and others as further described in each fund prospectus or other published documents. These fees are deducted prior to allocation of the Plan's investment earnings activity and thus are not separately identifiable as an expense.

Contributions Receivable and Allowance for Expected Credit Losses: In June 2016, the FASB issued Accounting Standards Update (ASU) 2016-13, Financial Instruments – Credit Losses (ASC Topic 326) Measurement of Credit Losses on Financial Instruments. ASC Topic 326 significantly changed how entities measure credit losses for most financial assets and certain other instruments that are not measured at fair value through net income. Under the standard, disclosures are required to provide users of the financial statements with useful information in analyzing an entity's exposure to credit risk and the measurement of credit losses. Financial assets held by the Company that are subject to the guidance in ASC Topic 326 are notes receivable from participants and contributions receivable. The Plan adopted the standard effective January 1, 2023. The impact of the adoption was not considered material to the Plan's financial statements and primarily resulted in new and enhanced disclosures only. No allowance for current expected credit losses was considered necessary at December 31, 2024 and 2023.

Notes Receivable from Participants: Notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Corrective Contributions: Corrective contributions include qualified nonelective contributions or other plan corrections and are generally recorded in the year of the event as 'other employer contributions' in the statement of changes in net assets available for benefits. Any associated receivable is presented as 'other employer contribution receivable' as of the Plan's year-end.

Corrective Distributions: Corrective distributions include Plan corrections that are generally recorded in the Plan year and deemed payable to participants. Corrective distributions may also be required in the event that employee contributions exceed the contribution limitations of the Plan allowed by the IRS. These amounts are netted against contributions in the statement of changes in net assets available for benefits and the associated liability is presented as 'excess contribution payable' as of the Plan's year-end.

Expenses: Substantially all expenses for maintaining the Plan are paid by the Plan Sponsor and excluded from the financial statements. The Plan's individual account fees and expenses are charged directly to participant accounts. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events: The Plan has evaluated subsequent events through September 18, 2025, the date the financial statements were available to be issued.

C. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

D. Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification Topic 820 (ASC Topic 820) establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Mutual funds, which are actively traded, are valued at quoted market prices on nationally recognized securities exchanges and represent the net asset value (NAV) of shares held by the Plan at year-end and are classified as Level 1 within the valuation hierarchy.

Common Collective Trust: Valued at the NAV of units of a bank common collective trust. The NAV as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

E. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

F. Tax Status

Effective January 1, 2012, the Employer adopted the Volume Submitter Defined Contribution Plan (a Fidelity Volume Submitter Plan). Fidelity has received a notification letter from the IRS dated June 30, 2020 which indicates that the form of the plan is acceptable under the Internal Revenue Code (IRC). The Plan has been amended since adopting the plan, however, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently operated, in compliance with the applicable requirements of the IRC and, therefore, continues to be exempt from income taxes. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

G. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

H. Related Party Transactions and Party-In-Interest Transactions

During 2024 and 2023, Fidelity Management Trust Company was the Trustee and Fidelity Workplace Services LLC was the recordkeeper of the Plan. Certain Plan investments are shares of mutual funds managed by Fidelity.

The financial statements include recordkeeping expenses paid by the Plan. Fees paid during the year for accounting and other professional services rendered by parties-in-interest were based on customary and reasonable rates for such services.

The Plan issues notes to its participants, which are secured by the participants' balance.

These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.
