Notes to Financial Statements

Note 1: Description of Plan

The following description of Mathews Archery, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Mathews Archery, Inc.; Brennan Industries, Inc.; McPherson, Inc.; and Camrielle Productions, LLC (collectively the "Company"). Employees are eligible to make elective deferrals upon reaching the age of 18 and having completed three months of service. Employees are eligible for the discretionary Company matching and nonelective contributions upon reaching the age of 18 and having completed a year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

In December 2022, Setting Every Community up for Retirement Enhancement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 CARES Act. The effective date of the provisions of SECURE 2.0 vary from beginning effective immediately through 2028. Those provisions include both required and optional elements. Plan management will determine the optional provisions to elect in the future.

Contributions

Each year, participants may contribute a percentage of their pretax or after-tax annual compensation, as defined in the Plan, up to the annual maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan also provides for automatic enrollment at 2% of eligible compensation if no election or waiver is made by the participant. The automatic deferral percentage increases by 1% up to a maximum of 6% of compensation on January 1 each year. Participants also may contribute amounts representing distributions (rollovers) from other qualified defined benefit or contribution plans.

Matching and nonelective contributions by the Company are at the discretion of the Board of Directors and are determined annually. During 2024, the Company elected to make a matching contribution of 100% of participant deferrals, limited to the first 6% of compensation. For the year ended December 31, 2024, the Company made a matching contribution of \$981,950. No nonelective contributions were made in 2024. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company discretionary match contributions, and allocations of Company discretionary nonelective contributions and plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, investment elections, and account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in Company contributions is based on years of service, with vesting of 20% after two years of service, increasing by 20% each year thereafter. A participant is 100% vested after six years of credited service.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate of prime plus 1% at the time of the loan. Interest rates range from 4.25% to 9.50%. Participants make payments on their own, outside the payroll process.

Payment of Benefits

On termination of service, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. The Plan also allows for in-service distributions upon attaining age 59 1/2 or five years of plan participation. Hardship distributions are permitted if certain criteria are met.

Forfeitures

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,046 and \$0, respectively. These accounts are used to reduce future Company contributions to participant accounts or pay plan expenses in accordance with the plan document. Forfeitures in the amount of \$28,055 were used to reduce Company contributions during 2024.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Notes to Financial Statements

Note 2: Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses had been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Excess Contributions Payable

At December 31, 2023, amounts payable to participants totaling \$40,803 for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024. There were no excess contributions for the year ended December 31, 2024.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses.

Subsequent Events

Effective May 1, 2025, Camrielle Productions, LLC ceased its participation in the Plan. This will not have a significant impact to the Plan.

The Plan has evaluated subsequent events through September 22, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would be used only if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds held in pooled separate accounts: Fair value of the mutual funds held in pooled separate accounts is based on quoted net asset values of underlying investments held by the pooled separate accounts adjusted by an asset change. The underlying mutual funds held in the pooled separate accounts are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price.

Note 4: Information Prepared and Certified by the Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable, and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by The Standard Insurance Company (f/k/a Minnesota Life Insurance Company), the Custodian of the Plan.

Note 5: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

Note 6: Tax Status

The Company adopted a non-standardized, preapproved plan document with an IRS opinion letter, which states the plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

In December 2022, the Company filed a Voluntary Correction Program (VCP) application with the IRS to retroactively amend the plan document as of January 1, 2021 in order to exclude certain wages from the definition of eligible compensation. The Company does not believe there will be any issues or concerns in receiving the necessary IRS approval as it relates to the plan amendment, but the Company has not received approval from the IRS as of the date of the financial statements.

Note 8: Related-Party Transactions and Party-in-Interest Transactions

Certain plan investments are managed by The Standard Insurance Company (f/k/a Minnesota Life Insurance Company). The Standard Insurance Company is the Custodian, as defined by the plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan incurred fees related to activities from The Standard Insurance Company as the third-party administrator. Fees for their services during the plan year ended December 31, 2024 were \$3,281.

The Plan's investment advisor is Orgel Wealth Management. For the year ended December 31, 2024, fees paid by the Plan to the advisor amounted to \$78,221.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.
