Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed audits of the accompanying financial statements of The Daily Planet 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of June 30, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

Responsibilities of Management for the Financial Statements

Notes to Financial Statements

1. Description of Plan:

The following description of The Daily Planet 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all eligible employees of Daily Planet, Incorporated (the "Organization"). Employees are eligible to participate upon hire and become eligible to receive employer matching contributions after completing one year of service, during which they have completed at least 1,000 hours of service, and attaining age 21. Employees begin receiving matching contributions on January 1 or July 1, following the date they become eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The plan was restated effective July 1, 2023, with all provisions remaining unchanged.

Plan Administration: Overall responsibility for administering the Plan rests with the Organization. From July 1, 2022, through January 14, 2024, all assets of the Plan were held by the custodian, Nationwide Trust Company, FSB ("Nationwide") and participant accounts were administered by Actuarial Benefits & Design, which served as the third-party administrator of the Plan through June 30, 2023. Effective January 15, 2024, all assets of the Plan were held by Ascensus Trust Company, LLC ("Ascensus") and Newport Trust Company, LLC ("Newport"). Effective July 1, 2023, NOVA 401(k) Associates, Inc. began serving as the third-party administrator of the Plan. Nationwide, Ascensus, and Newport (collectively, the "Custodians") served as custodians of Plan assets during 2024.

Contributions: The Plan provides for participant contributions of pre-tax annual compensation, as defined in the Plan. The Organization matches 100% of participant contributions, subject to a limit of 3% of the participant's compensation. Participants of qualifying age may make additional "catch-up" contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Organization's contributions and (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options: Participants may direct the Custodians as to the balances in accordance with guidelines established by the Plan. Participants may change their investment elections at any time.

Vesting: The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance. Participants are immediately vested in their contributions and the related Plan earnings. Participants are vested 50% in Employer contributions and the related Plan earnings after two years of service, and 100% after three years of service.

1. Description of Plan, Continued:

Notes Receivable from Participants: Participants may borrow from their Plan accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms cannot exceed five years, unless the proceeds are used to acquire a principal residence. The loans are secured by the vested balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll reductions. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants, deemed to be uncollectible by the plan administrator, are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits: Distribution of the vested portion of a participant's account will occur upon the participant's termination of service, retirement, death, disability, or hardship withdrawal, as defined in the Plan. A participant is entitled to receive a lump-sum payment as described by the Plan.

Forfeitures: Forfeited balances of terminated participants' non-vested accounts are used to reduce employer contributions. There were \$3,219 additions to forfeitures during 2024 and were \$725 of additions to forfeitures during 2023. The Organization didn't use any forfeitures in 2024 or 2023. There were \$8,864 in forfeited balances available at June 30, 2024, and \$4,258 in forfeited balances available at June 30, 2023.

2. Summary of Significant Accounting Policies:

Basis of Accounting: The financial statements of the Plan are prepared on the accrual method of accounting.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment gain (loss) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies, Continued:

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events: Management has evaluated subsequent events through July 10, 2025, the date the financial statements were available to be issued, and has determined that there are no subsequent events to be reported in the accompanying financial statements.

3. Fair Value Measurements:

The Financial Accounting Standards Board (“FASB”) has issued guidance for measurement and disclosure of fair value and established a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology are quoted prices for similar instruments in active and inactive markets; and model driven valuations with significant inputs and drivers derived from observable active markets. There were no level 2 assets as of June 30, 2023 or 2024.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement. There were no level 3 assets as of June 30, 2023 or 2024.

Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments carried or disclosed at fair value:

Money Market: Valued at cash balance.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (“SEC”). These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Administrative Expenses:

Although not required by the Plan, some of the costs of the Plan administration are absorbed by the Organization. Administrative expenses incurred by the Plan during the year ending June 30, 2023, primarily were for fees charged by Nationwide Trust Company, FSB, the custodian of the Plan. Administrative expenses incurred by the Plan during the year ending June 30, 2024, primarily were fees charged by Ascensus, the current custodian of the Plan. Administrative expenses totaled \$5,907 for 2024 and \$26,727 for 2023.

5. **Related-Party Transactions:**

The Plan invested in one mutual fund that is administered by Nationwide Trust Company, FSB, the custodian of the Plan. This was related-party transaction. The Plan invests in several mutual funds that are administered by Vanguard, which is associated with Ascensus, LLC. These are considered related-party transactions and are indicated as parties-in-interest in the accompanying schedule of assets (held at end of year).

In addition, as disclosed in Note 4, the Plan pays recordkeeping fees to Nationwide Trust Company, FSB which totaled \$26,727 for 2023. The amount is included in administrative expenses.

6. **Plan Termination:**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the account balances of all participants would immediately vest.

7. **Tax Status:**

The Internal Revenue Service has determined, by letter dated March 31, 2017, that the adopted prototype plan was designed in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan had been amended since receiving the pre-approved plan document; however, the plan administrator believed the Plan was designed and being operated in compliance with applicable requirements of the IRC.

Effective July 1, 2023, the Plan was restated. The Internal Revenue Service has determined, by a letter dated March 21, 2017, that the adopted volume submitter plan was designed in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the pre-approved plan document; however, the plan administrator believed the Plan was designed and being operated in compliance with applicable requirements of the IRC.

Management has evaluated the effect of accounting guidance surrounding uncertain income tax positions and concluded that the Plan has no significant financial statement exposure to uncertain income tax positions at June 30, 2024 and 2023. The Plan is not currently under audit by any tax jurisdiction.

8. **Risk and Uncertainties:**

The Plan provides for various investments in money market and mutual fund accounts. Investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the financial statements.
