Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note H to the financial statements, is complete and accurate.

NOTE A - DESCRIPTION OF PLAN

The following description of Kisinger Campo & Associates Corporation ("Company") Savings Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan and trust covering employees of the Company. It was adopted on November 15, 1990 and subsequently amended. An amendment in 1999 provided for a discretionary profit-sharing component. Interns and part-time employees must have attained age 21 and have completed one year of eligibility service to be eligible to participate in the Plan. All other employees must have attained age 21 and have completed three months of service to be eligible to participate in the Plan. These requirements are applicable for discretionary contributions, salary reduction, and matching contributions. Additionally, employees receiving discretionary contributions must be employed at December 31.

The financial statements of Kisinger Campo & Associates Corporation Savings Plan are the representation of management and include estimates of amounts and judgments it believes are reasonable under the circumstances.

2. Contributions

Participants may contribute up to 90% of their compensation as 401(k) contributions up to the limits permitted by the Internal Revenue Code.

The Company makes matching contributions. The Company will match 50% of the participant's contribution. Participant contributions in excess of 10% of a participant's compensation are not matched by the Company. The Company added a profit-sharing segment to the Plan during fiscal year 1999, which allows the Company to make a discretionary contribution.

3. Participant Accounts

Each participant in the Plan has a separate account that is credited with the annual allocation of (a) the Company's contributions, (b) the employee's elective contributions, and (c) the Plan's earnings or losses.

4. Vesting

Participants vest in their Employer Contribution Account on a sliding scale based on their number of years of service.

NOTE A - DESCRIPTION OF PLAN - Continued

A participant is vested in employer matching contributions and discretionary contributions as follows:

One hundred percent vesting occurs, regardless of the number of years of service, when a participant reaches normal retirement age (65), meets the requirements for early retirement, dies, or becomes totally and permanently disabled.

5. Payment of Benefits

Benefit payments are made in the form of a single sum, annuity, or deferred status distribution. Upon normal retirement, death, or becoming permanently disabled, Plan participants will be entitled to 100% of their account balance. The participants will only be entitled to the vested portion of the employer contributions if employment is terminated for any reason other than those previously mentioned. Participants are entitled to 100% of the account balance of any salary reduction or voluntary contributions made on their own behalf.

6. Forfeitures

Forfeitures consist of matching contributions and are applied to reduce the Company's future matching contributions. The Plan had forfeitures from non-vested accounts of \$32,842 \$20,207 at December 31, 2024 and 2023, respectively.

7. Basis of Participant Contributions

Participants may elect to have the Company contribute to the Plan for any plan year during which they are participants, such amounts expressed in whole percentages of their compensation, that would otherwise be payable by the Company as compensation, subject to certain Internal Revenue Code limits.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the Plan's significant accounting policies applied in the preparation of the accompanying financial statements follows:

1. Basis of Accounting

The accounts of the Plan are maintained on the accrual basis, except for benefit payments, which are reported on the cash basis.

2. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein as well as the related disclosures. Actual results could differ from those estimates and such differences could be material.

3. Valuation of Investments and Income Recognition

The Plan's investments are reported at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds and separate accounts are valued at the net asset value ("NAV") of shares held by the Plan at year-end. The investment in the common/collective trust fund ("CCT") is stated at fair value, as determined by the issuer of the CCT based on the fair market value of the underlying investments.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Upon discontinuance of the contracts with T. Rowe Price Trust Company, the Plan would be paid in a single sum, the market value of the mutual funds and common/collective trusts as of the termination date.

4. Concentration of Credit Risk

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in the values of investment securities will occur in the near term.

It is also possible that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

5. Payment of Benefits

Benefits are recorded when paid.

6. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Participants may borrow monies from the Plan at an amount that does not exceed the lesser of \$50,000 or 50% of a participant's vested account balance.

NOTE C - FAIR MARKET VALUE MEASUREMENTS

The Plan's Investments are held by T. Rowe Price Trust Company at December 31, 2024 and 2023.

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements).

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

Mutual funds: Valued at the net asset value ("NAV") of shares held by the Plan at year end. Investments in certain restricted mutual funds are valued at quoted market prices of the issuer and are Level 1 measurements.

Common/collective trust: Valued at the quoted market price of the issuer or Level 2 measurements.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - PLAN TERMINATION

Although the Company has not expressed any intent to do so, it has the right under the Plan, to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

NOTE F - TAX STATUS

The trust established under the Plan to hold the Plan's assets is qualified, pursuant to the appropriate section of the Internal Revenue Code and, accordingly, the trust's net investment income is exempt from income taxes. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service and the Plan sponsor believes that the Plan continues to qualify and to operate as designed.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE G - PARTY-IN-INTEREST TRANSACTIONS

The Plan's assets are held by T. Rowe Price Trust Company and T. Rowe Price Retirement Plan Services, Inc. provides recordkeeping services for the Plan. Company contributions are managed by the administrator who invest cash received, interest and dividend income and make distributions to participants. Fees paid to the administrator of the Plan for investment management services amounted to \$49,111 and \$39,512 for the years ended December 31, 2024 and 2023, respectively. Administrative functions are also performed by officers or employees of the Company. No officer or employee receives compensation from the Plan. Expenses for the independent auditor fees were paid directly by the Company and administrative fees were paid by the Plan. Additionally, investment advisory fees of \$11,729 and \$60,913 were paid by the Plan for the years ended December 31, 2024 and 2023, respectively. Professional fees of \$0 and \$1,548 were paid by the Plan for the years ended December 31, 2024 and 2023, respectively.

NOTE H - CERTIFICATION

T. Rowe Price Trust Company has certified the Plan's investments and the related investment income and losses as being complete and accurate as of and for the years ended December 31, 2024 and 2023.

NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

NOTE J - COMMON/COLLECTIVE TRUST

The T. Rowe Price Stable Value Common Trust (the "Fund") is a common/collective trust sponsored by T. Rowe Price. The beneficial interest of each participant is represented by units. Units are issued and redeemed daily at the Fund's constant NAV of \$1 per unit. Distribution to the Fund's unit holders are declared daily from the net investment and automatically reinvested in the Fund on a monthly basis, when paid. It is the policy of the Fund to use its best efforts to maintain a stable NAV of \$1 per unit; although there is no guarantee that the Fund will be able to maintain this value.

Participants ordinarily may direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made to the Fund, plus earnings, less participant withdrawals and administrative expenses. The Fund imposes certain restrictions on the Plan, and the Fund itself may be subject to circumstances that affect its ability to transact at contract value, as described in the following paragraphs. Plan management believes that the occurrence of events that would cause the Fund to transact at less than contract value is not probable.

Limitations on the Ability of the Fund to Transact at Contract Value

Restrictions on the Plan - Participant-initiated transactions are those transactions allowed by the Plan, including withdrawals for benefits, loans, or transfers to noncompeting funds within a plan, but excluding withdrawals that are deemed to be caused by the actions of the Plan Sponsor. The following employer-initiated events may limit the ability of the Fund to transact at contract value:

- A failure of the Plan or its trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA
- Any communication given to Plan participants designed to influence a participant not to invest in the Fund or to transfer assets out of the Fund
- Any transfer of assets from the Fund directly into a competing investment option
- The establishment of a defined contribution plan that competes with the Plan for employee contributions
- Complete or partial termination of the Plan or its merger with another plan

NOTE J - COMMON/COLLECTIVE TRUST - Continued

Circumstances that Impact the Fund - The Fund invests in assets, typically fixed income securities or bond funds, and enters into “wrapper” contracts issued by third parties. A wrap contract is an agreement by another party, such as a bank insurance company to make payments to the Fund in certain circumstances. Wrap contracts are designed to allow the Fund to maintain a constant NAV and protect the Fund in extreme circumstances. In a typical wrap contract, the wrap issuer agrees to pay the Fund the difference between the contract value and the market value of the underlying assets once the fair value has been totally exhausted.

The wrap contracts generally contain provisions that limit the ability of the Fund to transact at contract value upon the occurrence of certain events. These events include:

- Any substantive modification of the Fund or the administration of the Fund that is not consented to by the wrap issuer
- Any change in law, regulation, or administrative ruling applicable to a plan that could have a material adverse effect on the Fund’s cash flow
- Employer-initiated transactions by participating plans as described above

In the event that wrap contracts fail to perform as intended, the Fund’s NAV may decline if the market value of its asset declines. The Fund’s ability to receive amounts due pursuant to these wrap contracts is dependent on the third-party issuer’s ability to meet their financial obligations. The wrap issuer’s ability to meet its contractual obligations under the wrap contracts may be affected by future economic and regulatory developments.

The Fund is unlikely to maintain a stable NAV if, for any reason, it cannot obtain or maintain wrap contracts covering all of its underlying assets. This could result from the Fund’s inability to promptly find a replacement wrap contract following termination of a wrap contract. Wrap contracts are not transferable and have no trading market. There is a limited number of wrap issuers. The Fund may lose the benefit of wrap contracts on any position of its assets in default in excess of a certain percentage of portfolio assets.
