Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Rich & Cartmill, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

Basis for Opinion

A. DESCRIPTION OF THE PLAN

The following description of the Rich & Cartmill, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Rich & Cartmill, Inc. (the Company) for the benefit of its employees. The Plan was originally adopted October 1, 2001, and has since been restated with an effective restatement date of October 31, 2018. Upon reaching the age of 18, employees are eligible to participate in salary deferral contributions and receive matching contributions after reaching three months of service. Participants may begin salary deferrals and receiving matching contributions on the first day of the calendar after meeting the eligibility conditions. Participants are eligible to receive the Company's profit-sharing contributions on the first day of the calendar month after they have completed one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Bank of Oklahoma serves as the trustee of the Plan.

Contributions

Each year, participants may contribute up to 100 percent of pre-tax annual compensation, as defined in the Plan, up to IRS maximum limits. Participants who are projected to be age 50 or older by the end of a calendar year may also make catch-up contributions. Employee rollover contributions are also permitted. The Company makes matching contributions of 100% of an employee's salary deferral amount up to 5% of the employee's eligible compensation. Company profit-sharing contributions are discretionary as determined by the Company's board of directors. In 2024, the Company made profit-sharing contributions of 8% of each participant's eligible compensation. Contributions are subject to certain limitations imposed by the Internal Revenue Code.

Participant Accounts

Investment account options available include various mutual funds. Each participant has the option of directing their contributions into any of the separate investment options and may change the allocation daily. Each participant's account is credited with the participant's contribution, the Company's contribution and earnings thereon, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Forfeitures

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are vested ratably over a five-year period that begins on their hire date in the Company's matching contribution and profit-sharing contribution portions of their accounts plus earnings thereon. Any forfeited amounts from benefits paid to participants from non-fully vested accounts are transferred to an unallocated forfeitures account to be used to reduce future Company contributions or pay the Plan's expenses, at the sole discretion of the Company. During the year ended December 31, 2024, forfeitures totaled \$23,829. During 2024, the Plan utilized \$17,511 of forfeited amounts to reduce Company contributions and Plan expenses. At December 31, 2024 and 2023, unallocated funds totaled \$6,497 and \$180, respectively.

A. DESCRIPTION OF THE PLAN (CONTINUED)

Notes Receivable from Participants

Active, eligible participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the vested balance in the participant's account and bear interest based on local prevailing rates available as determined by the plan administrator. Once the loan is granted the interest rate on the loan will not change. Principal and interest is paid ratably through semi-monthly payroll deductions, over a term not to exceed five years (except for loans used for the purchase of a principal residence).

Payment of Benefits

Upon termination of service or reaching normal retirement age, an employee may elect to receive either a lump-sum amount equal to the value of their account or to roll over the amount to another retirement plan (if the account balance is greater than \$1,000). If the account balance is between \$1,000 and \$5,000, and the employee does not make this election, their distribution will automatically be rolled over to a qualified Individual Retirement Account (IRA). If the account balance is less than \$1,000, the distribution will automatically be paid out in a lump-sum payment.

Plan Termination

Although it has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

B. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments include the plan's gains and losses on investments bought and sold as well as held during the year.

B. SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

Notes Receivable from Participants

Loans are valued at their unpaid principal balances, plus any accrued but unpaid interest. Interest income is recognized over the life of the loan based on the stated interest rate. If any scheduled payment remains unpaid beyond the last day of the calendar quarter following the calendar quarter in which the participant missed the schedule payment, the loan shall be in default and will be treated as a taxable distribution.

Excess Contributions Payable

As of December 31, 2023, amounts payable to the Company totaling \$56,390, resulting from an error, are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Subsequent Events

Subsequent events have been evaluated through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

C. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Bank of Oklahoma has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, notes receivable from participants, and amounts due to broker as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment activity and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024;
- Investment information included in the footnotes as of December 31, 2024 and 2023 and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

D. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits.

Accounting Standards Codification Topic 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

Level 1 Fair Value Measurements

Fair values are based on quoted market prices in active markets for identical issues that the plan has the ability to access at the measurement date. The Plan's Level 1 investments include mutual funds valued based on quoted prices for identical assets on the measurement date.

Level 2 Fair Value Measurements

Fair values are based on inputs other than quoted market prices included within Level 1 that are observable for valuing the asset, either directly or indirectly. Observable inputs include quoted prices for similar assets in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs. The Plan does not hold any Level 2 investments.

Level 3 Fair Value Measurements

Fair values are based on unobservable inputs used for valuing the asset. Unobservable inputs are those that reflect the plan's own assumptions about assumptions that market participants would use in pricing the asset, based on the best information available in the circumstances. The Plan does not hold any Level 3 investments.

E. TAX STATUS

The Plan operates under a volume submitter profit sharing plan with CODA sponsored by Bank of Oklahoma. The IRS advised on September 30, 2014, that the form of the volume submitter plan was acceptable under Section 401 of the IRC. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

Generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is no longer subject to income examination for years prior to 2021.

F. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. The ongoing fluctuation of interest rates and tariff policies, and international military conflict have resulted in substantial volatility in financial markets. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

G. PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan incurs expenses related to general administration, record keeping and trust administration. These expenses and certain accounting and auditing fees related to the Plan are paid by the Company. The Company does not expect reimbursement from the Plan for these services. Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

Certain Plan investments are held in funds of the Plan trustee. Therefore, these transactions qualify as party-in-interest transactions. The Plan paid \$33,066 of recordkeeping fees to the trustee during the year ended December 31, 2024. Certain fees paid by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment.
