## INDEPENDENT AUDITOR'S REPORT

Wasatch Advisors, LP Deferred Profit Sharing Plan and Trust Retirement Committee:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Wasatch Advisors, LP Deferred Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### (1) Description of the Plan

The following description of the Wasatch Advisors, LP Deferred Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the summary plan description or the plan agreement for a more complete description of the Plan's provisions.

#### (a) *General*

The plan is a defined contribution plan covering all full-time employees of the Company who are 21 or older, except union employees, leased employees, interns, employees of an affiliated employer who does not adopt the plan and independent contractors. The Plan, which was adopted effective November 21, 1983, is provided for eligible employees of Wasatch Advisors, LP (the Employer) and is a participant-directed plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Audit Committee is responsible for oversight of the Plan. The Retirement Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Audit Committee.

#### (b) *Contributions*

Participants may elect to contribute up to 75% of their pretax or after-tax annual compensation each year as defined by the Plan. Participant contributions are limited annually by Internal Revenue Service guidelines to \$23,000 in 2024. Employees who are 50 or older may also make "catch-up" contributions of up to \$7,500 in 2024. Eligible employees may also, subject to provisions of the Plan, contribute amounts representing distributions from other qualified plans (participant rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, money market funds, collective investment trust, or personal choice retirement accounts as investment options for participants. Employee contributions are deposited into the investment options selected on a semi-monthly basis.

The Employer matches 100% of employee contributions up to a uniform percentage as determined by the Employer of the employees' total compensation, for all employees that have completed two years of service and are actively employed on the last day of the Plan year. For the years ended December 31, 2024 and 2023, the uniform percentage elected was 5%. The Employer match was \$1,107,068 and \$1,032,452 for the years ended December 31, 2024 and 2023, respectively. The Employer may also make a discretionary profit sharing contribution to employees that have completed two years of service and are actively employed on the last day of the Plan year. For the years ended December 31, 2024 and 2023, the profit sharing contribution was 6% of compensation plus 5.7% of compensation in excess of the Social Security wage base for the year. The Employer profit sharing contribution was \$1,981,557 and \$1,832,522 for the years ended December 31, 2024 and 2023, respectively. Employer matching and profit sharing contributions are deposited to participant accounts on an annual basis. Contributions are subject to certain IRS limitations.

**(c) Participant Accounts**

Each participant's account is credited with the participant's contributions and company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**(d) Administrative Expenses**

Certain expenses of the maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Investment related expenses are included in net appreciation/depreciation of fair value of investments.

**(e) Distributions**

On termination of service due to death, disability, retirement or upon attainment of age 59 1/2, a participant may elect to receive either a lump-sum amount equal to the value of the participants vested interest in his or her account, an annuity in monthly, quarterly, semi-annual or annual installments for a certain period or a rollover to another qualified plan. Hardship withdrawals are allowed subject to certain restrictions.

**(f) Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participants account and bear an interest rate of 3.25% to 8.50% for the years ended December 31, 2024 and 2023, which is commensurate with that charged by a bank or other professional lender making a loan in similar circumstances. The loan term may be no more than five years, except if the loan is made for the purchase of the participant's principal residence. In this case, the loan term may be up to 10 years. Principal and interest is paid ratably through semi-monthly payroll deductions.

**(g) Vesting**

Participants are immediately 100% vested in their contributions, employer match and profit sharing contributions and actual earnings thereon.

**(h) Forfeited accounts**

At December 31, 2024 and 2023, there were no forfeited nonvested accounts. Balances in these accounts are used to reduce future employer contributions.

**(i) Unallocated accounts**

At December 31, 2024 and 2023, there were no unallocated accounts. Balances in these accounts are used to reduce future employer contributions.

#### **(2) Significant Accounting Policies**

##### **(a) Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### **(b) Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **(c) Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See note (5) for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **(d) Contributions**

Contributions from plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

##### **(e) Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as transaction fees and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### **(f) Payment of Benefits**

Benefits are recorded when paid.

**(g) *Contributions Receivable and Current Expected Credit Losses***

Historical write-off rates continue to be the basis for the Company's allowance for current expected credit losses. To calculate the reserve, the Company considered the processes surrounding the contributions receivable since the inception of the Plan. The Company has not historically written off the contributions receivables that were accrued at Plan year-end. The Company expects business conditions for the Plan calendar year ended December 31, 2025, the collection period for the contributions receivables, to remain consistent with current conditions. As a result, the Company has recorded expected credit losses of \$0 as of December 31, 2024 and 2023.

**(h) *Subsequent Events***

The Plan has evaluated subsequent events through September 19, 2025, the date the financial statements were available to be issued.

#### (5) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

##### *Level 1*

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

##### *Level 2*

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

#### *Level 3*

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds and money market funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective investment trust:* Valued at fair value based on the investment's net asset value per unit. In accordance with fair value measurements and disclosure guidance, the collective trusts are reported at the net asset value per unit as a practical expedient. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

*Self-directed brokerage accounts:* Accounts primarily consist of bonds, cash, certificates of deposit, common stock, and exchange traded funds that are valued on the basis of readily determinable market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### (6) Income Tax Status

On June 30, 2020, the Internal Revenue Service (IRS) stated in an opinion letter that the prototype basic plan document adopted by the Plan, as then designed qualifies under the provisions of Section 401(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself, however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to related income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. Federal and State of Utah taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **(7) Party-in Interest Transactions**

Certain plan investments are shares of mutual funds managed by the Company. The Company receives management fees related to these funds. The Company is the Plan Administrator as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions.

Certain plan investments are shares of mutual funds managed by Fidelity Trust Company. Fidelity is the trustee of the Plan's assets as defined by the plan and, therefore, these transactions qualify as party-in-interest transactions.

### **(8) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### **(9) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
