We have performed audits of the financial statements of Global Association of Risk Professionals Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 - DESCRIPTION OF PLAN

The accompanying financial statements and supplemental schedule are those of the Global Association of Risk Professionals Inc. 401(k) Plan (the "Plan"), and the brief description of the Plan contained herein is provided solely for purposes of general information, and interested persons should refer to the Plan agreement for a more complete description of the Plan provisions.

General

The Plan is a defined-contribution plan covering all employees of Global Association of Risk Professionals Inc. (the "Company" or "Plan Sponsor"). The Plan was established effective June 1, 2003 and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Effective April 1, 2022, the Plan was amended and restated to reflect certain statutory changes, but there were no significant changes to the Plan provisions as a result of the restatement. The custodian and trustee of the Plan's assets is Reliance Trust Company ("Reliance"). ADP, LLC ("ADP") acts as the Plan's recordkeeper. The Plan Administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Eligibility for Participation

Participants are eligible to participate in the Plan after they have completed three months of service. If a participant has completed one hour of service in a month, they are credited with a full month of service.

Contributions

Eligible participants may elect to make pre-tax and/or Roth contributions to the Plan through payroll deductions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. For 2024, the Internal Revenue Service ("IRS") has set the contribution limitation amount of \$23,000, with a maximum catch-up of \$7,500 for eligible employees.

The Company contributes on behalf of each participant an amount equal to 100% of the first 5% of compensation that a participant contributes to the Plan ("Matching contributions").

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's Matching contributions, as well as an allocation of plan earnings. Allocations are based on participant's earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and Matching contributions plus actual earnings thereon. Nonelective employer contributions to the Plan and any earnings that they generate become 100% vested upon completion of three years of service. For the years ended December 31, 2024 and 2023, there were no nonelective employer contributions made to participants.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have one outstanding loan at a time

and loans are repayable over a period of up to five years, unless the proceeds are used to purchase a primary residence in which case it can be up to 30 years. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 2% above the prime rate, as defined. Principal and interest are paid ratably through semi-monthly payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution, substantially equal installments, or partial withdrawals. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. The Plan also allows for in-service distributions of the participant's vested accounts upon reaching the age of 59½ or due to hardships, as defined in the Plan agreement.

Forfeited Accounts

Forfeitures by non-vested participants may be used to pay for plan expenses or used to reduce future Company contributions. As of December 31, 2024 and 2023, there were no forfeited non-vested accounts, and no forfeitures were used to pay plan expenses or reduce Company contributions during the year ended December 31, 2024.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default based on the provisions of the Plan, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distribution fees from withdrawals are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance, the trustee of the Plan's investments, has certified that the following information in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Investment income and interest income received on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the (Level 2) input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds (Registered Investment Companies) - are valued by obtaining quoted prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The Plan's mutual funds are considered to be Level 1 securities.

Interest-bearing Cash - an investment in a short-term money market fund that is valued at \$1 per share, which approximates fair value and is considered to be a Level 1 investment.

Collective Trusts - collective trusts represent investments with investment manager. Units held in common collective trusts are valued at the NAV reported by their investment managers. The NAV is used as a practical expedient to estimate fair value. There is no redemption notice period associated with the Plan's NAV investments as they are part of participant directed accounts that can be traded daily and there are no unfunded commitments.

NOTE 5 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan permits notes receivable from participants. These transactions qualify as party-in-interest transactions. Fees paid to Reliance and ADP are included as part of the administrative expenses and qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 7 - TAX STATUS

The Plan adopted the Automatic Data Processing Non-Standardized Defined Contribution Pre-Approved Plan. The IRS has determined and informed ADP, by a letter dated October 6, 2020, that the pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code (the "Code"). Accordingly, the Plan has been accounted for as a qualified Plan and the related trust is tax exempt. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through August 21, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan's trustee was changed from Reliance to ADP Retirement Trust Services, LLC ("ADPRTS"). ADPRTS is a wholly owned subsidiary of ADP. The transition of trustee responsibilities is not expected to have a material impact on the Plan's financial statements.
