Basis for Opinion

We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following is a brief description of the Carestream Dental Retirement Savings Plan (the Plan) provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan as permitted under Section 401(k) of the Internal Revenue Code (IRC), covering eligible employees of Carestream Dental, LLC (the Company and Plan Sponsor). The Plan is funded by employee and employer contributions. At December 31, 2024 and 2023, the assets of the Plan were maintained in investment funds held by T. Rowe Price Trust Company. The Plan is intended to conform to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent legislation, where applicable.

Eligibility

All employees of the Company, other than those specifically excluded per the terms of the Plan Document, are eligible to participate in the plan upon hire.

Contributions

Generally, newly eligible employees are automatically enrolled and deemed to make salary reduction contributions of 4% of eligible compensation, which will remain in effect from year to year until an affirmative elective is otherwise made. Participants may authorize a pre-tax elective deferral contribution up to 75% of earnings or the maximum annual limitations as provided by the IRC. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company makes safe harbor matching contributions of 100% of the participant's contribution up to 4% of compensation that a participant contributes to the Plan. Additional amounts may be contributed at the option of the Company. There were no additional amounts contributed by the Company for the years ended December 31, 2024 and 2023.

Participants direct the investment of employee and employer contributions into various investment options offered by the Plan. Participants can access additional investments through self-directed brokerage accounts. Participants may change their investment allocation on a daily basis.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocation of (a) the Company's contributions (b) plan earnings and losses, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (Continued)

Administrative Expenses

A significant portion of the costs of administering the Plan are borne by the Company, with the remainder paid out of the assets of the Plan.

Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum amount, which is the lesser of \$50,000 or 50% of their vested account balance. The number of loans outstanding is limited to one per participant. Loan terms range from one to five years, but may exceed five years for the purchase of a primary residence. The loans are collateralized by the balance in the participant's account and bear interest at the prime rate. Principal and interest are paid ratably through payroll deductions.

Benefits Paid to Participants

Unless a participant elects otherwise, distributions are made as soon as practical after the participant's normal retirement date or actual retirement date occurs. The normal retirement date is the date upon which the participant reaches age 65.

Participants may also receive hardship withdrawals and in-service distributions under certain circumstances, as defined in the Plan Document.

Participants may receive their accumulated vested benefits held by the Plan's trustee upon termination of employment or elect to keep their vested balance in excess of \$1,000 in the Plan. If the participant elects to keep his or her vested interest in the Plan, the participant's account will continue to receive its share of earnings and losses.

Vesting

Participants are immediately 100% vested in their elective deferral contributions and Company matching contributions.

Administrative Budget and Fee Credits Accounts

The Plan has an administrative budget account that is funded with revenue generated by certain investments held by the Plan. The revenue generated by the investments (typically in the form of rebates or paybacks for using the fund) is shared with the recordkeeper. These funds may be used to pay Plan expenses or be distributed to each participant. The excess revenue earned by the Plan during 2024 and 2023, respectively, amounted to \$20,337 and \$20,119 and is included in other income on the statement of changes in net assets available for benefits. During 2024 and 2023 respectively, \$16,500 and \$30,119 of Plan expenses were paid from the administrative budget account. The unused balance of this account amounted to \$9,196 and \$5,359 as of December 31, 2024 and 2023, respectively.

Certain investments in the Plan provide the recordkeeper with administrative fee payments. Participants invested in one of these investment options become eligible to receive credits to their account on a quarterly basis based on the administrative fee payment amounts. At December 31, 2024 and 2023, \$143,281 and \$126,653, respectively, was funded into the account. The total amount plus earnings was subsequently distributed to eligible participants.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan prepares its financial statements on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Valuation of Investments

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold or held during the year.

Payment of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Income Taxes

The Internal Revenue Service has determined and informed the Trustee by a letter dated August 19, 2020, that the Prototype Plan and related Trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the accompanying financial statements.

Risks and Uncertainties

The Plan's assets include various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to the value of such investments, changes in the values of investments will occur and such changes could materially affect the amounts reported in the accompanying financial statements.

3. FINANCIAL CERTIFICATION

The following financial information relating to the Plan's assets at December 31, 2024 and 2023, as well as investment income and investment transactions for the years then ended, has been derived from information provided by T. Rowe Price Trust Company, the Trustee of the Plan, and has been certified by them as complete and accurate.

4. FAIR VALUE MEASUREMENTS

The Plan uses various valuation techniques in determining fair value. ASC Section 820 established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Section 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

4. FAIR VALUE MEASUREMENTS (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in valuation methodologies in 2024 or 2023.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Values are determined based on quoted market prices in active markets.

Common collective trust: Valued at Net Asset Value ("NAV") based on the underlying assets of the trust. The fund seeks to provide maximum current income while maintaining stability of principal. The fund invests primarily in a portfolio of Guaranteed Investment Contracts, Bank Investment Contracts, Synthetic Investment Contracts and Separate Account Contracts, which are designed to provide stability and a competitive yield. NAV is obtained from information provided by the investment advisor using the audited financial statements of the common collective trust funds at year end. The fund seeks to preserve the value of \$1.00 per unit. There are no unfunded commitments or redemption restrictions.

Brokerage account: Brokerage account consists of mutual funds, the values of which are determined based on quoted market prices in active markets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.
