### Opinion

We have audited the accompanying financial statements of the Theatrical Stage Employees Health & Welfare Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and its benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.

## Notes to Financial Statements

### Note 1 – Description of the Plan

The following description of Theatrical Stage Employees Health & Welfare Trust (the Plan) provides only general information. Participants should refer to the trust agreement for a more complete description of the Plan's provisions.

- a. **General** – The Plan provides health, dental, short-term disability, and life and accidental death and dismemberment benefits covering eligible employees of contributing employers. Certain plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.
- b. **Benefits** – The Plan provides for health benefits (hospital, medical, surgical, and major medical), dental benefits, vision benefits, short-term disability, and life and accidental death and dismemberment insurance covering those participants who have met the eligibility requirements. The Plan also provides health, dental, and life insurance benefits to certain participants if they have accumulated credit amounts (expressed in hours) in excess of hours required for current coverage. Accumulated eligibility credits of up to six months coverage may be carried forward. The Plan has insurance contracts with Kaiser Permanente, Delta Dental of Washington, Sun Life Financial, and Vision Service Plan.

Initial eligibility requires 180 accumulated hours within two consecutive months. For continuing eligibility, an employee must have at least 90 hours in his or her bank. The maximum hour bank accumulation allows only six months of reserves, with an hour requirement of 540 hours.

- c. **Contributions** – The plan agreement provides that the contributing employers, under the collective bargaining agreement, make contributions to the Plan based on a percentage of gross salaries. A participant may contribute specified amounts, determined by the plan consultant, to extend coverage to eligible dependents of the participant or extend coverage under the Consolidated Omnibus Budget Reconciliation Act (COBRA).
- d. **Administration** – The Plan is administered by a Board of Trustees that is assisted by a contract administration organization. Administrative expenses are borne by the Plan.

### Note 2 – Summary of Significant Accounting Policies

A summary of the Plan's significant accounting policies applied in the preparation of the accompanying financial statements follows:

- a. **Basis of accounting** – The financial statements of the Plan are prepared on the accrual basis of accounting.
- b. **Investment valuation and income recognition** – Investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment adviser and custodian.

## Notes to Financial Statements

### Note 2 – Summary of Significant Accounting Policies (Continued)

- b. **Investment valuation and income recognition (continued)** – Purchases and sales are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.
- c. **Premiums** – Premiums due to insurers are recorded based upon eligibility earned during the year as they relate to the eligibility formula of the Plan and actual payments subsequent to year end.
- d. **Payment of claims** – Claims are recorded when paid by the Plan.
- e. **Contributions** – Contributions from employers are accrued based upon months worked during the year by covered employees.
- f. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.
- g. **Accumulated eligibility credits** – Plan obligations for accumulated eligibility of participants as of December 31, 2024 and 2023, were estimated based on the current hour bank of each participant and the current premium rate in effect.
- h. **Subsequent events** – Subsequent events were evaluated through August 26, 2025, the date the financial statements were available to be issued.

### Note 3 – Tax Status

The VEBA trust funding certain benefits for the Plan received an exemption letter from the Internal Revenue Service (IRS) dated December 31, 1970, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 or 2023 for unrelated business taxable income.

In addition, the Plan and trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 4 – Plan Termination

Although it has not expressed any intent to do so, the Board of Trustees has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

Upon the termination of the trust agreement, the Trustees shall conclude the affairs of the trust fund. Where the termination occurs as a result of a merger, as authorized by Article VIII, Section 28, any and all monies and assets remaining in the trust fund, after payment of expenses, shall be transferred to the trust fund with which the merger has been negotiated. With respect to any other termination, any and all monies and assets remaining in the trust fund, after the payment of expenses, shall be used for the continuance of the benefits provided by the then-existing benefit plans, until such monies and assets have been exhausted, unless some other disposition is required in regulations of the Secretary of Labor. In no event shall any of the remaining monies or assets be paid to or be recoverable by any participating employer, association, or labor organization.

### Note 5 – Fair Value Measurements

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### Note 5 – Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Level 1* – The fair value of the money market fund, equity mutual funds, and fixed income mutual funds are based on quoted net asset values of the shares held by the Plan at year end. Cost approximates fair value for cash equivalents.

*Level 2* – The U.S. government securities and corporate bonds are valued by independent third-party pricing agents using either a quoted price in an active market for the identical security, or direct and/or indirect observable inputs for the security. Observable inputs include reported trades (where applicable), benchmark yields, dealer quotes, issuer spreads, bids, offers, benchmark securities, and others.

*Level 3* – The Plan has no investments that are classified as Level 3 for the years ended December 31, 2024 or 2023.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 6 – Accumulated Eligibility Credits

The Plan is required to provide benefits to certain members if such members have accumulated credit amounts (expressed in hours) in excess of hours required for current coverage. Under the Plan, accumulated credits of up to six months coverage may be carried forward. The accumulated eligibility credits (expressed in dollars) at December 31, 2024 and 2023, as a result of hours processed for the month of December and prior, are \$1,625,600 and \$1,630,000, respectively.
