Note 1 - Description of Plan

The following description of the Wish Farms 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Wish Farms 401(k) Plan was established effective January 1, 1998 as a defined contribution plan covering eligible employees of Wish Farms, LLC and certain of its related companies that are adopting employers. The Plan covers all employees immediately upon employment. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The 401k committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings. As of January 1, 2019, the plan was converted to a Prototype Non-Standardized Profit Sharing Plan with CODA. As of January 1, 2022 it was amended to include required provisions related to the SECURE, CARES, Consolidated Appropriations Acts, and IRS regulations.

Contributions: Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company must make safe harbor matching contributions of 100% of employee elective deferrals up to 3% of compensation and 50% of elective deferrals up to the next 2% of compensation. The Company may also make discretionary matching and profit sharing contributions, as determined by its board of directors. The Company made no such contributions for 2024. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions and the Company's safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contributions plus actual earnings is based on years of continuous service. A participant is 100% vested after six years of credited service or upon normal retirement age, death or retirement due to disability.

Notes receivable from participants: Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1-5 years or up to 25 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at prevailing rates at the time of application. Principal and interest are paid ratably through payroll deductions. Interest rates on loans ranged from 3.25% to 8.50%.

Forfeited accounts: The employer may decide in its discretion how to treat forfeited non-vested employer contributions. There were no forfeited non-vested accounts at December 31, 2024 and 2023.

Note 1 - Description of Plan (Continued)

Payment of benefits: A participant with an account balance of \$5,000 or less receives his/her account balance in a lump sum distribution immediately upon retirement or termination of employment. Upon termination, retirement, disability or reaching age 59½, a participant with an account balance greater than \$5,000 may elect to receive his/her account balance in a lump sum distribution or installment payments. Generally, the Plan must begin minimum distributions of the vested balances of participants reaching age 74. If a participant dies, a death benefit equal to their account balance is paid to the participant's beneficiary.

Note 2 - Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Investment valuation and income recognition: Investments are reported at fair value, except for the fixed account, which is measured at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Contributions: Contributions from Plan participants are recorded in the year the Company makes the payroll deductions from the participants' wages. Any corresponding contributions from the Company are recorded in the same year. Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability, with a corresponding reduction to contributions.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: The Company absorbs some of the cost of maintaining and administering the Plan and such costs are excluded from these financial statements. Third-party administrator fees and record keeper fees associated with certain participant transactions are paid from Plan assets. Fees associated with certain participant transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 3 - Certified Investments

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023 and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, a qualified institution.

The Fixed Income Guaranteed Option is part of the general account assets of Principal Life Insurance Company and provides a guaranteed interest rate for a set period of time. A surrender charge may apply to transfers or withdrawals from an unmatured Fixed Income Guaranteed Option investment.

Note 4 - Fixed Income Guaranteed Option

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal). Principal maintains the contributions in the Fixed Income Guaranteed Option account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The crediting rate is based on a formula established by the contract issuer but may not be less than 0.05%. The crediting rate is reviewed on a semiannual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may cause the Fixed Income Guaranteed Option to not transact at contract value. Such events include but may not be limited to the following: (1) temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by or under other common control with the employer; (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the plan sponsor's business; (5) removal from the plan of one or more groups or classifications of participants; (6) partial or complete plan termination; or (7) plan disqualification. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

Note 5 - Fair Value Measurements

The framework in FASB ASC 820, *Fair Value Measurements*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets, (2) quoted prices for identical or similar assets in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are considered level one investments.

Common/Collective trust funds are valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The common/collective trusts are considered level one investments.

Note 6 - Related Party and Party In Interest Transactions

Orenda Retirement, LLC serves as the third-party administrator and record keeper for the Plan and transactions with them qualify as party-in-interest transactions. Commissions and service fees paid to the record keeper by the Plan were \$47,048 for 2024.

Note 6 - Related Party and Party In Interest Transactions (continued)

Principal Trust Company serves as the custodian for the Plan and transactions with them qualify as party-in-interest transactions. Commissions and service fees paid to the custodian by the Plan were \$5,775 for 2024.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

Note 8 - Tax Status

The Internal Revenue Service has determined and informed Principal Life Insurance Company by a letter dated December 31, 2018 that the Non-Standardized Pre-approved Profit Sharing Plan With CODA adopted by the Plan is designed in accordance with applicable sections of the Internal Revenue Code. The Plan has not applied for its own determination letter from the Internal Revenue Service. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain positions that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by the U.S. Department of Labor and Internal Revenue Service; however, there are currently no audits for any tax periods in progress.

Note 9 - Risks and Uncertainties

The Plan invests in various securities that are exposed to interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in their fair values will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the financial statements.

Note 10 – Subsequent Events

The plan has evaluated subsequent events through September 22, 2025, the date the financial statements were available to be issued.
