Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of McCormick Barstow 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of McCormick Barstow 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 

Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of McCormick Barstow 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of McCormick Barstow 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1 – Description of Plan

The following description of McCormick Barstow 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of Plan provisions.

General – The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all employees and partners of McCormick, Barstow, Sheppard, Wayte & Carruth, LLP, and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). McCormick, Barstow, Sheppard, Wayte & Carruth, LLP (the Firm), is the Plan’s sponsor and serves as Plan administrator.

Eligibility – Full-time employees and partners are eligible to participate in the Plan upon reaching age 21 and after completing 12 consecutive months of service. Eligible employees and partners may elect to participate on January 1 or July 1 after meeting eligibility requirements. Participants may make changes to their deferrals as of any pay period with at least 10 days’ advance notice.

Contributions

Participant contributions – Each year, participants may contribute between 1% and 100% of pretax annual compensation, as defined in the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Employer matching contributions – The Company may elect to make discretionary matching contributions to the Plan. The matching contribution is made as a percentage of a participant’s salary deferral and can be capped at a specific percentage of compensation or at a specific dollar amount. For the year ended December 31, 2024, the matching contribution was dollar-for-dollar up to 2% of compensation. The matching contribution for the year ended December 31, 2024, was \$405,375.

Employer profit sharing contributions – The Company may elect to make discretionary profit sharing contributions to the Plan. For the year ended December 31, 2024, the discretionary profit sharing contribution was equal to 4% of the participant’s eligible compensation. The discretionary profit sharing contribution for the year ended December 31, 2024 was \$1,734,390.

Employer nonelective safe harbor contributions – The Company makes nonelective safe harbor contributions equal to 3% of the participant’s eligible compensation, regardless of the employee’s hours of service or employment on the last day of the plan year. The nonelective safe harbor contribution for the year ended December 31, 2024, was \$648,294.

Contributions are subject to regulatory limitations.

Participant accounts – Each participant’s account is credited with the participant’s contributions, employer contributions, Plan earnings, and an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment election – Each participant may invest his/her account in any of the investment choices offered by the Plan. Investment choices offered by the Plan consist of various investment types offered by the Plan's recordkeeper, Empower Retirement, LLC (Empower). If an investment election is not made, the Plan trustees will invest contributions in the default investment, which is currently a target retirement date fund. Investment elections may be changed daily.

Self-directed brokerage accounts – A participant may elect to invest in assets through a self-directed brokerage account. Once set up, amounts are deposited to a money market account, after which the participant is responsible for further investment of the funds. The Plan does not provide a participant electing to self-direct with investment information, and will assess a quarterly administrative fee, depending on the account balance. Additional fees may be charged pursuant to the self-directed brokerage account agreement.

Vesting – Participants are vested immediately in their contributions, including rollovers, plus actual earnings thereon. A participant's matching and nonelective (safe harbor) funds are fully vested at all times. Vesting in the Firm's profit sharing contributions is based on years of continuous service. Participants who attain normal retirement age of 62, or terminate employment due to death or disability, become fully vested. A participant is 100% vested after six years of credited service.

Notes receivable from participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are allowed a maximum of two outstanding loans at a time. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed 20 years. All loans bear an interest rate, which is 2% over the prime rate as established by the Wall Street Journal on the date of the loan. Principal and interest are paid ratably through monthly payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans ranged from 5.25% to 10.50% with various maturities through July 2043.

Payment of benefits – Upon separation from the Firm, participants with vested account balances of \$1,000 or less will receive a lump-sum payment. Participants with vested account balances of \$1,001 to \$5,000 are automatically rolled over to an Individual Retirement Account (IRA) unless otherwise directed. Participants with vested balances in excess of \$5,000 will receive their vested account balance in the form of a qualified joint and survivor annuity or a life annuity, unless an alternative form (such as a lump-sum or installment payment) is elected.

In-service withdrawals – A participant cannot receive a distribution from the Plan unless employment is terminated, with the following exceptions: hardship (see below); age 60 or older and account is fully vested; partial withdrawal at age 62; and active military duty.

Hardship withdrawals – Hardship withdrawals are allowed on a case-by-case basis with evidence of need as determined by the Plan sponsor. Participants who receive a hardship withdrawal are prohibited from making elective deferrals to the Plan for a period of six months.

Forfeitures – Forfeitures of nonvested accounts are used to pay for certain administrative costs of the Plan in accordance with the provisions of the Plan. During the year ended December 31, 2024, no forfeitures were used to pay for administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$149,506 and \$108,369, respectively.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – Investments are reported at either fair value, face value, contract value, or cash surrender value. Some of these investment values are certified by the Plan's trustee, Empower Trust Company. See Note 3 for information certified by the trustee and Note 5 for discussion of fair value measurements.

Investments in common stock, registered investment companies (mutual funds and money market funds), corporate bonds, and notes receivable are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (the "exit price") in an orderly transaction between market participants at the measurement date.

Units held in collective trusts (CTs), unit investment trusts, and limited partnerships qualifying as investment companies (LPs) are valued using the net asset value practical expedient (NAV practical expedient) as fair value, as reported by the fund managers. The NAV practical expedient is based on the fair value of the underlying assets owed by the fund, minus its liabilities, and then divided by the number of units outstanding.

Investments in cash equivalents, deferred annuity contracts, and life insurance are not valued at fair value, but instead are valued at either face value or contract value.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Contributions – Contributions from participants and corresponding matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of benefits – Benefits are recorded when paid.

Administrative expenses – Certain administrative functions are performed by partners or employees of the Firm. No such partner or employee receives compensation from the Plan. The Firm may pay the cost of annual administrative expenses, such as recordkeeping services; legal and accounting fees; preparation of annual reports; annual audit; and similar expenses. These are considered exempt party-in-interest transactions. Investment and advisory fees are paid directly by the Plan to the third-party administrator who is also a party-in-interest.

Individual account expenses – In addition to the above, individual participant accounts are charged with additional fees, such as loan fees (for initiation and set-up, and annual loan maintenance), and quarterly fees to maintain a self-directed brokerage account. Accounts may also be charged with other expenses, such as: installment payment set-up charges, expenses to evaluate a domestic relations order, expenses to process a payment pursuant to a qualified domestic relations order, fees to process an in-service distribution, fees to process a termination distribution, fees to process a required minimum distribution, search fees for a “lost” participant, fees to maintain an account post-termination, or overnight mailing charges.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan’s financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits, but arose after the statement of net assets available for benefits date, and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through August 29, 2025, which is the date the financial statements were available to be issued.

Note 5 – Fair Value Measurements and Valuations

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Common stock – Valued at the closing price reported on the active market on which the individual securities are traded.

Registered investment companies (mutual funds and money market funds) – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

Real estate investment trust – Valued at the closing price reported on the active market on which the individual real estate investment trusts are traded.

Corporate bonds – Valued using pricing models maximizing the use of observable inputs for similar securities, which includes basing value on yields currently available on comparable securities of issuers with similar credit ratings. When quoted prices are not available for identical or similar bonds, those corporate bonds are valued under a discounted cash flow approach that maximizes observable inputs, such as current yields or similar instruments, but includes adjustments for certain risks that may not be observable, such as credit and liquidity risks.

Notes receivable – Valued based on amortized cost, or original cost plus accrued interest.

Unit investment trusts – Units held in unit investment trusts (UIT) are valued using the NAV practical expedient of the UIT as reported by the UIT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the UIT, minus its liabilities, and then divided by the number of units outstanding.

Collective trusts – Units held in collective trusts (CT) are valued using the NAV practical expedient of the CT as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding.

Limited partnership – Units held in limited partnerships (LP) are valued using the NAV practical expedient of the LP as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the LP, minus its liabilities, and then divided by the number of units outstanding.

- (a) The purpose of the fund is to provide a vehicle for collective investment and reinvestment in a portfolio of securities and other financial instruments having fixed income characteristics, including, but not limited to, guaranteed investment contracts, security-backed contracts, certificates of deposit, obligations fully guaranteed by the United States as to principal and interest, and money market funds, with the objectives of preserving capital and maintaining a stable level of return with low volatility. Wells Fargo reserves the right to require a 12-month notice of withdrawal of assets from the fund for withdrawal of assets initiated by the sponsor or fiduciary.
- (b) The limited partnership manages a portfolio of ETFs (exchange-traded funds) and uses a low-risk covered call writing strategy to help offset expenses, dampen volatility, and generate additional income. The investment objective of the partnership is to provide investors with tax-efficient, equity-like returns with substantially lower risks than the S&P's 500 Index. The partnership does not invest in mutual funds, individual stocks, securities that do not track an index, or securities traded only on foreign securities exchanges.
- (c) The unit investment trusts offer fixed portfolios of stocks and bonds, with the objectives of providing capital appreciation and/or dividend income.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6 – Tax Status

The Internal Revenue Service has determined and informed the Firm by a letter dated April 9, 2018, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statements of net assets available for benefits. At times, the balance of cash equivalents may be in excess of insured limits.

Note 8 – Party-in-Interest Transactions

The Plan paid expenses related to the Plan's operations and investment management to various service providers. Certain Plan investments are managed by Empower Retirement. Empower Retirement is the recordkeeper of the Plan and transactions with this entity qualify as exempt party-in-interest transactions.

Note 9 – Plan Termination

Although it has not expressed any intent to do so, the Firm has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.
